



T., says: Bessie Stansfield, a pretty 19-year-old teacher, left school during the storm to go to a farmer's house thirty yards distant, dead body was found nearly a mile from the school-house. Four children froze in a schoolhouse at Mellette. The teacher left them to get assistance, and her body has not yet been found. 


