

VINEWOOD BOULEVARD THE CITY STREET

On Which the Fast Roadsters will go .-College Hill Addition Affords Many Delightful Building Lots with Extensive Views.

Every year Ann Arbor is being more rapidly built up. In various parts of the city houses may now be seen in process of erection. In many places they have been crowded in so thickly as in great measure to mar the beauty of the streets. To counteract this tendency and to give beautiful building spots at reasonable prices, Messrs. Corliss and McLaughlin who built the Ann Arbor street railway, have platted College Hill Addition in the eastern part of the city and well within the the city limits. They are expending \$2,000 in laying out beautiful streets and planting trees. Already the work has so far progressed that one can drive with comfort over the new streets ia the addition and view the building lots which will give the purchasers fine views from their homes. For College Hill addition is rolling land and elevated so that from points a great deal of country may be seen. Naturally a man with a taste for the beauties of nature will desire to view them from living in the city.

The addition is easy of access, being at present within two blocks of the street railway and with every indication that the road will shortly be extended to Valley street.

The addition fronts on Washtenaw avenue, as beautiful a residence street as there is in Ann Arbor. Opposite it is the fine residence of Evart H. Scott. Beginning at Washtenaw avenue and running west is Vinewood Boulevard, 100 feet wide, with a row of trees and a sixteen foot grass plat in the center of the Boulevard. It is intended to make this Boulevard the drive for the city. Some very fine lots front on it. The other streets of the addition are named Valley, Wayne, Orchard and Day streets.

In all there are 110 lots, all of which are sixty-six feet wide and The prices at which the lots are held are not high, especially considering the desirable location. On many of

Several of the lots have already been purchased. Dr. V. C. Vaughan has bought three lots with the intention of building a handsome resi dence. It is desired to obtain for the addition a handsome class of residences and in a few years it will undoubtedly be entirely built up.

Not only can residents on the addition have pure well water, but they can also have the city water put in their homes and enjoy all the advantages to be found in those parts of the city now so thickly

It is a mistake to think that the chorus girls all come from the middle and lower classes, says a comic opera manager in Kate Field's Washington. HOW TIGERS KILL THEIR PREY.

Some Commonly Accepted Theories Ex-ploded by an Intrepid Observer.

An observer has been among tigers taking notes and has given the results of his observations to the world. As a general rule, he is inclined to doubt the truth of the commonly accepted theory that the tiger, after lurking in ambush springs on the unexpected victim, and, tearing savagely at his throat, eagerly drinks its blood. This method of attack may sometimes be adopted, but it rule. In approaching his prey the tiger makes the best possible use of cover, but when further concealment is impossible he will course a deer or other swift-footed animal with a quite extraordinary turn of speed.

According to the account published by the Homeward Mail, a sudden dash of two hundred yards in the open is nothing uncommon, and the author mentions the case of one tigress with whom he says he was at one time quite intimately acquainted, who used to catch hog or deer almost daily on a perfectly open and burned-up plain. Small animals are, for the most part, dispatched by a blow of the paw; but in the case of the more bulky the experienced tiger leaping on the back of his victim grips the neck in front of the withers with his jaws, one forepaw clasping the shoulprotectionists, not of the hide-bound der of the animal and the other fully extended under the throat. Should he be unable to crush the spine with his jaws he will then jerk the head back violently and thereby break the neck.

"I have examined," he says, "hundreds of animals killed by tigers, and have never yet detected injury to the blood vessels of the throat, but invariably marks attributable to the abovetigress leaped upon a perpendicular rock some six feet high with a man weighing nearly eleven stone in her jaws, and on another occasion a male tiger dragged an exceptionally large buffalo up a bank at least ten feet high. Whether these anecdotes accord or not with the individual experiences of other shikaris they are at least an interesting addition to the literature of the subject.

There were 602 votes cast at the special election in Ypsilanti, to decide about bonding the city for \$20.000 for bonuses to manufactories, of which 403 were cast for Edward C. Smith, R. E. Grand the \$20.000, and 199 against. The factories which have gone a long ways towards building up Ypsilanti have been obtained without bonuses. If those who have opposed further bond of the city, care to resort to legal proceedings they could probably defeat the issuing of bonds.

# PATTON'S TRIUMPH

Most Complete In the Case of Professor Briggs.

PRINCETON'S THEOLOGY INDORSED.

The Vote Being 440 to 50 That the Professor's Ideas Are Bad Presbyterianism -Intense Excitement and Solemn Stillness as the Ballot Was Taken-The West and Southwest Stand Up for Disapproval, as Do the Foreign Delegates-

DETROIT, May 30.—The Briggs fight was fought to the end yesterday and Princeton won. Prof. Briggs' doctrinal views were disapproved by a great majority and Dr. Patton was once more trinmphant in a fight against "loose theology." At the opening of the assembly yesterday some greetings were exchanged with other Presbyterian bodies. A feeling of sadness permeated the assembly over the sad event of Thursday, which for a time modified the excitement consequent on the opening of what was expected to be the final debate on the great question before the body; but as the debate proceeded it seemed that the awful presence of death was for gotten for a while, and theological guns thundered with increasing vigor all along

Pleaded for Temporary Disapproval. Rev. Hathaway, of Jersey City, began the debate. He urged disapproval of the Briggs appointment for a year rather than permanently. If the assembly disapproved for a year it would give time for such investigation as was necessary. It would be a sad day for the church when they allowed a technicality of law to defeat justice. He pleaded not for Dr. Briggs, but for the best interests of the church. The assembly was making history. Let it not make history for which their children might have to apologize.

It Must Be Now or Never. Rev. S. Bowden, of Genessee, N. Y., said the assembly must disapprove or let the appointment be confirmed by default. It stated clerk. Dr. Patton was not present. Was now or never as to the veto. If this assembly did not disapprove the thing ly as they knew how. When the vote was appointment be confirmed by default. It assembly did not disapprove the thing was finished. No action could be taken except that proposed in the committee's report. The amendment of Dr. Logan de laying the veto nullified the report, and Dr. Briggs' appointment was settled. This would be held by any judge before whom the compact should come. The assembly must protect all its rights. It was the highest court of the church, and when a

case came from a lower court it must be reversed or affirmed. A Railway Lawyer's Views.

The substitute was seconded, and Dr. Worcester addressed

the assembly in advocacy thereof. Wanted to Soothe the Directors. He said the substitute provided a course calculated to soothe the self-respect of the directors of Union, who felt that undue haste was being exercised in the case. It gave time for new light to come in for all. If it was referred back to the directors they could revoke the appointment, which ended the affair; they could reappoint and the matter would come up again in a year the matter would come up again in a year day to pay a fine of \$100 and costs. James Lewis, of Joliet, Ills., spoke for the substitute; Elder Junkins, of Philadelphia opposed it. Dr. C. H. Parkhurst, of the Union Theological seminary, said he loved Dr. Briggs, but that he was a difficult man to get along with. The directory would meet the assembly in any plan of settlement of the sembly in any plan of settlement of the matter. He favored Worcester's substi-tute. Several more speeches were made, and then the moderator announced that 5 o'clock had arrived.

CLOSING SCENES OF THE DAY.

A Struggle for Recognition as Time Passed -The Final Vote.

The scenes in the assembly as consideration of the case came to a close were very exciting. After the adoption of the resolution in favor of taking a vote on the matter at 5 o'clock, both sides began getting in their best licks. Briggs' friends were persistent in their attempt to post-pone consideration. During the last few minutes the contention for the floor was terriffic. Civil Service Commissioner Lyman; Rev. Dr. Baker, of Philadelphia, and Rev. Dr. Bartlett, of Washington City, were among those who were fortunate in securing the moderator's eye, and, though Judge Shipman of New Jersey, had been waiting an hour under Moderator Green's nose for a chance to say a last good word for Briggs, the moderator did not notice

Five o'clock came with Dr. Bartlett urging the veto of Dr. Briggs' appointment, when a Briggs man jumped up with a motion to adjourn. The assembly howled him down. Dr. Worcester's substitute for the report of President Patton's committee was first presented. There was not one hundred in favor of it. Next came Dr. Logan's amendment that disapproval be extended only for the present, which was voted down with as big an adverse majority as Dr. Worcester's substitute. Then

came the report of Patton's committee. Amid wild excitement, mingled with hi-larity, the vote was ordered, but from disorder the whole scene changed to most solemn stillness when the name of the first presbytery on the list was called by the stated clerk. The ayes had it from the start. Only a solitary "no" lent aid and comfort to the Briggsites for half an hour. 

# BRAVE BOYS THEY,

Who Fell in Defense of Their The seventh annual meeting of the Country's Integrity,

THE MEMORIAL DAY OF A NATION

Multitudes Turn Out to Pay the Annual Tribute of Honor to the Heroic Dead, and Testify That They Died Not in Vain -A Brilliant Parade at Chicago-Interesting Event at Chattanooga—The Pres ident at Philadelphia-Sad Death of a

CHICAGO, June 1.—If the clerk of the weather had been under the orders of the Grand army commander-in-chief, he could not have done better for Decoration Day than he did. The air was just cool enough for comfort, the day was clear, and everything was propitious for the yearly tribute to the memory of those who "died to make men free." The morning was devoted to the actual business of strewing flowers over the graves in the various cemeteries in the suburbs of the city, and this labor of love was well done. As early as 8 a. m. the frequent passage of some post of the G. A. R. with fife and drum, and "keeping step to the music of the union," gave evidence that the old soldiers were marching to strew flowers on the graves of their dead comrades. In many of the companies there were young children-some of them little tots-going with their fathers to visit the "windowless palace" of some loved one whose life went out in the war of the rebellion.

The Afternoon Parade.

The principal event of the day, aside from the exercises in the morning, was the afternoon parade. This was a brilliant success, was more than an hour passing a given point, and was participated in by nearly every G. A. R. post in the city, besides others from suburban places. The long line of blue was lighted up here and there with the gay uniforms of Knight Templars. Knights of Pythias, Patriotic Order Sons of America, and Zouaves. The Fifteenth regiment U. S. regular infantry was out in force, commanded by Col. Crofton, and the Frst brigade I. N. G. presented a very soldierly appearance, and won the commendation therefor of the thousands of people who densely lined the sidewalks and roadway leaving only room for the line to pass.

Notable for Their Appearance. The most striking body in the line, so far as appearance goes, was the Chicago Hussars; the Chicago Light Horse guards were next and the zouaves next. The company of Italian bersaglieri was also a notable feature, not only for their novel uniform, but also for the fact that they car ried the Italian flag as well as "old glory. The P. O. S. A. asserted their American ism by carrying a star spangled banner about every fifty feet along their entire line, and it was a long one. All the members of the police and fire departments of the city who could be spared were also in line, the former headed by late Chief of Police Marsh and the latter by Chief Sweenie They presented a fine appearance, and the firemen "took the cake" in the perfection of their march by platoons.

Reviewed by Gen. Miles.

In six divisions the parade passed through a part of the business portion of the city, finally countermarching on Michigan avenue, where the reviewing stand hed been erected. Here the chief review ing officer was Gen. Miles, U. S. A., and with him were Department Commander Horace S. Clark, G. A. R., and Gen. Miles' staff. As the veterans passed the stand the ladies of the Woman's Relief corps showered them with flowers. Altogether it was a grand day for the vets, many of whom were grizzled and gray-haired, and the procession was the largest Decoration Day turnout ever seen in this city.

# The West Took a Holiday.

CHICAGO, June 1.—All throughout Illinois, Indiana, Iowa, Michigan and Wisconsin the people turned out Saturday to do honor to the memory of the boys in blue bus—Columbus 11, Baltimore 4. who fell on the field of battle. Indeed, from the labes to the gulf and from the Atlantic to the Pacific the day has never been so generally observed.

# DID NOT DIE DISHONORED.

A Monument Unveiled to the Memory of the Andrews Raiders.

CHATTANOOGA, Tenn., June 1.-The fact that the military "spy" cannot be dishonored by being forced to suffer a dishonorable death was illustrated here Saturday, when a monument to the Andrews raiders, provided by the state of Ohio, was unveiled. It was the event of Decoration Day, and ex-Governor Foraker was orator of the occasion, while half a dozen descendants of the raiders were present. What is known as the Andrews raid occurred in April, 1862. The leader, James J. Andrews, was a Union spy. He made two attempts with Ohio soldiers in 1862 to make his way through the south to Atlanta, Ga., capture a locomotive, on which he and his companions proposed to ride over the road to Chattanooga, burning the bridges after them. Both failed.

A Terrible Race for Life. It was in the second attempt that he and seven of his men lost their lives. He and his men captured a locomotive and three freight cars in the second raid at Big Shanty, but after a tremendously exciting run and hot pursuit of ninety two miles, during which there was much hard work and some very desperate chances taken, the raiders abandoned the engine and took to the woods, to be all captured within the next two or three days. There were twenty-two men in the party. Eight were executed, eight escaped, and six were exchanged.

Names of the Eight Heroes.

The men executed were James J. Andrews, of Flemingsburg, Ky.; Marion A. Ross, George Wilson and Perry G. Shad-rock, of the Second Ohio infantry; J. M. Scott, of the Twenty-first; Samuel Slavens and Samuel Robertson, of the Thirty-third, and William H. Campbell, of Salineville, O. They all understood the nature of the service which they undertook and the risks they ran. Had they succeeded their efforts would have had a marked effect on the progress of the war.

Obedience to the law is the first element of domestic peace and social order. You went out to maintain that, and have established, as I believe, again in the affections of all our people the old flag of our fathers, and have settled perpetually the question of loyal submission to the constitution and the law in all the states.'

The Observance in New York. NEW YORK, June 1.—Memorial Day was never more generally observed in this city than it was last Saturday. About every military organization in the city was in the parade in the morning, together with a large number of civic societies and an army of old veterans. In the afternoon services were held at Grant's tomb. The United States man-of-war Enterprise was anchored in the Hudson river opposite the tomb and fired minute guns during the continuance of the services. A number of ex-Confederates were present as guests of the day. The Hon. John S. Wise, of Virginia, delivered the address of the day, which was a very eloquent one.

At the National Capital. WASHINGTON CITY, June 1.—The usual ceremonies were observed here on Decoration Day. Mrs. Gen. Sheridan had charge of the floral decorations. The most impressive of the features was the decoration of the graves of the unknown dead at Arlington. There were services at the graves of Gen. Logan, Gen. 
