

A Great Publication Scheme With a Very The drummer was talking to two or three

"I met an old fellow the other day in Adrian," he said, "that had a scheme of

"An old fellow at a hotel there," he continued, "got to talking to me about news papers. He said his name was John Smith of Smithville, Smith county, Tenn., and that he had originally come from Michigan and was then on a visit among his relatives in various parts of the state, and also to look up members of the Smith family and name.

"I have made money,' he said, 'half a million or more, and I'm going to spend a part of it in establishing a monthly periodical to be called Smith's Magazine, to which nobody shall become a subscriber unless he bears the name of Smith. Plain Smith, too, none of your Smyths or Smythes or Smithes or Schmids or anything like them.'

"'Great Scott, man,' said I, 'give me the money. What do you want to throw it away for? The Smiths are not humerous enough to keep you going.'
"'Ain't they?' he said, with a little sneer.

'Well, let me tell you there is hardly a state in the Union that hasn't a postoffice with the name Smith in it somewhere, and there are 1,500 postmasters and postoffice employees named Smith. Illinois has, for in stance, a Smithfield, a Smithdale, a Smith boro, a Smithshire, a Smithton and a Smithville. Then there are Smith's Creeks, Smith's Fords, Smith's Ferries, Smith's Mills, Smith Groves, Smith Valleys, Smith's Crossroads, Smith's Lakes, Smith Landings Smith's Corners, Smith's Rivers, Smith Flats, Smith's ranches, Smithburgs, Smith's Basins, Smithtowns, Smith's Branches, Smith's Roads, Smith's Forks, Smith's points, and down in South Carolina Smith's Turnout, all postoffices, too, from Maine to California, and the Lord only knows how many Smith places there are that are not postoffices, mine, for instance. In Michigan there is a Smith in St. Clair county and one in Saginaw; a Smith's Corners in Sanilac and in Oceana counties. Then there are Smith's Creek, two Smith's Crossings, Smith's Siding and Smithville, four of them postoffices.
"'Two Smiths in Michigan are postmas-

ters, and among business men there are about 100 in Detroit in business; 25 in Grand Rapids; 22 in the two Saginaws to only 7 in the two Bay Cities; Lansing has 4, Kalamazoo 8, Ypsilanti 6, Adrian 7, so on down to Adair, a small town of 60 or 75 people, where there is 1. These are the figures of two years ago, and of course they have increased, because the Smiths are prolific and progressive. I believe I am safe in saying there are upward of 15,000 Smiths in the state of Michigan alone. In other states they are propor tionately as numerous, and you can readily see what a contingent I have to draw from, not counting the family pride. Why sir, in the national capital, a city of 250,000 people, there are over 1,200 Smiths, a Smith ratio of 1 to every 200, not counting the children. And children, sir, are features of the Smith family."

GOLD IN CALIFORNIA.

THE PRIESTS OF VERY EARLY TIMES WERE AWARE OF IT.

Long Before the Forty-niners Rushed to the El Dorado, Indians Peddled the Precious Dust on the Streets of Monterey.

The discovery of gold in California has recently called forth a good deal of discussion, and also an especially interesting story from Captain W. H. Thomes, president of the Society of California Pioneers.

Captain Thomas, before he took up his permanent residence in Boston, spent many years in California and is very much interested in the early history of the gold discoveries.

He says: "I am perfectly satisfied that the presence of gold in that region was known to the priests in the very earliest times. The priests, who were the first pioneers, were a pastoral people. As missionaries they gained a wonderful influence over the native Indians and gradually flooded the country with great herds of sheep and cattle that roamed over ranges thousands of acres in extent. These herds the Indians tended, and it was therefore the policy of the priests to keep the Indians in subjection.

"The priests brought with them from Spain grapevines and orange trees, and they sought to bring peace and plenty to new land. They were wise, long headed men and must have known of the existence of gold, but they also knew the avariciousness of the Spanish people. They reasoned that if the presence of the yellow metal should become known in Spain hordes of greedy adventurers would rush in, robbing, killing and ravishing. Their peaceful relations with the Indians would be broken off, the great herds would be scattered, and the supremacy of the priests themselves would be lost.

"This supremacy was at its highest in 1765, when from the missions at San Diego a chain of 24 missions was extended northward. Junipero Sera was priest president of all the missions in California and was an intelligent, persevering, enterprising man. He was not only instrumental in founding mission after mission, but he added to the herds thousands of sheep and cattle.

"I have been six times to California and have talked with priests of all nationalities, Mexican, Spanish, Irish and American, and I am confident from what they say that Junipero Sera knew about the gold, but he was a singular character and ruled with a hand of steel, so that gold was a word that no one dared to utter. He had the history of Peru and other countries in his mind, and he knew that an influx of gold hunters meant terror and destruction and the failure of all his great plans.

"It is claimed that the first discoveries were in 1848, when the whole world was turned topsy turvy with the astonishing news. I myself was in California in 1843 and staid there for three years, and I can positively say that gold was known there then, for I have seen it in Monterey. On Sundays the Indians would come into town, naked except for a cloth around their middles, and exchange a little pinch of gold for a drink of aguardiente or native rum. No one knew where they got the gold, but sometimes they would have several dollars' worth of the precious dust. This was an old custom, for at Mission Carmel I interviewed, through an interpreter, an aged Indian, who said that when he was a boy gold was found in the mountains and rivers round about, and the natives would wash out a panful in order to get a good drunk on Sunday, which Christian Indians were forbidden to do. He thought that there was still gold in the mountains, but he was so old that he had forgotten where it was.

"In 1841 Andres Castillero, the same person who afterward discovered the New Alameda quicksilver mine in Santa Clara county, while traveling from Los Angeles to Monterey found near the Santa Clara river a great number of water worn pebbles which he gathered up and carried with him to Santa Barbara. He there exhibited them, said they were a peculiar species of iron pyrites, and declared that according to Mexican miners wherever they were found there was a likelihood of gold being also found. A ranchero named Francisco Lopez, who was living on the Piru creek, a branch of the Santa Clara river, but who happened at the time to be at Santa Barbara, heard Castillero's statement and examined his specimens.

"Some months afterward, having returned home, he went out to search for strayed cattle. At noon, when he dismounted from his horse for the purpose of resting, he observed a few wild onions growing near where he lay. He pulled them up, and in so doing noticed the same kind of pebbles as those to which Castillero had called his attention. Remembering what Castillero had said about them, he took up a handful of earth, and upon carefully examining it discovered gold. The news of the discovery, at the place which was called San Francisquito, about 35 miles northeast of Los Angeles, soon spread. In a few weeks a great many persons were engaged in washing and winnowing the sands and earth in search of gold.

"The auriferous fields were found to extend from a point on the Santa Clara river about 15 or 20 miles from its mouth over all the country drained by its upper waters, and thence easterly to Mount San Bernardino.

"On May 14, 1843, Alvarado wrote to the prefect of the district reproving him for not giving official notice of the discovery and directing him to gather and forward an account of all circumstances of interest relating to the gold for transmission to the supreme government.

"From that time to the present day there has been more or less working of these mines, but no places of very great richness have been found, and none to compare with those afterward discovered on the tributaries of the Sacramento and San Joaquin,"-Boston Herald.

The Skittish Doctor.

Dr. S-was noted among his professional brethren for his power of concentra-tion. When once he bent his mind to a problem, he became totally oblivious of everything about him.

The doctor had a horse that was almost as famous as himself. Among her peculiarities was the habit of shying. She would not shy at things which most horses consider fit subjects for that sort of digression. She would pay no attention whatever to a newspaper blowing about the streets, but was

mortally afraid of a covered wagon. At the sight of one of New Haven's sub-urban stages she would run over the curbstone and threaten not only the doctor's life, but that of the chance passer. Of this habit she could not be broken. It seemed as though she could smell a stage long before it came in sight, so that the doctor would go half a dozen blocks out of his way rather than meet one. Early one morning he received a telephone call to the effect that one of his patients had become alarmingly worse. Without waiting for his carriage he started to walk, the distance being about a mile.

His mind became at once absorbed in the case, but not so much so that he did not remember that the course of the Seymour stage lay right in his path. He looked at his watch and saw that he would be sure to meet it if he went the shortest way. He was in a hurry to get to his patient, but there was no help for it. He uttered a malediction over the circumstance, and turned off at the first corner. This obliged him to nearly double the distance, and the day was warm. He walked as he never walked before, and failed to recognize a couple of intimate friends whom he nearly ran over.

It was not until he had spent two hours with his patient and came out to look for his horse that he began to realize that he had walked a mile out of his way so that he need not shy at the Seymour stage.-Frederick H. Cogswell in Harper's.

A Priest Who Had Plenty of Ivory.

At some distance beyond the primeval forests of Cameroon on the frontiers of the Soudan a strip of land is found which abounds with ivory. Its sovereign is Chief Ngilla and Mohammedan influences have not been wasted upon him. Merchants from every land come here bringing pearls and textiles which they exchange for ivory. Many a fine tusk is sold for a nickel for which they would be obliged to pay at least \$100 at the coast.

Lieutenant Morgan in his reports on this country relates of a man who had neither gems nor costly fabrics to offer for ivory. and yet was one of the largest possessors of that beautiful white substance. He was a high priest, whose home was on the River Niger, and he came armed with plenty of paper, ink and pens, writing short axioms from the Koran on pieces of paper, which he sewed in small leather pouches and sold them as amulets to the faithful. The recompense was a large one in every instance, consisting of the handsomest ivory tusks that could be had.

When Chief Ngilla came to him to buy one of these talismans, and endeavored to persuade him to let him have the same for less than he had been accustomed to receive, the cunning high priest said to him:
"Sir, it is immaterial to me whether you give a large or a small tusk, but it is not so to Allah. He will arrange his protection of your body accordingly." It is needless to say that he received what he asked for. He did a thriving business with his amulets, and was the richest holder of ivory of the choicest kind in that region.—St. Louis Post-Dispatch.







A QUEER VERDICT.

A Coroner's Jury Decides Sullivan Was Dead When Lynched.

It Returns a Verdict of Suicide, the Mob's Victim Having Cut His Throat Before Being Taken from His Cell-A Most Horrible Affair.

CALLED IT SUICIDE.

CORUNNA, May 27.—The coroner's jury in the inquest over the body of William Sullivan, who was lynched Tuesday night, returned a verdict that he had committed suicide by cutting his throat. No reference is made to the lynching. When the mob reached Sullivan's cell, he was found lying on its floor unconscious from the loss of blood caused by a jagged gash in his throat which the unhappy man had inflicted with a piece of glass in his possession. Still many question whether he was dead or alive when he was taken

The details of the lynching show the affair to have been the most brutal and horrifying that ever transpired in the state. It was about 9:15 o'clock that some men wearing masks, backed up by the others, made a rush upon the side door of the jail, and with a crash burst it open. In a moment the corridor was packed with men. Sheriff Jacobs appeared in the doorway leading from the other hallway and shouted to the men to stop, at the same time making a motion to draw his revolver. In an instant the sheriff was seized and held by half a dozen men so that he was unable to move. He attempted to argue the matter but the lynchers would not listen. Several deputies tried to come to the assistance of the sheriff, but they were hustled out of the building.

The cell was broken open with a sledge, and despite the fact that Sullivan was lying on the floor unconscious, the blood flowing freely from the wound in his throat, the lynchers slipped the noose about his neck and dragged him out to the terrible doom that awaited him. As the victim was pulled out the shout that was tremendous, and the crowd scrambled to obtain places nearest the body. The frightened wretch was dragged to an oak about 200 feet from the jail and a hundred eager hands grasped the end of a rope that was thrown over a limb and in an instant the body of the murderer was dangling in the air.

The body hung motionless for a moment or two, then gave a sudden twist and swung half way around the trunk of the tree. A terrible scene followed. Those nearest the body kicked and punched it back and forth and grabbed the limbs and pulled them violently. "Let us shoot him!" shouted several. "No, don't," cried others. Meanwhile the crowd continued to jeer at Sullivan, applying to him the vilest epithets and asking with curses how he liked it. The fury of the mob seemed to increase at every moment. The body was pushed from hand to hand and several drew their pocketknives and lunged at the swinging corpse. The maddened mob fell to pulling the body about again and kicking it, when an old man with long gray beard held his hands aloft and kept crying for silence until the crowd stopped him by shout-

When the body was lowered to the ground portions of the mob which had been unable to get close enough to take a hand in the actual hanging seized upon the rope and dragged the lifeless body through the mire. Afterthe streets and around the courthouse square. Every few seconds their curiosity would overpower them, and they would stop to look at the body. It was a sight they will never forget: Bruises and cuts and contusions made the face unrecognizable, while the eyes were ghastly and the mouth set in the tight grip of death. Finally the crowd rounded up in front of a saloon. They were going to burn the body, but the sheriff's aids came up and stopped the terrible work. The remains were taken to the jail.

The jurors at the inquest were: George O. Chattuck, A. L. Beard, George F. Robinson, George D. Moreau, Morris L. Chase and Henry Klinkman, all well-known citizens and business men of this place.

The jury found that William Sullivan, a felon, voluntarily and with malice aforethought, made a felonious assault upon himself with a piece of broken glass and inflicted a wound 8 inches in length, with suicidal intent. This was all it amounted to. No mention of the other and greater occurrence was made.

Another Bank Failure.

JACKSON, May 27. - The Farmers' state bank of Brooklyn, this county, has closed its doors with liabilities amounting to about \$20,000. There is no money on hand, but the bank owns large amounts of real estate. Col. N. G. King, owner of the bank, has been sick for a long time and unable to give his attention to the business, which is given as the cause of the failure.

Death of a Pioneer

BATTLE CREEK, May 27. Mrs. Sarah Hathaway, aged 95, a pioneer of the Grand river valley, is dead. Fifty years ago she went to the valley by wagon from Detroit, thence down the Thornapple and Grand rivers to Grand Haven, where she lived many years. Her husband, the late William Hathaway, was judge of probate of Ottawa county for several terms.

The Michigan Legislature Has Adjourned Sine Die. A flavoring extract manufactory will

Its Session Thirty-Five Days Shorter Than Its Predece sor-Synopsis of the Business Transacted During the Closing Days.

AT AN END.

LANSING, May 29.—The legislature adjourned sine die at noon to-day. The legislative ses-sion of 1893 was thirty-five days shorter than

LANSING, May 23.—The house passed a concurrent resolution providing for the appointment by the governor of a commission of three persons to report a bill for the incorporation of cities and villages without appeal to the legislature. A bill was passed providing for computing the taxable earnings of companies whose lines are partly within and partly without the state on the actual earnings of mileage within the state instead of on a pro rata basis. The senate committee on military affairs reported favorably the house bill for the reorganization of the state militia and in committee of the whole bills were passed as follows:

Requiring corporations doing business in Michigan to keep a list of stockholders and transfer book within this state when the principal office of the corporation is located outside of the state; the indeterminate sentence bill providing for a conditional pardon by the governor; providing for the inspection of the factories, the work to be done under the supervision of the labor bureau; the section prohibiting the employment of children under 14 years of age; prohibiting employers from coercing employes from joining or belonging to any legally organized labor organization; fixing ten hours in any twelve as a day's work for railroad brakemen and providing for prorate compensation for overwork.

LANSING, May 23.—In the senate the Doran bill to protect employes against coercion of employers, the factory inspection bill, the bill making ten hours a day's work for trainmen, and the measure appropriating \$75,000 for an asylum for the insane in the upper peninsula were passed. The bill was reported favorably for the taxation of capital stock of palace, drawing room and sleeping car companies for personal injects on the barbers Sunday closing bill and the joint committee on judiciary was instructed to report out the barbers Sunday closing bill and t

LANSING, May 24.—The senate passed bills increasing the salaries of the justices of the supreme court to \$7,000 and requiring the justices to reside in Lansing; repealing the special charter of the Michigan Central Raliroad company and bringing the road under the general law for taxation purposes, thereby increasing its annual tax \$30,000; increasing the salary of the attorney general to \$3,000; adopting the Pennsylvania system of taxing palace sleeping and parlor car companies on their capital stock, and providing for the appointment of a commissioner to locate an additional normal school in the upper portion of the lower peninsula.

In the house the senate bill reenacting the old law for the election of presidential electors on a general ticket was passed after a contest. The house also passed the senate bill compelling banks doing both a savings and commercial business to keep the securities and assets of each department separate, and the Saturday half holiday bill for banks. The Turnbull bill, authorizing justices of the peace to suspend sentence on persons convicted of drunkenness in case the latter give bonds to take a course of treatment at some legally incorporated gold cure establishment, was likewise agreed to and the bill is now in the governor's hands.

LANSING, May 25.—The women of Michigan won a great victory to-night when the senate passed the bill granting suffrage at all school and municipal elections by a vote of 18 to 11. The sole qualification is an ability to read the English language. AMERICANS' CRESTS.

WARD M'ALLISTER FAVORS A TAX ON COATS OF ARMS.

Mr. McAllister Also Advocates the Establishment of a Herald's Office as One of the Government Apartments-Right of Americans to Wear Crests.

The number of persons using crests and coats of arms in this country is very large, and there is no way of ascertaining how large it is. The American who wants a coat of arms and has not got one usually adopts one which pleases his eye, without regard to any other considerations. In England supporters are seldom granted with coats of arms to any but members of the peerage. But Amercans must have everything of the finest, and therefore they usually take supporters to themselves. There is one very rich and famous family in this city. though of humble origin, which displays a coat of arms with four supporters instead of the two which usually satisfy

English ducal families. There is, however, a great deal of dissatisfaction with this irregular state of things. Mr. Ward McAllister, the arbiter of fashion, said it should not be tolerated. Coats of arms, he says, should be registered at a herald's office, as they are in England and other well regulated European countries. Then we should know who were entitled to them, how they got them and so forth.

"I propose," said Mr. McAllister, "that the American herald's office should be established as one of the departments of the federal government at Washington. This is a very practical suggestion. The government would be able to put a tax on armorial bearings and in that way raise a large revenue, as the English government does. It is one of the happiest ways of raising a tax I can think of. Members of fashionable society and all the other persons taxed would be pleased by it, and no one, I think, can show any good reason against it.

"I know it is easy for you to assert that Americans have no business with coats of arms and such things because they are relics of feudalism, but that is nonsense. They are not any more harmful relics of feudalism than many of our social customs. Fashion requires us to use them, and fashion must be obeyed. It is merely a matter of fashion. A man with a coat of arms is not likely to be a more dangerous plutocrat than a rich man without one. Besides, armorial bearings are ornamental and look well on silver and china. That is one of the best reasons for having them.

"I must say a few words as to who has the right to use them. It is not necessary that a family should obtain them by grant from the English or some other European king. It is enough if they have been used since the beginning of the country's history, or for three generations. In England any respectable person not in retail trade can get a coat of arms by paying for it.

"Unquestionably many younger sons came over to this country who had a right to bear the arms of their family. Their descendants settled in different parts of the Union and are now in the fullest manner entitled to use arms. On the other hand, many men of wealth and high social standing, but not of aristo-cratic origin, have adopted them since the practice became fashionable, as they have a perfect right to do. These families will transmit their arms to their descendants until they become as interesting as those of aristocratic European

origin.
"There are some interesting anecdotes to be told of the introduction of coats of arms into the general society of this city. number of initiations next Tuesday Of course there are a few New York families who have used them continuously since the creation of the colony, but of East Washington street. when the practice first became general it was received with a good deal of opposition. Gordon Hamersley used to say that his crest was useful to tell him which was his carriage. Colonel Thorne, who married Miss Jauncey, went to Europe 50 years ago and established himself in Paris, living as no other American had ever done. He took the British minister through his hotel, who, after viewing its interior and its stables, turned to Colonel Thorne, exclaiming, "And you say you do all this on £12,000 a year! It is marvelous." On returning to America to live the colonel turned out in this city postilions with his coat of arms embroidered on the left sleeve of each postilion. This created such a rumpus, the population hissing him as he drove by, that he was compelled to withdraw them.

"Some of our best people were pilgrims and Huguenots, who on reaching this country and establishing themselves here abjured such vanities as coats of offered as a reward for the capture of arms, as a monarchical institution. This the murderer of one of their companwas all very well in the beginning, but ions. the blue laws have faded. We no longer cultivate primitive simplicity, but with wealth and age we turn to luxury and find among its necessities the use of coats of arms. The necessity and love of the American for title or some designation of distinction, plain Mr. 'not filling the bill,' is illustrated in the west and south. For 50 years or more it has been a universal custom to bestow a military title on all men who have risen above mediocrity, such as governor, general, captain, colonel, it being purely honorary. Such titles men carry through addicted to the use of life with this love of ours for individual distinction, which is one of our marked characteristics. When a man wants to seal his letters, mark his plate or decorate his harness, he wants a crest, and as Americans with money own the universe this crest must be forthcoming. Of course it is only an accessory to the arms, and now the question is, How shall Americans get them? And how shall they be able to keep them?
