

Gentlemen: I have the honor to return to you without approval an ordinance passed by the common council on the 19th instant, entitled "An ordinance relative to closing saloons, bars in restaurants and elsewhere, for the reason that said ordinance permits the places designated to remain open during the months of July, August and September, until half past ten o'clock in the afternoon.

In my judgment all places where intoxicating liquors are sold as a beverage should be closed not later than ten o'clock standard time, which means of course half past ten suntime. Nearly all the work of the world is performed by men who are in bed at that hour. And it is safe to say that any person who is not willing to leave a saloon at half past ten and go home ought to be, and that the chances are he would be, if he had not already remained there too long.

I regret that there has been a misunderstanding as to my views upon this question. For such misunderstanding I am in a manner responsible. My attention was called to this matter by the chairman of the committee on ordinances in the city attorneys office at the time this ordinance was being drafted, and I stated then that I thought there was no objection to an extension of the time of closing during July, August and September. I have not spoken to the chairman upon this subject since. I saw the city attorney, however, soon afterwards and told him that such a measure was not defensible and requested him to notify the committee. I saw him a second time upon this same subject, and supposed that my position would not be left in doubt.

A GHASTLY FIND.

Fishermen Discover a Box of Bones Near Traverse City.

It Is Believed They Are the Remains of the Ely Family, Who Mysteriously Disappeared in 1871-Were They Murdered?

A MYSTERY.

TRAVERSE CITY, June 30 .- The north woods are full of mysteries that will never be explained. The finding of a box of human bones in a cedar swamp near Traverse City by two fishermen points to the solution of one of the mysterious disappearances that have become common of late years. In 1871 a farmer named Ely, living on the shore of Long lake, disappeared with his entire family, between two days, leaving everything untouched in his house. A hired man came forward with a deed of the house and farm that had never been recorded and claimed everything as his own, though he could not explain how he came to have it. Nothing was done at the time, and in 1876 Mr. Ely's father came to hunt him up, but could never find a trace of his son or his family. Nothing could be proved against the new owner. but he did not seem to enjoy life and the old farm and house soon fell into disrepute, and the house has stood silent deserted for years with empty windows and echoing rooms. Some time ago a chest of woman's clothes was found in the thick woods near the house, and iden-tified as belonging to Mrs. Ely, but no one has taken any steps to prove anything of late years, and the box of human bones is the first decisive thing that has ever been unearthed. The man who was supposed to know more than any living person about the mystery died a year or so ago, and it will probably never be solved.

MICHIGAN A GOOD FIELD.

Recent Legislation Has Caused a Wonderful Growth in Life Insurance.

LANSING, Mich., July 1.—State Insurance Commissioner McGill in his annual report says that the progress of life insurance in Michigan since it was established upon a permanent basis has been truly marvel ous. The number of life, fidelity and casualty insurance companies now doing business in the state is thirtyseven. During the year covered by the report 54,040 policies were issued to the amount of \$28,823,967. The number of policies in force are 101,380, representing \$115,627,565; premiums received during the year are \$3,932,365; losses paid, \$1,471,385. The increase of business during the year was nearly 25 per cent. in the amount of policies in force.

Has Been Stealing Letters for Years.

PORT HURON, July 2.—For some time large numbers of letters from Canada have mysteriously disappeared at this point. Two weeks ago Chief Inspector Stuart, of Chicago, and Inspector Larimore, of Battle Creek, began an investigation, which resulted Saturday afternoon in the arrest of Charles Ford, a car foreman of the Grand Trunk railway. Six hundred and eighty-nine let ters were found in large pockets of his He was held in \$6,000 bail. Ford admits his guilt and says he has carried on the thieving for years.

Burned to Death by Gasoline.

JACKSON, July 3 .- Mrs. Abram Giltner, 33 years old, while cleaning window draperies with gasoline Sunday was fatally burned. She had placed the pan containing the fluid on a wood stove in which there had been a fire, when the oil exploded. Her clothes were ignited and she ran into the street and fell prostrate, when a neighbor covered her with a blanket and extinguished the flames, but not in time to save her life.


