The sewer at the lower end has reached the corner of Depot street and Fifth avenue. The council on Wednesday evening made a change in the route, so that the sewer is to run on Fourth avenue instead of Fifth avenue on the block between Depot and Summit streets. The board of public works expect to save by this change a four-foot cut for 200 feet and a two and a half foot cut for 300 feet. The two parts will probably be joined in the next two days. A

### Senate and the Wilson Bill.

The friends of tariff reform have a stubborn fight on their hands in the Senate. To begin with, they have to encounter the determined opposition of organized capital and trusts, and that, too, in a body composed largely of millionaires and representatives of corporations. Already the agents of aggregated capital and local interests are assembling in Washington, intent upon no other object than to defeat the will of the people in the matter of tariff reform. Iron kings, coal lords, sugar trust barons, and representatives of the wealthy manufacturers are on the ground, all urging their Senators to get them a hearing before the finance committee. Then there are among the majority in the Senate a number of weak kneed representatives of tariff reform some of whom desire the elimination of the income tax, while others desire the retention of the duty on iron and coal and still others who are opposed to the removal of the sugar bounty. 



FILES CHARGES AGAINST THE BOARD OF CANVASSERS.

Olted to Appear Before His Honor In the Executive Office at Lansing on the 15th of This Month-Some Very Nice Legal Points Will Probably Be Made at the Hearing.

LANSING, Feb. 7 .- At a late hour Tuesday night Governor Rich served a ropy of the following charges and citations upon each of the returning board of 1893, through his private secretary.

State Canvassers: GENTLEMEN—Public charges have been GENTLEMEN—Public charges have been made and have come to my knowledge that gross errors were made in the canvass of the returns of votes given in the various counties at the election held in this state on the first Monday in April, A. D. 1833, for and against the adoption of joint resolution No. 10, approved March 9, 1893, proposing an amendment to Section 1 of Article 9 of the constitution of the state, relative to the salaries of the state officers, by which it was made to appear that such amendment to the constitution had been ratified and approved by a majority of the electors voting thereon, whereas it is alleged that by a true and correct canvass of the returns of such votes the said amendment was defeated.

ment was defeated. Under the power as granted and duly imposed upon me as governor of this state by Section 8, of Article 12 of the constitu-tion. It becomes my duty to inquire into the condition and administration of your the condition and administration of your several offices, and especially into the manner in which you have severally and collectively performed the duties of the board of state canvassers of which you are exofficio members, for the purpose of determining whether you have been guilty of gross neglect of duty in the matter of canvassing said returns. You are, therefore, severally cited and required to appear before me at the executive office, in the city of fore me at the executive office, in the city of Lansing, on the 15th day of February, 1894, at 1 o'clock in the afternoon, then and there to answer to the following specific

charges, viz.:

1. That you, the said John W Jochim, secretary of state: Joseph F. Hambitzer, state treasurer, and John G. Berry, commissioner of the state land office, who are the board of state canvassers under the constitutions and laws of this state, were constitutions and laws of this state, were each and every one of you guilty of gross neglect of duty in this, that you did not, nor did either of you examine the state-ments or returns of votes from the several eounties filed in the office of the secretary of state, showing the number of votes cast for and against said proposed amendment to the constitution relative to the salaries

to the constitution relative to the salaries of state officers, by the electors in this state at the election of 1893.

2. That you were severally guilty of gross neglect of duty in this, that you did not, nor did either of you, ascertain and determine the true result of such vote, nor perform with due and proper care the duties relating to canvassing the statements and returns from the several counties of the votes given at such election for and against said proposed amendment to the against said proposed amendment to the constitution, required of and imposed upon you as members of said board of state canassers by the constitution and laws of

3. That you were severally guilty of gross neglect of duty in this; that you made and suffered to be made gross errors in the canvass of the statements and returns filed in the office of the secretary of turns filed in the office of the secretary of state, of the votes given in the several counties at said election in April, 1893, for and against said proposed amendment to the constitution, by which it was falsely made to appear that such proposed amend-ment had been approved and ratified by a majority of the electors voting thereon. Whereas, by a true and correct canvass of the said statements and returns the said the said statements and returns the said

the said statements and returns the said proposed amendment was defeated.

4. You are further required then and there to show cause why you and each of you should not be removed from office for gross neglect of duty. John T. Rich.

This is believed to indicate that the theory of the jury is that the same person either conceived or perpetrated both frauds.

Lansing, Feb. 8.—Secretary Jochim,

Treasurer Hambitzer and Land Com-missioner Berry went to Mason Wednes-day morning, and all were called upon to testify before the grand jury. No other witnesses were sworn. Jochim entered the juryroom in the forenoon, and was in the sweatbox nearly two hours. Land Commissioner Berry followed, but was disposed of much more quickly, while Treasurer Hambitzer was under fire for only about an hour. but will probably be recalled. It is safe to say that neither of the members of the board of canvassers are giving up valuable information willingly. ### Preservation of Steel Pens.

Almost all of the inks at present in use in commercial establishments, and especially the cheaper black ones, attack steel pens rapidly and make many of the finer pointed pens useless after a few hours of constant use. M. Guyot suggests a little device by which steel pens may be protected against this corrosive action of ink for a very long time. He says: Keep on your table a little cylindrical vessel-a tumbler, for instancein the bottom of which have placed a few crystals of potassium carbonate and over this a moistened sponge.

If, when you finish writing, you will drop your penholder into this glass, letting the penholder rest in contact with the sponge, when you again need it you will find it clean and uncorroded. The same result will be obtained if you occasionally wipe it on the sponge, and subsequently on a dry wiper, during its protracted use. If you wipe it on the sponge frequently, and put it right back in the ink, you run the risk of eventually spoiling the ink in the stand, as well as in writing a word immediately after cleaning, which with some inks will fade. - National Druggist.

HADSHI IZZET HATED CHRISTIANS.

But a Consul Once Made the Famous Turk-

is Governor Respect Him. Some time ago there died in Adrianople one of the most famous and original of the subjects of the sultan of Turkey. He was Hadshi Achmed Izzet, pasha governor general of the valayet, or province, bordering on the Black sea. Hadshi Izzet was an ideal Turk of the old school, a strange mixture of Solomonlike wisdom and childish foolishness, energy and apathy, cruelty and mercy, truth and deceit, generosity and

avarice. In the eyes of the ruler and contemporaries he was a hero, and it was with a purpose clear to many that his majesty appointed him governor general of Adrianople and kept him for as many years at the head of that important province-the gateway of the Ottoman empire. The pasha was born more than 90 years ago and rapidly climbed to places commensurate with his name and the influence of his family. At the time of his death he was the dean of the Turkish Almost countless are the anecdotes

told of the pasha, who was known and respected from the Turkish Dan to the Turkish Beersheba. His hatred of the 'Christian dogs," as he always called the people of the west, was boundless. It was invariably his custom, when force of circumstances obliged him to give his hand to a "dog," to wash it upon withdrawal while in the presence of his guest. It is said that Hadshi Izzet laid aside his habit only once.

One day a consul of one of the greatest European countries was obliged to seek an audience with the sultan's lieutenant in governmental affairs. He had already been insulted once by the pasha's washing his hands after the greeting and determined that he should not be so treated a second time if he could possibly prevent it. The consul was a thorough master of the Turkish tongue, and for this reason had a great advantage over many of his colleagues.

When the servant of Hadshi Izzet received him at the palace threshold, he spoke as follows in a voice which he knew would reach the ears of the governor in his office near by:

"Go and tell thy master that I wish to speak to him. Say to him that I shall also do him the honor to give him my hand, but shall crack my hat over his ears if he attempts to wash his hands after shaking mine." The servant started away to announce

the visitor to his master. But the governor had already heard the message and came, smiling, toward the daring consul. While he placed his right hand in that of the foreign representative he said: "That was right. You please me, effendi. You at least have courage." The hands were not washed until the

consul had left the palace.-San Francisco Chronicle.
