Mr. McKinstry laid part of the shortage at the door of a clerk and claimed that the finding of the committee was far in excess of the true amount. He asked for arbitration and deposited a certificate of deposit for \$1,405.70 with the Ypsilanti Savings bank, on November 18, which was not to be returned to him until \$1,405 was deposited in the bank to apply on any shortage which might be found to exist in his accounts as city clerk.

Last Saturday Mr. McKinstry made a demand on the cashier of the bank for the certificate, but the city got out an injunction restraining the cashier from delivering it to him. After this move, a criminal complaint was entered against him and Deputy Sheriff Davis, of Ypsilanti, came to Ann Arbor Monday afternoon to arrest him. He was not here, but was arrested by Detroit officers on a telegram from this city and locked up at the central station in Detroit.

The certificate of deposit given to the Ypsilanti Savings bank, it turns out, did not belong to McKinstry at all, but was given him by the Farmers' and Mechanics' bank to turn over to Miss Mary A. Keating as soon as she discharged a first mortgage on some lots n this city whch had been assigned to the bank. The bank here demanded the certificate which was only in McKinstry's hands as register of deeds and this demand undoubtedly caused his attempt to get back the certificate from the

Ypsilanti bank. Mr. McKinstry was arraigned before Justice Childs Tuesday afternoon and ber 16 with bonds for \$1,000. He remained under surveillance until Wed-Tom Navin, of Detroit, and Chas. H. Kline, of this city, to defend him.

The New Method of Studying Geography. -The U. of M. Team Defeats Minnesota and Chicago an are Champions of the West. Score 12 to o in the Chicago Game.

'What would you do in a school having twenty three different kinds of text books?" came next. Consolidate classes and use the topic method in history and formity of wages in district schools?"

geography, was the answer of the asso-"How can we secure a uniciation. Answer by Mr. Austin, of Saline, who said that there could be no uniformity of wages as there was no uniformity in the qualifications of teachers. At this point Prof. McDermiad, of Chelsea, arrived and presented a paper on Geography. In regard to teaching Geography, there are two schools. One believes in approaching the subject from the large side, viz, taking the earth as the unit. The other, to which the writer belonged, would begin with home surroundings and work out. Teach the pupil first to draw maps, upon a certain scale, of his desk with various objects upon it, then of the school yard, then to the district, etc. One of the first essential is knowledge of direction. Take up the study of rivers, teaching erosion, deposition, etc. In teaching Washtenaw county take an imaginary journey to Ann Arbor, considering on the way the industries, productions, etc. Teach that Ann Arbor is the county seat. Make much of social conditions and in this connection draw attention to the court house, jail, church buildings, University buildings, etc. Connect Ypsilanti with Ann Arbor. In second journey go to some body of water, as Whitmore lake. Show each shore, bay, cape, peninsula, etc. In studying size use school yard as the unit.

Mr. Arbury, of Battle Creek, opened the discussion. The question with teachers in district schools is "What can we actually do in the time at our disposal?" not "What would we do in other circumstances?" Commended the paper read by Prof. McDermiad. Correlation should be prominent. Sociology, writing, spelling, arithmetic, history, political economy, civil government, commercial relations, in fact almost every subject could be correlated with geography. The country teacher was handicapped by lack of time, but should learn to dovetail one subject into another, and make one subject help another. Teachers should have special training just as other professions do.





The Argus did say in reference to the increase of county expenses that it had made no attempt to deduct from the figures of actual payments furnished by the committees of the board of supervisors, amounts which might be shown to be chargable to other years, for such deductions could be made from both years and the amounts would about offset each other. In another column will be found the report of the committee of the board made this year, published together with the table, the publication of which has made the Ypsilantian, the Sentinel, the Courier and the Register so wrathy. It will be seen by looking at the two tables that our figures were official, and that they have the sanction of a good republican name. The first column of figures in our own table are from the report of the committee of a year ago, which committee was composed of John R. Miner, Evart H. Scott and Eugene

The republicans are striving to lay the onus of the county expenses upon the board of supervisors. But the officers who incur these expenses are republican, and furthermore the board of supervisors pass only upon a small proportion of the expenses. As will be noticed in the table in another column, the committee of the board divide the expenses into two columns, one "orders To the Honorable Board of Supervisors of Washtenaw County: on the contingent fund, " warrants drawn by the clerk on which the board does not pass, amounting for the year ending September 30, 1895, to \$28,-485.79, and the other "county orders," which are warrants drawn by the board amounting to \$13,878 58. This shows that the board is not to blame for the big expenses. Neither do we blame it on the clerk; he only pays the expenses the various officials incur.

It is customary to hear the new rider defend himself from the charges of extravagance in the purchase of a bicycle by the declaration that he will, by use of it, soon save in car fares alone more than the wheel's cost. Let no man delude himself with any such idea. Supposing it were possible for him to ride a bicycle to and from his work each of the 300 working days in the year-and such a supposition is away beyond the probabilities in the case-he would store up in carfare savings but \$30 per annum, at which rate it would take just three years and four months for him to garner the \$100 pile his wheel had cost him. Therefore such arguments are fallacious, and should at once and forever be abandoned.

Don't hide behind a subterfuge so weak as this carfare allegation. Be honest with yourself and the world. Say it right out, so all may hear you, that you have bought a wheel because you want to ride one, because of the pleasure it gives and the wider scope it gives you when an outing is possible. If that is not sufficient to silence those who criticise you, leave them to their ways and go yours awheel, satisfied that your investment in a bicycle yields you never failing dividends of health and happiness. -St. Louis Globe-Democrat.

Rust on the Wires of a Piano.


The appearance of rust on the tuning pins and the steel wires of a piano is a sure indication that the piano has been exposed to moisture or dampness. The time of year or the age or quality of the piano has nothing to do with it, as rust may appear in a night. The fact that the room is heated by a stove just outside of it will probably account for the rust, as the chances are that after the usual cooling of a fire overnight its heating in the morning would be likely to cause condensation on the metal, and rust would immediately appear. Do not use oil or any greasy substance to remove it. It will probably not do any harm unless it causes the strings to break, in which case they will have to be replaced. Most pianos require tuning twice a year. The only important care to be given a piano is to keep it in an even, dry temperature. - Ladies' Home

> The Spider's Spinning Machine. The "spineret," or web machine of the common garden spider is an object worthy of the careful study of every owner of a microscope. It consists of four united masses, each pierced by a multitude of holes, the openings being imperceptible to the naked eye. These several holes each permit the passage of a single thread. Some idea of the infinitesimal fineness of these threads may be gained when it is known that the spider's thread as we see it is made up of upward of 4,000 minute webs, 1,000 from each of the four spineret masses. 


The Oldest Wooden Building.



FOR BETTER ROADS.

Reports Received at the Agricultural Department.

RESULT OF AT INVESTIGATION.

Much Might Be Saved if the Highways Were Put in Better Shape-Vandaiism in the Interior Department - Important Papers Rendered Valueless by Autograph Fiends-Cases of Presidential Postmasters To Be Submitted to the Senate.

WASHINGTON, Nov. 2 -The office of road inquiry of the department of agriculture has completed an interesting investigation relating to the common roads of the United States. Returns have been received from about 1,200 counties, showing the average length of haul from farms te markets or shipping points to be twelve miles, the average weight of load for two horses 2,002 pounds, the average cost per ton per mile 25 cents and \$3 for the entire

Estimating the farm products at 219,-824,227 tons in weight and making estimates on other articles carried over the public roads, it is calculated that the ag-United States consuls abroad of the expense of hauling where the roads are good, so as to render possible a calculation which will show how much of this vast outlay is due to bad roads.

MONROE DOCTRINE.

FACTS CONCERNING ITS ORIGIN AND WHAT IT SIGNIFIES.

First Suggested by an English Statesman. Submitted to Jefferson and Madison, Who Approved It-Never Received Congressional Affirmation.

It is a singular fact that the Monroe doctrine is of British origin. In 1823 George Canning, British foreign secretary of state, suggested that the United States government should take decided ground against interference by the "holy alliance" in Mexico and South America, where the Spanish colonies had established their independence.

The "holy alliance" was a union of Austria, France, Prussia and Russia for the maintenance of the European monarchies. It was formed soon after the Napoleonic wars and was renewed and strengthened in 1820, when uprisings occurred in several countries of Europe. Great Britain had been asked to join the combination, and some steps had been taken in that direction under Lord Castlereagh. On his death by suicide Cangregate expense of this transportation in the United States is \$946,414,665 per annum. Reports have been asked from the der his guidance Great Britain held alouf from the continental alliance.

The United States had recognized the independence of Mexico and the other revolted Spanish colonies, and Canning was inclined to pursue the same course. In 1823 he suggested to Richard Rush, United States minister at London, that this government should express in a forcible manner its opposition to intervention by the European powers in behalf of Spain against its colonies which had rejected allegiance.

This suggestion was conveyed to President Monroe through John Quincy Adams, the American secretary of state. President Monroe submitted the proposition of Canning to Jefferson and Mad ison for their opinion on the subject. Jefferson's answer was prompt and decisive in favor of such a declaration as Canning had suggested. He said it was the most momentous question submitted for his opinion since the Declaration of Jefferson's opinion and equally appre-

ciated the importance of the question. Under these circumstances President Monroe, in his annual message Dec. 2, 1823, expressed the doctrine that has since borne his name. There had been some correspondence with Russia and Great Britain in regard to boundary treaties, which the president described, adding:

"In the discussions to which this interest has given rise, and in the arrangements by which they may termi-States are involved that the American continents, by the free and independent condition which they have assumed and maintain, are henceforth not to be considered as subjects of colonization

But with the governments that have declared their independence and maintained it and whose independence we have on great consideration and on just principles acknowledged, we could not view any interposition for the purpose of oppressing them, or controlling in any other manner their destiny, in any other light than as a manifestation of an unfriendly disposition toward the United States."

This is the Monroe doctrine: 1. No new European colonies on this hemisphere. 2. No interference with colonies of European powers now existing. 3. No interference by any European power with the affairs of any American nation. It is but justice to say that the vigorous language in which it is expressed evidently came from the able and caustic pen of John Q. Adams, secretary of state. John C. Calhoun was secretary of war in the same cabinet and approved the positions taken by the president.

This doctrine never has been affirmed by congress. In fact, it has been rejected repeatedly when resolutions were offered approving the acts of the government on the subject. But it has been reaffirmed by every administration since that of Monroe in one form or another. The vigorous declarations of Mr. Seward and the commencement of preparations for their enforcement drove France and Spain from Mexico and secured the reestablishment of the republic after the death of Maximilian. It is the doctrine of the American people and never will be abandoned. - Chicago Chronicle.

The establishment of the state public school marked an epoch in the child life of Michigan. The state assumes the right to the guardianship of those or ill treated, and cares for them by furnishing them a temporary home at the school where, by means of perfect physical comfort and healthful moral training, they are led to forget their old life and become prepared to take their places with their more fortunate fellows in the families and public schools thoughout the state.

Since the opening of the institution in 1874, nearly 3,700 children have now in the institution about 200, and over 1,350 are with good families throughout the state and underthe supervision of the school. The others have passed uot from under the school's control. Those with families are placed on contracts which provide for their proper care and education

Is it not probable that there are many in this vicinity who would gladly take one or more of these cihldren into their homes and make them their own?

The Outrage at Kharput, More ample details have just been received here of the burning of the American mission buildings at Kharput. They show that the Turkish government offi-There was no protection offered or given them until after the massacre had actually occurred and after the American mission buildings had been actually burned. It is estimated that the value of the American property destroyed is about \$100,000. It consisted of the girl's college, the theological seminary, the chapel and five residences. All the burned buildings were looted by the mob before being set afire, and all the personal effects of the American missionaries, the libraries, scientific instruments, etc., were stolen.

Ladies in Great Terror. So far only a small proportion of the property has been recovered. The lady missionaries were naturally in a great terror while the rioting was going on, and Mrs. Gates, the wife of one of the missionaries, was so prostrated with alarm that she gave premature birth to a child, which did not live. The authorities Kharput, however, protected the missionaries after the latter fled from their residences to the official quarters. From that time on the Americans were kept under guard, and those who so desired were furnished with escorts to the Black sea coast.

"I was not aware, until just before coming into the session this morning, that I was to be asked to say anything to you on this great topic of Church halls. I shall speak to you on three subjects: (1) The occasion of Church halls in connection with great universities under the care of the State; (2) the method of their operation and (3) the results which they secure.

"The United States census of 1890 shows that there are in universities and colleges of the United States, under the direction of the various states, 46,000 students and over. In the universities and the colleges of the older sort, which exist as private corporations, like the colleges of New England and the Middle States, there were, at the same time. 103,000 students. So that in 1890 there were nearly one-third of the total number of students in universities and colleges gathered in these State institutoins, which are in no way whatsoever connected with any religious body; and I have no doubt that today the number of students in the institutions is fully one-third of the total number of students in the colleges and universities Here is our opportunity-one-third of the young people who are receiving higher education in institutions which are in no way connected with any religious body, by the side of which we may plant our Church and set up our banner. We are, or ought to be, fishers of men; and I represent to you, gentlemen, that these institutions where these young people are gathered for higher education are good places for us to go and fish.

How Icelanders Take Snuff.
