



Speech of Senator Lodge Makes Them Indignant.

SAY STATISTICS ARE ERRONEOUS.

Some of the Poles in Chicago Go So Far as to Say That Senator Lodge Is a Tool of the Russian Government-Russian Nihilists Also Become Aroused and Burn the Massachusetts Senator in Efficy in a Vacant Lot.

CHICAGO, March 19. - Senator Lodge was burned in effigy by the Russian Nihilist club Tuesday afternoon in a vacant lot at Seventeenth street and Ashland avenue. The action of the club was the evidence of the intensity of the feeling aroused by the recent discussion in congress on the question of immigration, and particularly by the remarks of Senator Lodge. Other nationalities are taking steps to defend their honor. The indignation of the Poles has been aroused to a fever heat. They contend that Senator Lodge's statistics are erroneous. Some of the Polish editors suggest that the most reliable statistics are those in the Daily News Almanac. They claim that when making his statements Senator Lodge was either ignorant of the real facts, or that he had a motive in making the state-

Think Him a Tool of the Russians. Prominent Poles say that it is not for a senator from Massachusetts to determine who the good citizens are. Some even charge him with being a tool of the Rus-sians. There is a sentiment among the Poles that there is something else behind into Lenapah and held up a store. After they had ransacked the place, Cherokee Bill saw Melton standing at the window what they call "this high-handed national persecution." As the Polish organizations by correspondents with their brethren across the sea learned that Russian money was being used in America to blackmail Polish citizens they concluded that had something to do with the recent attack upon them. They charge that the Russian government pays enormous sums of money for spies in America, whose sole purpose is to create dis-turbance and to see that Poles are constantly treated as ignorant and dangerous, so as to find a justifiable excuse for Russia's partition of Poland and her present barbarous treatment of the Polish

All Poles Will Unite. All the Polish organizations will unite to act against such misrepresentations. A number of magazines, which the Poles claim are being supported by the Russian government for the purpose of blackmailing the people and which are said to receive an annual subsidy for so doing, will be looked after. The Polish National alliance, the Polish Catholic union, the Polish National fund, the Polish league, the Polish Young Men alliance, the Polish Educational fraternity, the Polish Press club, the Polish military organiza-tions, the Polish turners, the Polish social and commercial organizations have all taken up the matter. Many have already passed resolutions denouncing the remarks of the various senators and condemning them. A series of meetings has been called to meet in different parts of the city. The Polish press advises the se-lection of a committeee of representative Poles who shall go to Washington to make inquiry concerning the position of congress in the matter.

"CHEROKEE BILL" HANGED.

Many Robberies and Not a Few Murder Laid at His Door.

FORT SCOTT, Ark., March 19 .- "Chero kee Bill" was hanged here Tuesday. He was but 20 years old and had been a member of the Bill Cook gang. When the Cook gang was broken up Cherokee Bill



started out single handed and committed many robberies and not a few murders were laid at his door.

The particular crime for which he was hanged was the murder of Ernest Melton, a white man at Lenapah, Cherokee Nation, on Nov. 8, 1894. On that day the desperado, in company with another out-law, known as the "Verdigris Kid," rode of a restaurant, twenty feet away. leveled his Winchester and shot him dead. Filibusterers Fooled the Spanish Detectives.

STEAMER HAWKINS BID NOT SINK.

One Story Is That the Vessel Carried Two Crews and Awaited a Storm-When It Came One Crew Took to the Beats and Reported the Loss of the Vessel-Desperate Measures Taken by the Filibus-

NEW YORK, March 19.-Spanish detectaves engaged in keeping watch on the movements of the Cubans in this country were very much exercised Tuesday night over the report that the steamer Hawkins did not sink the morning of Jan. 28, but that she made her way to the island. landed her cargo, and is now laid up at one of the Florida keys. The story took two forms. One was that the Hawkins carried a double crew. Both crews were well paid, one to serve till the steamer returned to port and the other to be discharged in small boats about five miles from the New Jersey coast. The vessel left port Saturday night and by Tuesday night had got no further than Barnegat point. As any ordinary vessel could make this distance in much less time, suspicion was at once aroused.

Waiting for a Storm.

The detectives argue that the Hawkins was merely crawling along the coast, waiting for a storm. The storm broke on Monday night, and on Tuesday morning the crew left the ship in small boats, tak ing a good many of the passengers with them. The detectives say that at the time the Cubans knew their intended movements were known to the United States and the Spanish authorities in this country. They knew the cruisers Raleigh and killed in an attempt to rob a store at Montgomery, under command of Admiral Bunce, were watching for them outside, ures to make it appear that the Hawkins had gone to Cuba, and this means was adopted. General Garcia was the only man of consequence rescued and the de tectives say that was done in order to allay their suspicions further.

Can Do More Good Here. Besides, they say, Garcia can do more good in this coun ry at the present time than he can in Cuba. Moreover, the de-tectives say the Hawkins had on board twice as many men as she could carry to Cuba, and that it was absolutely necessary to dispose of some of them en route. Another version of the story on which the detectives are working is that the Hawkhaving been scuttled by the Cubans after her cargo had been transferred to another vessel. They do not take up this theory with any degree of activity, however, as made her landing in Cuba. A Tunnel Through Pike's Peak.

It is reported that the actual work on the tunnel through Pike's peak was begun eight miles from the Cripple Creek goldfield. The work is done under contract with the city of Colorado Springs, and the tunnel is to run from Beaver bringing the water down the canyon and into the control of the waterworks at Colorado Springs. The tunnel is 11,000 feet above the sea level and is to be over a mile and a half long. The workmen will drill through solid granite, and a tunnel 5 by 7 feet will be built. The contract calls for the completion of the work within two years. The price to be paid is \$16 per foot, and at this rate it is estimated that the work will cost \$250,000. Workmen have begun operations at both ends of the proposed tunnel. 

Origin of Two Tavern Terms.

The term "entire," so often seen over inns and taverns (and not always understood by the passersby), is said to have first been used about 1722. Prior to that date the malt liquors in general use were ale, beer and "twopenny." It was usual for tavern customers to call for a pint or tankard of half and half-that is, half ale and half beer, half ale and half twopenny, or half beer and half twopenny. In course of time it became customary to call for a tankard of "three threads," meaning a third of ale, beer and twopenny. To save publicans the trouble and waste of turning three taps for one pint of liquor a brewer named Harwood conceived the idea of making a beverage which should unite the flavors of all three drinks. He called his production "entire," or "entire butt beer." As it was considered suitable for porters and other working people it is said to have obtained the fur-ther name of "porter."—London News.


