The great annual celebration of the Germans of Washtenaw county will take place in Ann Arbor, next Thurs-The committee has made great preparations for a fitting celebration of he day which commemorates the first immigration of Germans to the shores of the New World. The first celebration of German-American Day was held Sept. 23, 1890, in this city and was also the first celebration of its kind in Michigan and was a grand success. It is the purpose of the committee to make this celebration not only equal, but superior to it in the matter of general amusements.

The Ann Arbor city council has decided to turn out in a body to do honor to the day. The German societies of Ypsilanti, Manchester, Chelsea, Freedom, Saline and Dexter, and delegaions from the different townships in Washtenaw county as well as the different societies in Ann Arbor will be as his recitation of "The empty haverpresent to take part in the exercises of

The program for the day is as follows: In the early forenoon, reception of the visiting delegations; this will be followed by a grand parade, in which as the hosts of the day, will form on Liberty st. and march to Washington st. where they will halt in open order while the visiting societies march between their lines. The local societies will fall in behind. The visiting societies from Saline, Freedom, Manchester, and elsewhere in the county will be formed in one division, those from Ypsilanti in another, and those from Detroit and Jackson, from which cities excursion trains are to be run, in another. The business men of the city have arranged for 60 decorated floats and wagons for the parade, and the local societies have each a decorated wagon for the occasion. The parade is expected to be over a mile long, and will march through the principal streets to the Relief and Turner parks, where dinner will follow. In the afternoon at 2 o'clock the "Festrede" will be delivered by Louis J. Lisemer, editor of the Hausfreund-Post and Washtenaw Evening Times; 4 p. m., meeting of delegates to designate the place of meeting next year. There will also be games, day, L. J. OLD SOLDIERS' PICNIC.

They Had a Jolly Time in Salem Saturday.

The event of last week for Salem was the veterans' picnic and reunion given on Saturday last, at the residence of Mr. and Mrs. Isaac S. Savery two miles west of Lapham's corners. The day was excessively warm but was otherwise pleasant until near the close of the program. There were 42 veterans present with many more civilians. Mr. and Mrs. Savery were indefatigable in their efforts to serve their guests and were ably assisted by their immediate neighbors. It had been expected that Judge C. B. Grant, of the supeme court, would be present and make the principal address of the occasion, but sickness in his family prevented his attendance. An effort was made to secure the attendance of Elder, late Capt. Allen, of Detroit, which was not successful. Two distinguished speakers were present, however, and occupied the time and attention of the company with entire acceptability.

The conspicuous hero of the occasion was Seargent Conrad Noll, recently the recipient of a bronze medal from the United States for courageous gallantry exhibited at the battle of Spottsylvania, on May 12, 1864. Though Uncle Samuel or his servants have been thirtytwo years in getting to the recognition of this deed of bravery, they have finally reached it and the many friends of the sergeant rejoice in his possession of his well deserved medal. LEAPED FROM THE BRIDGE.

Marvelous Feat Performed by a Woman in Attempting Suicide.

WASHINGTON, Aug. 18.-Mrs. Marcia V. Hopkins, 55 years of age, for the last thirty years a clerk in the treasury department, performed a marvelous feat on Monday afternoon by jumping from the rail of the aqueduct bridge into the Potomac river, a distance of seventy-five feet, without receiving the slightest injury. Her act was not for the purpose of creating a sensation or establishing a bridge jumping record, but was the result of a deliberate plan to end her life.

Walter Finlay was in the water at the time. To reach the drowning woman he had to swim about seventy-five yards. She did not accept his friendly efforts. He was so persistent that she finally submitted and allowed him to assist her. Mrs. Hopkins said she was not conscious of having been injured in the slightest, and never felt better in her life than she did after being taken from what might have been a watery grave. When asked to speak of the sensation experienced she said she felt the same as one feels when dreaming of falling to the ground from some high building. Her dress eased the fall. The skirts acted as a parachute, and prevented her from striking the water with the same force a man would.





WASHINGTON, Aug. 18.—The cable report from London that Lord Salisbury has yielded to Secretary Olney on the crucial point of the Venezuelan negotiations, that disputed tract in the proposed arbitration, is regarded as an important development by those interested in the subject. This inclusion of the "settled districts" has been the chief obstacle in the way of arbitration, so that if the report of its removal is confirmed the two governments appear to be nearer to an amicable agreement than at any time since the trouble began. Lord Salisbury has insisted from the first that this was sovereign British soil, which could not be subjected to the judgment of arbitrators.

Would Defeat Arbitration. Secretary Olney has urged that the omission of this settled portion from arbiration would defeat the whole scope of the arb tration, as the unsettled or worthess sections were not what Venezuela ontended for. The latest view of this phase was presented in a brief by Mr. Storrow, a lawyer of Boston, of whose ability Mr. Olney has a high opinion. The Storrow brief was laid before the Venezuelan commission as a part of the Venezuela case, but aside from this it is known that its line of argument was similar to that taken by the secretary of state. Since then, gold alone constituting the standard of money, gold has greatly increased in value and silver has greatly declined. That this change in relative value is not due to an overproduction of silver is plainly shown by the fact that from 1873 to 1894 the production of gold has been larger in comparison with its previous production than has the production of silver during the same period. Senses of Smell and Taste In Fishes.

The senses of smell and taste appear to be well developed in the great majority of the fish species. Tobacco thrown overboard from vessels is often seized by mackerel and halibut, but is immediately rejected. Nearly all varieties of fish, and more especially the "ground swimmers, "have a choice of food. Halibut and cod are attracted a great distance by certain kinds of bait. Herring, when fresh and in good condition, are splendid bait for cod, but are of no use whatever if they have become stale from long keeping. Catfish, buffalo and one or two varieties of the bass will bite bacon when they will pay no attention whatever to the luscious angleworm. The above and other facts which could easily be cited in proof have caused fishermen and scientists to come to the conclusion that the senses of smell and taste are both remarkably developed among the finny tribe. -St. Louis Republic.





MAYO AT REHEARSAL

HOW THE FAMOUS ACTOR TRAINED THE MEMBERS OF HIS COMPANY.

His Fondness For "Pudd'nhead Wilson." Ambitious Attempts as a Manager Which Failed-His Desetting Penchant For Arguing Was His Worst l'ault.

"The late Frank Mayo, whose sudder. death on a train near Omaha was such a painful shock to the whole dramatic profession, was one of the most severe and at the same time most just managers that it has ever been my pleasure to act under," said Henry Davenport, son of E. L. Davenport, the tragedian, and one of the managers of the Girard Avenue theater of this city. "He knew how a part should be played and insisted on the actor playing it in that way if it took 50 rehearsals to perfect the role according to Mr. Mayo's ideas.'

Mr. Davenport created the role of Judge Driscoll in "Pudd'nhead Wilson," Mayo's last success, and played it during the New York run of the production. "During the rehearsals previous to the first production of 'Pudd'n-head Wilson,' "continued Mr. Davenport, "Mr. Mayo acted every role in the play for the purpose of showing the members of the company how he wanted it played. Five Men Left Perched on Top of a Wall Which Did Not Go Down and They Are the Only Ones to Escape Injury-Fire Department Called Out and Begins Search for the Victims-List of Dead and

When the building came down five men who were working on the roof were left perched on the front wall. These were the only ones who escaped injury. They were taken down by the fire department

Some of the roof had been taken off and partitions had been knocked out. south wall bulged out in the middle, and roof, floors and wall came down with a partment was called out and a hundred men attacked the debris. The dead body of Halvor Oleson was first taken out John Thorsen of Little Black, Wis., was next. He is dying at the hospital. He leaves a wife and children. James Dean of Eau Claire came next. His recovery is doubtful. Men are 'still digging for the bodies of William Dean and Nicholas Roach, supposed to be buried deep in the basement. The front wall is still standing, but is liable to fall. Travel is blockaded for three blocks. The fall of a por tion of the west wall, torn down by the fire department, carried away electric light, power and telephone wires. Half the town is in darkness and the street rail way is tied up.

Feared Others Are Lost.

Two concerns had the job dismantling the building. Dean of this city had the contract to tear down the superstructure and Schmidt & Bros. of West Superior had the stone foundation. It is feared that besides Dean and Roach, perhaps three or four other men, in the employ of Schmidt Bros., are dead under the ruins. Their names are not known. It is said they were from West Superior. The searchers are making slow progress. The cause of the collapse is related as follows by one of the workmen: At the rear of the building extending from north to south was an iron rod which had been put in to strengthen the walls. This rod was cut in the course of knocking off the upper story. As soon as the rod was cut the north wall spread and the floors dropped and forced the south wall out-

GAIL HAMILTON DEAD.


