He Condemns the Present Useless Way of Expending the Street Fund-Desires a Safe Careful Administration of Affairs.

Mayor Hiscock's first annual message which was read at the council meeting last Monday evening was a careful business like document, and the mayor indulged in no flowers of rhetoric, but made a number of excellent recommendations. The main parts of the message are given below with a summary of the omitted sections, and every taxpayer of the city should read it.

Mayor Hiscock at the commencement of his address referred to the bonded indebtedness of the city which foots up to \$55,500. Of this, \$28,500 he said was for lateral sewers bonds and was only a nominal debt as it is provided for by tax levied on the several districts, thus 'leaving our net bonded debt at the reasonable figure of \$27,000 and as there is a balance of \$7,000 in the treasury our financial condition is cer-

tainly an enviable one.' Referring to the streets of the city he said: "I recommend the paving of Main st. Our city has nearly all the modern improvements and it is a source of surprise that no work has been done in this direction. A good brick pavement can now be laid for \$1.30 to \$1.50 per square yard and I would suggest that immediate steps be taken to form a paving district on Main st. from Catherine to William, and if the consent of property owners can be obtained that work on this needed improvement be commenced and carried on to completion. With one street paved and its advantages shown, others would follow and the business part of our city soon present a modern appearance. Our residence streets are in a deplorable condition and some actually impassible in February and March. When we consider that in the last eight years there has been expended on the streets of Ann Arbor the sum of \$77,917 it is humiliating to think how little we have received in return for this vast expenditure of money and I protest against the further continuance of this system of street work.







Man Who Captured Cherokee Bill Filled Full of Lead.

Fort Gibson, I. T., April 20.—Ike Rogers, the man who captured Crawford Goldsby, alias Cherokee Bill, came in on the 10:30 train Tuesday forenoon, and had only alighted on the platform when he was shot by Clarence Goldsby, a brother of the desperado. Not less than 200 persons were on the depot platform when the shooting occurred. The first ball took effect in Rogers' body. Then the people crowded away and Goldsby fired three shots from a six-shooter into Rogers' head. He then picked up Rogers' Winchester rifle and ran under the car to the other side. There was about fifty shots exchanged between him and the crowd, only one ball taking effect, it striking a colored man in the face and inflicting a painful, but not fatal wound.

How to Treat a Wound.

Three useful things to have in a farmer's house as a provision in case of wounds not sufficiently serious to necessitate the calling in of the medical attendant are a spool of adhesive plaster, some iodoform gauze and a package of carbolated absorbent cotton. Cleanse and dry as nearly as may be the cut surface with a wad of the cotton, using moderate pressure and elevating the part if necessary to check the flow of blood. Do not apply any water. Bring the cut surface together as a curate as possible and retain them there with as few and as narrow strips of the plaster as will suffice, cutting them of a good length. Then cover the wound with a dozen or so thicknesses of the iodoform gau which should extend an inch beyond

wound. Over the gauze apply a lib layer of the absorbent cotton, allowing it to extend beyond the gauze. The cotton may be kept in place by a bandage of cheesecloth, or a part of a leg of a stocking may be drawn over it. Moderate pressure, if evenly distributed, is helpful. The pressure of a string is hurt-Keep the part moderately elevated and take care that there is no constriction of the limb above the wound by a garter. - Exchange.

Looking for a Comnissioner of Labor.

Gov. Pingree's visit to Ann Arbor. Tuesday afternoon, gave rise to considerable speculation as to what its object was. A neglect or refusal to comply with this notice, will be deemed by me a sufficient cause for immediate investigation into the management of such estates as I have mentioned.

BATTLE IN PROGRESS.

Greeks and Turks Are Fighting at Reveni.

KING STARTS FOR THE FRONTIER.

Crown Prince Constantine Assumes Supreme Command of the Greek Forces-Twenty Thousand Men Engaged in the Fight Which Has Taken Place in the Milouna Pass-Costly Error Made by a General in the Greek Army.

Athens, April 20.-Fighting between the Greeks and Turks was resumed Tuesday morning at Reveni, not far from Tyrnavo, northwest of Larissa. A big battle was in progress. The Turks were attacking in still greater force than Monday, but the Greeks made a stubborn resistance.

It is reported here that a Greek force which was trying to bridge the River Arachthos, on the frontier of Epirus, has been driven off by the Turks. It is further stated that the Turks have advanced upon Arta and have been bombarding that place since 5 o'clock Monevening. Sharp fighting between the Greeks and Turks is proceeding on the frontier of Epirus.

The bombardment of Prevesa, Turkish position at the entrance of the Gulf of Arta, was resumed at 9 o'clock Tuesday morning by the Greek forces on land and sea. It is reported that the town will be reduced to ashes in the course of a few days. The Greek squadron left the Piraeus under sealed Several merchantmen have been hastily armed and detachments of Greek troops have been hurried on board of them.

GREEK GENERAL BLUNDERS.

Costly Error Is Made at Gritzovali-Au Order Misunderstood.

Athens, April 20.-There was renewed fighting between the Turks and Greeks in the Milouna pass Monday. It was is still young, asks if she can be told of of the most severe description, but full details are not obtainable here. The firing ceased at 5 o'clock Monday evening. The total Greek loss in the various engagements in the Milouna pass is estimated here at 1,000 killed and wounded. More than 200 wounded soldiers and officers of the Greek army have arrived at Larissa, Tyrnavo and Volo. The losses of the Turks are declared to be much greater than those of the Greeks.

Prince Constantine has returned to Larissa from Gritzovali, where he witnessed some severe fighting. The Greek reverse at that place was due to the fact that General Mastropas, who is in command of the Greek arfillery misunderstood Prince Constantine's orders. The Turks thereupon advanced, and soon occupied Gritzovali, pursuing the retreating Greeks, killing a few and wounding 20 of them.

General Mastropas' brigade later rallied and made a stand. In the meantime Prince Constantine hurried reinforcements forward to the assistance of General Mastropas. General Smolenitz, former Greek minister of war, succeeded in forcing back the enemy. Prince Constantine has severely censured General Mastropas for his blun-A dispatch received here from Cairo, Egypt, says that at the request of the Turkish government, the Egyptian government has handed the Greek diplomatic agent, M. J. Gryparis, his passports and has ordered all Greeks to leave Egypt within a fortnight.

Warships Compelled to Retire. Berlin, April 20.-An official telegram

received from Constantinople by the Turkish embassy here says the Turks have not sustained great damage at Prevesa, and that two Greek warships compelled by the Turkish hre retire from there and that Tuesday there were no signs of the Greek fleet being in the vicinity of Prevesa. The official telegram referred to further says that the Turks have recaptured all the positions commanding the Tyrnavo, thus confirming the dispatches on the subject from the correspondent of the Associated Press at the Turkish headquarters at Elassona

Party of Greeks Leave Texas. St. Louis, April 20.—Specials say that the first body of Greeks to depart from the southwest for the seat of war to fight for King George has left Texas. The men are headed by Alexander Stavrianos, who started from Dallas for the east to St. Louis, thence to Chicago and New York. At Marshall, Tex., a number of Greeks from Houston and Galveston joined the Stavianos party and others will be picked up at Little Rock, Ark. At New York they sail on the first steamer that can be taken.

Sensation in the Kentucky Senatorial Fight.

SENATOR OGILVIE IN FRANKFORT.

All the Members of the Upper House Now tion Than Ever-The Republican Candidate Issues a Card Saying He Will Not Prolong the Fight Beyond a Reasonable

Frankfort, Ky., April 20.-A sensation was created here just before the time for the senate to meet Tuesday morning. It was known that Mr. Hager, the new Democratic senator, had arrived with his certificate and would be sworn n during the morning. But when the train came in it bore Senator Ogilvie, the sick Democrat, who has not been here before this session. This made the senate full for the first time this session, with 138 members in a joint session, 70 Republicans and 68 Democrats and 70 once more necessary to a choice. It put Hunter one vote further from an election, and made more certain the impossibility of his election than has the indictment or any other occurrence this session. It also made it necessary for any new nominee to receive more votes to secure an election.

Card from Dr. Hunter.

Those who have up to this time doubted that Dr. Hunter, the indicted Repub-lican nominee for the United States senate, would withdraw gave up all hope Tuesday morning when they learned that he had issued the following statement over his own signature:

I have gone over the whole situation carefully, and I admit that I do not know where my one vote is to come Under the circumstances I am willing to say that I shall not prolong the fight beyond a reasonable time when I see that it is hopeless. This proceeding before the grand jury has had absolutely nothing to do with my change of front. It has not been a factor in the fight except to solidify and strengthen the loyalty of my friends. It was simply a transparent conspiracy to defame me.

"W. GODFREY HUNTER." New Man in Doubt.

Just when he will withcraw is a matter that is as yet doubtful, but in all probability he will get out of the race now very soon. But he will not do so until he and his supporters have settled on a man to become the nominee of the new caucus. Who that man will be is doubtful, but it is generally conceded that the fight will be between Judge W. H. Holt and Senator W. J. Deboe. The latter has the best chance, as Hunter is, said to be sore on Judge Holt because he has not taken off his coat and worked for him as Deboe has.

Looks Like a Dying Man. When the joint assembly met Tuesday both the new senator and Senator Ogilvie were on hand. Many pronounced the bringing here of Senator Ogilvie, who looks like a dying man, a crying shame. There was no journal reading, but the Blackburn Democrats demanded a preliminary roll call. The latter showed present and unpaired 108 fifty-first ballot begun but all voted as they have heretofore and the ballot stood: Hunter, 53; Blackburn, 38; Martin, 12; Boyle, 5; Stone, 1. Necessary to

Archbishop Ryan became titular bishop of the see of Tricomia twenty-five years ago last Wednesday. His episcopal concration took place in St. Louis in the Church of St. John the Evangelist, of which he was then the rector. The aniversary of the event having occurred in holy week the celebration was post-poned until this week.

Hundred Million Ounces of Gold.

Washington, April 20.-Autralia has this year reached the 100,000,000-ounce ine in her production of gold. That is, she has, since 1851, produced that amount of gold and the yield of that precious metal is on the increase. Victoria has produced 61 per cent. of this output. Consul General Maratta, who submits the figures in this connection to the state department, shows that the yield last year was 2,375,948 ounces, an increase of 16,000 ounces over the production of 1895.

Nominated for Congress.

Hannibal, Mo., April 20.-The primary election held for the selection of a Democratic candidate for congress to fill the vacancy caused by the death of B. P. Giles resulted in the nomination of James T. Lloyd of Shelby county by a majority of 204 over his strongest com-petitor, E. M. Richmand of Macon county. Lloyd received 4,448 votes and Richmand 2,244. The election will be

Killed by an Avalanche.

Red Cliff, Co., April 20.—A bad snow-lide has caused loss of life in Eagle iver canyon, three miles west of here. Frank Larsealoc and Ernest Kemp are dead and their bodies have been recovered, and it is supposed that three more men are buried in the avalanche, though it is not definitely known. FAIR CONTEST NARROWED.

Heirs Making Common Cause Againt Mrs. Nettie Craven.

San Francisco, April 20.—The trial of the only remaining issue in the Fair case has been begun. Instead of a contest over the whole estate and a struggle for \$20,000,000, it is a fight for \$1,000,-000, the case having narrowed down to a legal battle over two pieces of real estate which Mrs. Nettie Craven says Senator Fair conveyed to her by pencil deeds a few weeks prior to his death. The administrators and heirs have for a time forgotten their disagreements, and in this account have joined against Mrs. Craven, whom they regard as a

common enemy. After considerable discussion by the attorneys the court announced that the gery of the deeds. This issue had been raised by the answer of the administrators to Mrs. Craven's cross-complaint, and in so far as the complaint of Miss Virginia Fair raised the same issue as the intervenor would be heard. REPAIRING THE LEVEES.

New Orleans Does Not Mean to Give the River an Opening.

New Orleans, April 20.—The river is 18.9 above low water mark, and the reeling of uneasiness has nowhere subsided. The fine weather has given ample opportunity to make hard work the outlet for the general excitement, and thousands of men are at work in the city and country. Besides the constant strengthening of the banks many armed men patrol the levees at night to prevent the other fellows from cutting them.

With three breaks in Lousiana added to those in Mississippi, the situation should be somewhat relieved for the rest of the section, but the crest of the flood wave has been lost somewhere, and fears will not allay until the gauges show a drop of at least two

HYPNOTIST DEFIES SHERIFF.

Refuses to Take Up a Buried Subject at

Simcoe, Ont., April 20.—Professor Ferris, hypnotist, placed a subject in a trance here Monday afternoon and buried him six feet under ground, there to remain three days. Sheriff Jackson and a posse of officers appeared on the scene as the grave was filled in and ordered Ferris to take the man out or suffer arrest. The professor refused, stating that he was violating no law. After consultation with the county attorney, the sheriff found he could take no action. The subject is supplied with air through a box. His face can be seen. It resembles that of a corpse, but has not the extreme pallor. There is a great deal of excitement over the case.

Killed by a Train.

Chicago, April 20.-John Sheppard, a abover, 59 years old, who lived at 8220 Vincinnes avenue, was instantly killed by a Chicago and Eastern Illinois southbound train at the crossing at Eighty third street and the Western Indiana railroad tracks at 7 o'clock Tuesday morning. The body was badly mutilated, and was sent to the county morgue. The police are inclined to think that Sheppard deliberately threw himself in front of the train.

Brazil Massing Her Troops.

Rio de Janeiro, April 20.-Twenty battalions of federal troops are massed at Queimados, and a strong movement will be made in a short time against the rebel Conselheiro's positions. The Uruguayan government has presented a heavy claim against Brazil for per-mitting the passage of rebels across the frontier. An Argentine vessel navigating the river Uraguay was fired upon by forts on the Uraguayan shore.

Holman's Condition Favorable.

SUNDAY SCHOOL LIBRARIES.

Many of the Books an Insult to the Intelligence of Young People.

Edward W. Bok has been making a careful and comprehensive examination of Sunday school libraries, and in The Ladies' Home Journal he confesses himself disgusted with the literature thus placed in the hands of our boys and girls. A less complete investigation, Mr. Bok says, would not have made it possible for him to believe that the libraries of our Sunday schools were stocked with such piles of rubbishwishy washy literature," as he terms it. He quotes the titles and gives the themes of a number of books he obtained from Sunday school libraries, and these seem to completely warrant his conclusions. "Such books," he contends, "are an insult to the intelligence of the young people and have a pernicious influence. Instead of being healthy books they are decidedly unhealthy in tone and teaching. Surely we are cultivating a dangerous taste for reading in the young when we feed them on such rub-

Mr. Bok unhesitatingly lays a part of the blame upon the publication boards and societies, which are influenced by a denominational spirit that narrows their choice of books. Then, again, it is shown that the most mediocre sort of 'talent'' is employed to write these books, and that beggarly prices—less than \$80 per book—are paid. A share of responsibility, Mr. Bok asserts, rests upon the men who purchase Sunday school libarries, who, as is most frequently the case, are not qualified for the task and whose object is to secure a library as cheap as possible. Mr. Bok warmly urges that the selection of Sunday school books be left to women, who 'instinctively know and feel the kind of a book which a boy or girl will read and enjoy." He insists that women should be given carte blanche to make the selections so far as the prescribed amount of money will go. "A hundred good books," Mr. Bok concludes, "are far better than 500 books of indifferent interest," which are bought simply because they are cheap. "A Sunday school library cannot be created in a day, and no discouragement should be felt if the financial means of the church are contracted and necessitate the purchase of only a few books at a time.'

HOW THE COUPEURS GATHERED IT FROM THE HEADS OF THE POOR.

Wiles Employed to Get a Woman to Part With Her "Chief Glory"-There Was Always a Sure Market, For False Hair Was Worn by All Fashionable Ladies.

A question that has doubtless often presented itself is, Where did all this hair come from? This question I will endeavor to answer. With the coming of spring in the midlands and west of France appeared what may fitly be viduals, armed with long, iron tipped staves and bearing heavy packs of merchandise upon their backs. At first glance one would have taken them to be ordinary hawkers, yet merchandise was but an accessory to their strange industry. They were the coupeurs, the reapers of a hirsute harvest.

Armed with long, keen shears, they went their way seeking the tresses of willing victims dwelling in outlying hamlets and villages of peasant France, and a laborious business it was. From 'dewy morn'' until the shadows of night gathered thickly they did their 10 wayside. In Auvergne these seekers after hair were known as chimneurs. The Bretons called them margoulins. These terms have not fit English paral-

These curious journeymen exerted every effort to gain their ends—a good head of hair—the former preferring the local fairs as a workroom, the latter choosing to visit the dwellings of their possible clients. In summer the Brittany margoulin was often seen going through the streets, carrying his long staff, from which hung twists of hair, while he cried in doleful tones the well known "Piau, piau!" at the sound of which the cottagers, with an itching desire to possess some of his gewgaws, attracted the wanderer's attention. CARPET PRINTING.

When the First Experiments Were Made by John Bright.

The printing of tapestry and velvet carpets, after being woven in the white dates back 50 or more years ago. Old carpet men will at once recall the fabric made by John Bright at Rochdale, England, and how he flooded our country with his products. Their introduction, however, was difficult, as they came in conflict with the productions of John Crossley & Sons, then the greatest producers of the original tapestry and velvets in the world. The difference, of course, between the two productions was that the Crossleys had the designs shotes before Hank settled in the vicinprinted, as now, in colors on the warp before weaving, while that made by John Bright (tapestry) had its figures and colors stamped upon the fabric by hand after it was woven. A Bridge Kept In Repair by Mussels. The byssus, or silky beard, by which the mussel moors itself to the stone, is Press. a familiar object of our sea rocks. It is in its nature like the silk of the silkworm and exudes in a glutinous thread from an organ at the base of the foot.

The tide flows so very rapidly here that it was found impossible to keep the bridge in repair by means of mortar. The corporation therefore keeps boats employed in bringing mussels to it, and the interstices of the bridge are filled by hand with these mussels.

It is supported from being driven away by the tide entirely by the strong threads which these mussels fix to the stonework, and by an act or grant it is a crime liable to transportation for any person to remove the mussels unless in the presence and by the consent of the corporative trustees.—Scottish Nights.
