Ann Arbor Merchants Prosecute a Firm Under the

TRANSIENT TRADERS

Ordinance and Secure a Justice Court Conviction.

The Defendants Went to Jail Rather Than Pay Their Fine.-A Damage Suit Against the City Will Likely Result.

The transient traders' ordinance which has since its passage by the council over a year ago been more or less of a dead letter on account of the lack of efficient enforcement of its provisions on the part of the city authorities has again been brought prominently before the public by the result of the suit brought in Justice Duffy's court yesterday afternoon which, it is expected, will eventually decide the constitutionality of the ordinance which was passed by the common council of Ann Arbor, Sept. 14, 1896.

The city merchants demanded that the provisions of the ordinance be enforced. City Attorney Kearney de-clared that it was unconstitutional and refused to prosecute, and then the merchants took the matter into their own hands, raised the money necessary to conduct the case, employed counsel and entered suit.

The defendants in the case are Luther L. James, Ed. Croarkin and Patrick Sloan, all of Dexter, who on October 30, opened up a clothing stock in the store No. 109 N. Main st., and when applied to by Marshal Sweet to pay the \$10 a day license fee imposed by the ordinace refused to do so. M. J. Cavanaugh appeared on behalf of the complainants, and Arthur Brown for the defendants.

A jury was drawn and sworn in as follows: Ottmar Eberbach, foreman, E. F. Mills, W. G. Henne, A. M. Doty, G. H. Wild and M. Goodale. The case was then proceeded with.

Mr. Cavanaugh opened the case and explained to the jury the contents of the indictment, the provisions of the charter, and the power given to the council by that charter to frame and pass such an ordinance, and stated that although the ordinance provides that application shall be made to the city clerk for a license to do business by transient traders, the defendants had not made any such application.

The only witness called on either side was Marhal Zenus Sweet, who testified that he had demanded the license fee from Mr. James who declined to pay it as he was going to locate here permanently. He also made the same statement to Mayor Hiscock, who explained to Mr. James that if he located here permanently the money would be refunded to him.

Mr. Cavanaugh contended that the ordinance was valid as the state had given the city council authority by the charter to impose just such provisions for the safety of residents of the city, and quoted numerous decisions of the supreme courts in support of his arguments, he also showed that the courts were very chary about interfering with municipal discretion.

Mr. Brown only quoted one decision of the supreme court in support of the defendants' side of the case, but claimed that the ordinance was a highly discriminative one and that the license fee was more of a tax than a license, and that for those reasons it was unconstitutional.

Mr. Cavanaugh replied to Mr. Brown's remarks and the case was given to the jury, who after a brief deliberation brought in a verdict of guilty thigh. She thought nothing of it at of not complying with the city ordinance

Justice Duffy sentenced the defendants to pay a fine of \$15 and costs or to should be paid for a period not to exceed 15 days.

On advice of their attorney the defendants refused to pay their fines and costs claiming that they had no money. A commitment was therefore made out and the young men were taken to jail to serve out their sentence.

Last evening notices were posted on the door of the store which read "Gone to jail for selling goods too cheap."

From the fact of the defendants having chosen to go to jail rather than pay their fines or enter an appeal against the decision of the court and jury it is evident that they intend to institute a damage suit for false imprisonment. How they will come out in such a suit to be seen, but so far the merchants are on top and if the ordinance is as good as its backing they will remain there.

NANSEN'S STORY

Will Be Told by the Great Arctic Explorer Himself Tuesday Evening.

Popular interest in the coming of a lecturer is seldom so greatly awakened Barney Gorman Went to Sleep as in the case of Dr. Fridtjof Nansen, who will lecture at University hall on Tuesday evening next in the S. L. A. course. Dr. Nansen's lectures in the east have drawn splendid audiences. He was given an ovation at the reception tendered him in New York, and if his greeting in Ann Arbor is on the same scale University hall will not be large enough to accommodate the great crowd that will be present to greet the great Arctic explorer.

Ten years ago Dr. Nansen was comparitively unknown, except to his own country and to a few scientists in England. He was preparing for a long desired journey on which he had set his thoughts many years before-an attempt to cross the inland ice-lap of Greenland from east to west, the safe accomplishment of which, in the summer of 1888, spread the young Norwegian's fame far and wide.

He is described as a most interesting and fascinating man, slim and tall in stature, being over six feet in height and very fair; strong, active, determined, full of knowledge and resource, a worthy descendant of the vikings, his very name-Fridtjof, an uncommon one in Norway-signifying a viking. He speaks in excellent English, with

The whole civilized world knows about Dr. Nansen's voyage to the Arctic succeeded in working out beyond the regions in his remarkable ship, the Fram, on whose peculiar construction he depended largely for success. 



WHAT ONE LEADER SAYS ABOUT IT

Declares That the Proposed Importation of Coolies into an Illinois Coal Mine Is Proof of the Justice of the White Men's Demands-Defection of Union Men at Braceville and Elsewhere Arouses Indignation-Knights of Labor in Convention.

Spring Valley, Ills., Nov. 9.-The news that Chinamen are to be imported into the mines at Carbon Hill is not considered very seriously at this place. Men stood around the corners all morning in knots discussing this latest phase of the strike situation in northern Illinois. But the coolles did not interest them as much as the reported settlement at Braceville, where it is reported the miners have accepted the operators'

The men in this part of the district are indignant over the action of the Valley leaders say that, no matter if Braceville does return to work at a non-union scale, they will hold out until next May, if necessary, for the one formulated at Springfield.

Firm for a Living Wage.

Ladd, Seatonville, La Salle and Peru are equally firm, The miners of La Salle had a meeting. A few days ago sixty foreign-speaking miners signed the non-union scale. The meet- Columbus, O. ing was arranged for the purpose of persuading these men from going to work. It met with success, and La Salle is as firm for the union scale as it ever was. The labor leaders here scoff at the idea of the "coolie" movement, which the general Wilmington company is back of, being a success. They say it is only a bluff. Said one prominent leader

"What if they do succeed in working one obscure mine with Chinamen. That does not necessarily break the strike. We are not going to let 200 Chinamen at Carbon Hill make the price of coal digging for 2,000 white miners of northern Illinois. The very fact that the northern Illinois operators are importing cheap 'coolie' labor is an indication that the white miners are poorly paid and evidence of the justice of their cause." Convention at Streator.

A committee of miners from this point of the district will probably be sent to Braceville for the purpose of inducing the men of that place to reconsider their late action. A delegate A. Brown and wife to B. B. The Toposcope. In the loftiest tower in the city of Vienna there is a novel instrument, known as the toposcope, constantly attended day and night, for the purpose of locating fires. It consists of a good telescope, which is solidly attached to an arrangement of levers, while graduated sections of a circle are arranged horizontally and vertically in such a way that the moving of the telescope sideways or up or down results in a change of position of the hands attached to the levers in reference to the graduated scales. Thus, the stability of the apparatus being assured by the firmness of the fastening, whenever the telescope is focused upon the same object the hands will point to the same figures on the horizontal and on the vertical sextant, and since an index of the whole city has been made it is but a matter of a few seconds, when a glare is discovered at night, to direct upon the spot the toposcope on the side, to read off the numbers, to look up the object and to telegraph to the central station the details observed. Local conditions are, of course, necessary for the successful operation of such an apparatus, but in this case they are said to be almost perfect. The tower is over 500 feet high, and an uninterrupted view of the great area of the city is thus possible to the watchman if the atmospheric conditions are favorable.

America have a A New York Policeman Rewarded For

Catching a Burglar. Hon. Theodore Roosevelt writes an article entitled "The Roll of Honor of the New York Police" for The Century. Mr. Roosevelt says:

Early in our term we promoted a patrolman to the grade of roundsman for activity in catching a burglar under rather peculiar circumstances. I happened to note his getting a burglar one week. Apparently he had fallen into the habit, for he got another the next week. In the latter case the burglar escaped from the house soon after midnight and ran away toward Park avenue, with the policeman in hot chase. The New York Central railroad runs under Park avenue, and there is a succession of openings in the top of the tunnel. Finding that the policeman was gaining on him, the burglar took a desperate chance and leaped down one of these openings at the risk of breaking his neck. Now the burglar was running for his liberty, and it was the part of wisdom for him to imperil life or limb, but the policeman was merely doing his duty, and nobody could have blamed him for not taking the jump. However, he jumped, and in this particular case the hand of the Lord was heavy upon the unrighteous. The burglar had the breath knocked out of him, and the "cop" didn't. When his victim could walk, the officer trotted him around to the station house, and a week afterward he himself was promoted, it appearing upon careful investigation that he was sober, trustworthy and strictly attentive to his duty. Here again it seems to me that we

followed the eminently common sense plan of promoting a man who had earned his promotion by faithful and distinguished service and by proved superior capacity. We cared no more for the policeman's views on the tariff or the currency than we did for those of the burglar. Our interest and the interest of citizens generally was to have the officer catch that burglar and otherwise do his duty. If he did his duty, we were for him; if he did not, we were against him. In neither event did we care whether the officer had or had not the backing of the congressional delegation of the city or the central committee of the county. Of course, as perore, exposed us to wild outcries from the exposed us to wild outcries and heelers and much sneering at "civil service reform," but all the outcries and sneers meant was that we were doing our duty as decent men and as public officials, with some slight appreciation of what was implied by the words honor and uprightness. Political organizations are eminently necessary and useful, but when they are seized by professional spoils politicians of low morality, who run the "machine" in their own interests, who clamor against honesty and defy decency and rail against that device for obtaining clean government which is known as civil service reform, then it is time for all citizens who believe in good citizenship to rise in re-

The army of ants had formed up in line to this twig, and whenever the breeze blew it against the wall the foremost members of the band took advantage of the opportunity to get across.



PARDONED BY BLANCO.

New Captain General of Cuba Issues an Edict.

Will Pardon Cubans as "Insurgents" but Punish Them as "Incendiaries"-Stormy Voyage of the Filibuster Silver Heels-Report That Spain Will Grant Amnesty to the Crew of the Competitor-Rights of the United States Acknowledged.

Havana, Nov. 9 .- Marshal Blanco has issued the following edict, officially described as "expressing the magnanimous sentiments of the queen regent and the firm determination of the national government:"

"I pardon in full all those who have been prosecuted for the crime of re-

Rebels prosecuted for common crimes, independent of rebellion, such as spollaoffenses committed by them.

"Those suffering sentences imposed prior to the date of the edict will have their sentence commuted to a certain extent, and perhaps in some cases in

"Persons pardoned should appear before the civil and military authorities at their respective places of residences, which they will designate and which will be communicated to me.

Within the Military Zone.

'Should they designate places of residence outside the principal towns, they will be advised of the necessity of residing within the military zone of cultivation. The military authorities will be careful not to invade the jurisdiction of the civil authorities. Therefore, those pardoned cannot change their residence without obtaining the permission of both civil and military authori-

General Blanco's decree announcing pardon for political crimes does not extend in its action to "crimes" punished under special military law. category belong all the important revolutionists. They have been sentenced for "rebellion and incendiarism" at the same time, the first offense being political and the second a common crime.

The pardon, therefore, amounts to nothing practically, since, from General Gomez down to the last soldier in the revolutionary ranks, all have been sentenced by Spanish court-martials as common outlaws.

SILVER HEELS' STORMY TRIP.

Filibuster Accompanied by Tug Wise on the Trip to Cuba.

New York, Nov. 9 .- The little schooner Silver Heels, which in the early morning of Sunday, Oct. 17, dodged the revenue cutter Chandler and put to sea with a cargo of arms and ammunition for the Cuban insurgents, had a stormy trip. It now appears that she had the company in her tribulations of the tug

The Bilver Heels was subsequently reported off the Florida coast, but nothing more has been heard of her. SPAIN'S REPLY PACIFIC.

Full Text of the Document Read at the Cabinet Meeting.

Amnesty for Competitor Crew.

Washington, Nov. 9 .- Spain will remove one of the most serious dangers of friction with the United States by granting amnesty to the Competitor's prisoners. The announcement will be made in an amnesty proclamation shortly to be issued by the Spanish government. An intimation of Spain's action has been given to the administration. This action would indicate that the Sagasta ministry intends to start its work of attempting the pacification of Cuba by completely reversing the policy of General Weyler. It is supposed here that the Spanish government proposes to direct the discharge of these prisoners upon condition that they will leave the island of Cuba at once, never to the diseases for which it is recommend-lar form of insanity beyond, perhaps,

Acknowledges United States' Rights.

London, Nov. 9.-It is published here with show of authority that Spain has flefiantly acknowledged the right of the United States to interfere in Cuba. REPORT ON MICHIGAN'S CROP.

Acreage of Wheat Is Greater Than in '96, and Condition Averages Well.

Lansing, Mich., Nov. 9.-The official crop report says that the acreage condition of wheat in the state Nov. 1 was 82, comparison being with vitality and under the ground to the distance of growth of average years. The condition in the southern counties, where 85 per cent. of the crop is grown, is 13 per cent. lower than one year ago. fields favorably situated it is looking well, but a large proportion of the fields are more than ordinarily spotted. Recent rains have been of great immediate advantage, but heavy, soaking rains are yet needed to place the ground in the usually wet condition at the opening of winter. The estimates indicate that the area seeded to wheat this fall is 6 per cent, greater than sowed in the fall

The average yield of corn per acre in the state is estimated at sixty-one bushels of ears, equal to about thirty bushels of shelled corn. The area of clover seed harvested is large, at least much larger than in any late year, and the estimated average yield higher than ever yet reported in the farm statistics. The yield in the state is estimated at 1.92 bushels per acre. Potatoes are estimated to yield in the state 64 per cent. of an average crop.



PARADE THROUGH THE STREETS

In Spite of the Foggy Weather and Drizzling Rain Thousands Turn Out to See the Show-The Political Situation in Austria-"Badeni Must Go" Is the General Warcry-Prince of Wales Celebrates His 56th Birthday-Foreign Notes.

London, Nov. 9 .- In spite of a thick drizzle and a heavy fog the ancient custom of presenting the elected chief magistrate of London to the representatives of the sovereign and to the people was observed with success. The usual throng lined the route and the decorations were more numerous than customary. They consisted mainly of triumphal arches, Venetian masts, floral festoons, and a that such an incident as is described liberal display of bunting.

were exchanged, the lord mayor, in exercise of an immemorial right, remaining covered while the recorder read a eulogistic review of the new lord mayor's career, referring to his blameless youth, successful commercial career and well-spent life, crowned by the attainment of the highest civic honors. From this court, after the retiring lord mayor had been formally presented to the judges by Sir Forest Fulton, the procession went to the court of appeals and was received by the master of the rolls and the appeal judges, attired in their robes of black and gold. The ceremonies here were merely formal. The dignitaries then returned to their coaches and resumed the march to the city. BADENI MUST GO.

Chaos Prevails in the Political Situation in Austria.

London, Nov. 9 .- A letter received here from Vienna says the published reports of the political situation in the Austrian empire convey no adequate idea of the chaos prevailing. "Baden! must go" is the general warrry now, and his downfall is considered inevitable, regardless of the outcome of the present fight between the Germans and the Czechs. The letters adds:

'No one can foresee how it will end. If the Germans win there may be bloodshed in Bohemia and if the Bohemians are persistent the Germans will have to fight with their sharpest weapons to assert their prerogative and save the Austro-Hungarian duality. The danger, however, lies in the active participation in the fight by the Germans over the border. There is actually a small party in the reichsrath which openly declares for Prussia and wants to see the former German provinces, as Bohemia, handed over to the Hohenzollerns."

Paris, Nov. 9.-The French government has decided to abide by the judgment of the court-martial which condemned ex-Captain Dreyfus.

Famine Is Raging.

St. Petersburg, Nov. 9.—A terrible famine is ravaging the province of Archangel in European Russia. Many have died of starvation.

Found in a Dying Condition.

Pineville, Ky., Nov. 9.-Andrew Vaughn, a prominent farmer, and his wife were found by neighbors in their house in a dying condition. It is supposed Vaughn became mentally unbalanced and while in that state shot his wife and then himself.

Account of How He First Wrote His Favious Speech.

Speaking of the dedication of the national cemetery at Gettysburg and Mr. Lincoln's famous address delivered on that occasion, Nov. 19, 1863, Governor Curtin began by saying that there had been much discussion as to how and when that address was written, and he continued, says be Independent:

"I can tell on all about that. Of course I was there, and the president and his cabinet had arrived and were at the hotel. Soon after his arrival, as we were sitting around in the parlor, Mr. Lincoln looked thoughtful for a moment or two and then said: 'I believe, gentlemen, the committee are expecting me to say something here today. If you will excuse me, I will go into this room here and prepare it. After a time he returned, holding in his hand a large, yellow government envelope, on which he had written his

"'Here, gentlemen,' he said, 'I want to read this to you to see if it will do.' And, sitting down, he read it to us and then said: 'Now for your criticisms. Will it do? What do you say?'


