## A CHAPTER OF CRIME Instead of Killing the Horse He Acci-

A Young Woman Found Unconscious in a Hotel.

### SUED FOR BETRAYAL

Arrest in Wayne County.

Under a Promise of Marriage. She Was a Witness in the Late Richards' Case.

A rather peculiar case has occupied pulbic attention somewhat in Ann Arbor during the last few days. Tuesday afternoon a young girl registered at the Arlington house as Nellie Fawn, of Toledo. Wednesday morning as she was not out of her room at noon the chamber maid entered it and found her apparently unconscious from the effects of chloroform or laudanum. Dr. Cowie was called who revived her. She strenuously denied that she had attempted suicide and claimed that she had had a bad toothache and had taken the drugs to ease the pain. As soon as she recovered consciousness she left the hotel and later was found by Marshal Sweet at the rooms of a friend of hers who is a medical student named Howard Strick.

It was the old story of a woman's betrayal, her approaching shame, and a desire to conceal it. She had come here at the request of the young man, who to Marshal Sweet said "She is in trouble, and I let her come to help a friend out. I did not think she would try to kill herself. I don't want her to die on my hands. I'd rather have you take her to jail." And, to jail the weeping girl was taken. She said: An Ann Arbor Grocer Bound Over to 'He promised me he would let me have a good time if I would come. Now I'm going back to Allegan. I have known him a long time and think a great deal of him.'

At the jail the girl was taken up into a cell and when Marshal Sweet came down stairs he was asked by Sheriff Judson who she was. ### A FATAL SHOT.

dently Killed Himself.

A fatal and peculiar accident happened in Freedom on Tuesday of last week by which an unmarried man named William Schniering, a day laborer aged about 50 years, lost his life. The Argus is indebted to the Manchester Enterprise for the following account of the sad affair:

"Mr. Schniering was called to George Hohenberger's, who lives about a quar. As Soon as the \$1,000 Neter of a mile north of the Catholic church, in Freedom, to shoot an old horse. He was often thus employed. The horse was in a lot back of the A Young Man Robs His Benefactress the evening at the Athens Theater. house. Geo. and Hannah Hohenberger went to the lot with Schniering who held the horse with his left hand and held a revolver in his right. He intended to shoot the norse just above the eye. The first shot made only a slight wound, and Schniering said the animal held its head too high. The second shot was fired, but instead of seeing the horse drop in its tracks as was expected, they saw Schniering fall to the ground and the horse ran off and began eating grass. Recovering from their astonishment they looked at the prostrate form before them and were still greater surprised to find him quite dead. his face covered with blood.

"The horse was quite restive and in some manner undoubtedly struck the revolver, diverting its aim, as the ball struck Schniering just below the right eye, near the nose and came out at the left temple.

"Supervisor Dettling and Justice F. H. Koebbe were notified and an inquest was held at which it was decided that death was accidental.

"The body was taken to George Schniering's, an uncle of the deceased, who lives on the south side of Pleasant Lake, and the funeral was held at Bethel church, Thursday forenoon, Rev. Paul Irion officiating.

The laudable project of the citizens of Dexter to erect a soldiers' monument in that village is getting along finely and it is an assured thing that a monument will be erected which will be an honor to the soldier dead and a credit to the village and those who are subscribing to the fund.

At an enthusiastic meeting held Saturday evening, at which 250 people were present, it was reported by O. C. Bostwick that he had already solicited and had in hand over \$400, and over \$500 had been promised. The first person visited by Mr. Bostwick was the venerable Dennis Warner, who subscribed \$100 as his donation to the monument, and there were others who also responded nobly.

At a previous meeting a gentleman was present who showed several handsome designs of monuments, one of which was selected which would cost \$1,000. It will be about 20 feet in height and is surmounted by the figure of a soldier. The monument will be erected in the public square at the point of the park and will be flanked by two cannons.

At the meeting Saturday night O. C. Bostwick was chosen as chairman of the Soldiers' Monument Association that was then formed, W. C. Clark secretary, and Harry Carpenter treasurer. A committee of 12 was also appointed to solicit further subscirptions.

The people of Dexter are very much in earnest about having a soldiers' monument and hope to have it dedicated on Memorial Day, May 30, 1898.

Nearly 75 Per Cent. of the 400,000 Helpless Women, Children and Non-Combatants Affected by Weyler's Policy Have Died-Spanish Troops Also Suffer Heavily-Not Half of Those Sent to Cuba Are Now Alive-Blanco in a Bad Way.

As nearly as can be conservatively computed from official figures, little more than half are left alive and well of the 180,000 vigorous peasant died on the field, 12,000; sent back to Spain as "inutile," 25,000; now in hospitals, 12,000; total, 81,000.

ELUDED BY THE DAUNTLESS.

Naval Authorities Bothered by Movements of the Filibuster.

Washington, Nov. 16 .- The filibustering steamer Dauntless is again causing serious concern to naval authorities. A telegram to the navy department from Key West announces the sudden arrival of the Dauntless at that point, although Saturday the commanding officer of the Vesuvius, who was watching her at Jacksonville, reported her in dock there, being cleaned and painted and generally placed in condition for another expedition. He thought she would be ready in another week.

Kingston, Jamaica, Nov. 16.-The threatened rupture between Germany and Hayti has, so far, been amicably settled, though it is still understood that Germany intends to make a naval dem-German version of the trouble has already been published. Following is the Haytian side of the dispute: The dispute arose out of the imprisonment of Herr Emile Lueders, the son of a German who married a Haytian woman, for an assault upon a cab driver, said to have been unprovoked, to Lueders, it is claimed, pleaded guilty, he was sentenced to one year's seclusion and a fine of 500 francs.

An appeal was pending when the Ferman minister interfered without invitation and, it is claimed, forced his way into the private apartments of Tiresias Simon Sam, the president of the Haytian republic, and in a rude and peremptory manner demanded the release of Lueders, with an apology to the German government, an indemnity of \$1,000 a day for the time he had been in prison, the immediate trial of the police who arrested him and the dismissal of the judges who sentenced him. If the prisoner were not released within twenty-four hours the indemnity was to be \$5,000 per day for every day afterward. Feeling the current of public opinion and the certainty of support in any defensive action which he might take, the president called in as many troops as could be reached at short notice, the barracks were filled, ammunition was served out and every preparation made for a fierce struggle.



Widow and Brother Demand Remains of Ketcham.

LIVELY CONTEST IS EXPECTED.

If the Wife Can Show Her Marriage Certificate the Coroner Must Recognize Her-Otherwise the Relatives of the Deceased Will Win-An Appeal to the Courts May Probably Occur-Nothing New Revealed by the Inquest.

Chicago, Nov. 16.-If Mrs. John B. Ketcham, better known in the neighborhood of 3421 Indiana avenue as Mabel Wallace, persists in her determination to bury her husband's body in her own lot at Forest Home cemetery there will be a contest over the remains. The brother of the dead man is determined to carry the casket back to Toledo, O., with him. If the widow expects to come out of the fray victorious she must show her marriage certificate to Chief Deputy Coroner Mandelbaum, something she has heretofore refused to do. This was the prospect in view when at 10 o'clock in the morning a coroner's jury took possession of the luxurious back parlor in the widow's home and commenced the inquest over the remains of the clubman. The investigation will with little doubt be continued until a later date as the analysis of the stomach of the deceased is not as yet completed. The opening of the official inquiry gave prospect of trouble. widow had stated positively that her husband would be buried in her lot. Brother Insists Upon His Right.

With equal determination George Ketcham, the brother, had expressed his intention of taking the body to the family lot in Ohio. He went so far as to engage Daniel Horan, an Eighteenth street undertaker, to take the body to Toledo and there inter it. As a first step the undertaker applied to Chief Deputy Mandelbaum for a death certificate, but was refused.

"None will be issued until after the inquest," was the ultimatum from the coroner's office Mr. Mandelbaum will then decide into whose possession the body will go.

"This woman," he said, "will have to show me her marriage certificate be-fore she secures possession. If she thus proves she is his wife, she will, of course, be accorded the custody of the remains. If not, the brother will be intrusted with the casket. By the looks of things, I rather expect a dispute over posses-sion of the body."

Neighbors of the widow expressed it as their opinion that she would yield to the brother's claim, in spite of her previous attitude.

Must Await Official Report. Chief Deputy Mandelbaum took charge of the inquest in person.

"We will have to continue it," he said, "as the analysis of the stomach will not be finished short of two days, perhaps. Dr. Noel is conducting this end of the investigation, and of course our jury must receive his report before it can reach an intelligent verdict. Do I think the analysis will bring startling disclosures? No, I do not, but we are acting on the safe side. The circum-stances seemed to call for an investigation, however. The post-mortem showed the liver was almost gone as the result of heavy drinking, and it is my opinion death was due to natural causes."

George Ketcham was one of the first witnesses called at the inquest, and it was the coroner's intention to adjourn with his evidence. Walkup Died Suddenly.

Exactly one month after the marriage, Walkup died suddenly. A post-mortem examination revealed traces of arsenic in his stomach. The young wife was arrested on suspicion. The prosecution attempted to show that she had purchased arsenic at Cincinnati before they started for his home in Emporia, also that she had applied to several drug stores for poison, but she refused to sign the record showing its purchase.

The trial lasted three weeks. defense made no denial that death had resulted from arsenic, but claimed the man was in the habit of using it as medicine and by accident had taken an

When the young and beautiful girl took the stand in her own defense, jurors and even lawyers wept over her testimony, and a verdict of acquittal was returned. She had only one friend during that trial—a wealthy man named William Jay, who interested himself in her behalf and paid the expenses of the

Concluded to Suspend Business.

Delta, Col., Nov. 16.-After a prolonged session the directors of the Delta County bank concluded to suspend business and place the institution's affairs in the hands of an assignee. A. R. King was named for that position. The bank has been regarded as one of the soundest on the western slope. An accountant has been put to work on the books, but a statement has not yet been issued. The capital stock of the bank is \$50,000 and the deposits at this time, as near as can be learned, are \$52,000.

Instantly Crushed to Death.

Chicago, Nov. 16 .- Albert Hellander, an employ at Barnum & Richardson's car wheel foundry, 64 South Jefferson street, was crushed to death by the breaking of a crane used to lift heavy pieces of machinery from one part of the factory to the other. Hellander was standing directly under the crane when it broke, and a car wheel descended, striking him on the breast and killing him instantly. He was 38 years old and was married.

How a W tness In a Pension Case Announced Her Husband's Death.

Residents from Ghent and loafers from the wharfs sat together on one bench, and the bailiff, not to lose so good a chance, manifested his authority by calling out "order" and himself making more noise than all the people in the court.

## SILVER REPORT COMES

Official Compilation of the Correspondence.

INDIA SAYS NO, BUT MIGHT AID.

That Government Says France and the United States Had Gold to Fall Back on If Needed - Reply Might Have Been Modified Had Co-Operation of Other Countries Been Assured-Basis of Britain's Refusal to Join Conference.

Washington, Nov. 16.-The official report of the correspondence in regard to the bimetallic proposals of the United States monetary commission to the government of Great Britain, together with the report of the proceedings at the conference of the British premier, the secretary of state for India, the first lord of the treasury, and the chancellor of the exchequer, with the French ambassador and our commissioners, has reached this country. It fully confirms the reports cabled on Oct. 21 and 22. The negotiations fell through, notwithstanding the expressed willingness of the French government to open its mints, owing to the rejection by the British government of the proposition to again open the Indian mints to the free coinage of silver. None of the other propositions were replied to because that one, the most important concessions requested of Great Britain, could not be acceded to.

Deferred to India's Wishes.

The government of Great Britain, in making her answer, deferred to the wishes of the government of India, to which the proposal was referred, and the reply of the government of India, therefore, is the most important communication in the correspondence. It is a lengthy document, in which the advantages, pro and con, to India are argued, and a very strong case from their standpoint is made out in favor of the rejection of the proposal. The disturbance of values in India, with the attendant paralysis of trade, at least temporarily; the fall of silver prices in India, concurrently with the increase of gold prices in Europe and America, etc., are advanced, but the most potent reason urged against the proposition is that the burden of failure, if failure should come from the experiment for the re-establishment of bimetallism by France and the United States, must inevitably fall on India. Both the United States and France, the reply argues, with their supply of gold, could to a greater or less extent protect themselves if the experiment did not succeed. In other words, the Indian government as a preliminary proposition declared that it could not risk the success of the suggested meas-

Contains a Reservation.

This definite and absolute rejection of the proposal was fully set forth in the cable reports of the correspondence, but the document contains a reservation which would seem to indicate that if the scope of the proposed experiment were sufficiently broadened India might be willing, at least, to reconsider her refusal. That paragraph in Lord Elgin's letter is as follows:

"We note that the proposals of the governments of France and the United States are subject to the proviso that they are satisfied that they will receive assistance from other powers in increasing the demands for silver. We believe that a limited increase of the quantity of silver used as currency will exercise a very trifling influence, if any, in Typographical Journal.

General Breckinridge will suggest the advisability of a competent transfer of the administration of the homes to the jurisdiction of the secretary of war and the creation of a new bureau of the war department to manage its affairs.

The blind man has to depend almost entirely on the accuracy of his ears to guide him wherever he may wish to go, and it is remarkable in what a short time he becomes familiar with a new locality and fresh surroundings.

Few people are aware of the powers of the ear, but the blind, through constant exercise of that organ, are able to discover objects almost as rapidly as a

seeing person.

For instance, when walking in a perfect calm, he can ascertain the proximity of objects by the feeling of the atmosphere upon his face. It would seem at first that the echo given back, were it only from his breathing, might be sensible to his ear, but it has been as-certained by experiment that a blind bor and Toledo only. man with his ears stopped can tell when any large object is close to his face, even when it approaches so slowly as not to cause any sensible current of air.

When he is walking along the street, he can tell whether it is wide or narrow, whether the houses are high or low, if any opening which he may be passing is a court closed up at the end or whether it has an outlet to another street, and he can tell by the sound of his footsteps in what lane, or court, or square he is.

He goes along boldly, seeming to see with his ears and to have landmarks in the air. Of course no blind man likes to go over a new route unattended, but after he has traversed it once he knows every point of importance to him.-Pearson's Weekly.

YAWN AND LAUGH OFTEN.

Scientists Declare That Both Are Highly Beneficial.

It is not so very long ago since a foreign scientist discoursed on the benefits of yawning. This act, which is generally regarded as partaking of the nature of a tired condition, or symptom of such a condition, of the respiration and of the need for fresh air, is said to be of great service in clearing the eustachian tubes of the ears. These tubes lead from the back of the mouth to the inner side of the ear drum, and a yawning is looked upon in this light as a hygienic exercise which benefits the structures in question.

Another scientist has no difficulty in showing that when we laugh we increase the play of tension in our lungs. One result of this increased tension is to arrest the blood flow in the lungs and to induce the taking of deep inspirations. These latter are healthful things, for many parts of our lungs are not called into active use in ordinary breathing. The apex, or top of the lung, is notably a part which does not actively participate in the movements of breathing, and as this is the special seat of consumption attack we may reasonably hold that the law of disuse explains the greater liability of this portion of the organ to the onset of disease. The free and active use of a part, strengthening and toning it, as it were, is an essential condition for health; hence laughter, by bringing into play the whole of the lungs, or at least by favoring an increase of lung work, is to be reckoned an admirable exercise.

Besides this physical effect of laughter we have also to take into account its mental side. There is a certain brain stimulus to be noted, a psychic result, in addition to the physical effect, and it is pretty certain the mental phase of a good, hearty laugh is, in its way, as healthful as is its physical aspect. Singing is also praised as an excellent lung exercise, and public speaking is as effective a lung tonic as one may wish for. The only drawback to the work of the speaker is the foul condition of the atmosphere in which he has often to do his work. - Exchange.

## The Most Costly Fruits.

Hothouse grapes are the costliest of fruits. They are never less than 75 cents a pound, and when they are most costly, in February and March, they sell for \$9 a pound, sometimes going as high as \$10 a pound. At prices ranging up to \$2 a pound there is a ready sale for them. At the higher prices they are sold almost exclusively for the use of invalids. There is a sale for all that are produced, but the production is great, and the vines may die from exhaustion after a single season of forcing.

The next most costly fruit is the hothouse peach. Hothouse peaches sell in February at \$2.50 each. They are used mainly by invalids, but such peaches are also often sold for gifts. They are presented as flowers or as bonbons would be. Three or four peaches are packed in cotton and set off with a few peach leaves in a handsome box. Hothouse peaches run down to about 60 cents each in April and May, when we begin to get the first of the peaches from the south. -New York Sun.

RESOURCEFUL SMITH.

Here Is the Scheme by Which He Grew Rich Shoeing Horses.

"I lived at a little crossroads hamlet which was not even a postoffice, on the line between New York state and Pennsylvania," said a story teller to a Sioux City Journal reporter. "Of course, there was a blacksmith shop there. In those days the blacksmith's trade was a notoriously good one. All the blacksmiths got rich with their horse, mule and ox shoeing, and the wagon and the other repair work which they did. Most of the blacksmiths combined with their. other work wagon repairing and even wagon making. There were very few big wagon factories in those days, and a good hand made wagon cost big money. When they were doing nothing else, they would make wagons, and when there was lots of transient work the wagons had to wait. This state line shop was a busy place. There was no tavern there, but the blacksmith also had a cider press, and he made the cider for all the farmers for miles around. But neither this nor the profits of his shop could account for the rapid way in which he accumulated wealth. As is well known, apple cider, if allowed to stand long enough, will become "hard," and after that it will turn into vinegar. "This cider dealer always had plenty

of hard cider on hand, but never had any vinegar for sale. The farmers and others who stopped at his place could always get a drink of hard cider, which they took out of a tin dipper at 10 cents a drink, and the size of the drink was something which attracted very little attention. Hardly any kind of beverage is more intoxicating than hard cider. It is a good deal like champagne in one respect. You can drink a great deal of it one day, and the next day you will be awfully sick and sorry, and a good deal drunker than when you went to bed. The blacksmith required no license to sell hard cider, and he worked the game to the limit. His place became very popular, and the farmers came from many miles around in both states to get their horses shod at his place. Many of them would come home drunk. and their wives began to protest. They always had to have some excuse for having visited the state line shop, and so the blacksmith, after supplying them with a few dipperfuls of hard cider, would take the shoes off their beasts and put on new ones, whether they needed it or not. For this service he would charge a good round price, while in many instances it was noticed he made no charge for the cider.

"But, as is the way of all flesh, this blacksmith died one day, and then his business secrets came out. He left an estate of over \$80,000, and in the cellar of the cider press a great number of that cured me (and hundreds of others). It empty whisky barrels were found. For years he had been putting whisky into his cider and had been setting new shoes on nearly every horse which came along, willy nilly."-Washington Star.

WITH THREADS OF METAL

Tinsel Fabrics and the More Costly Brocades of Gold and Silver.

Tinsel fabrics are the lower priced of the cloths into which gold or silver threads have been woven. In tinsel fabrics the gold threads are of brass or copper, gilded, and the silver threads are of white metal. These threads of metal, originally fine wire, are rolled flat and burnished, and they glisten in the fabric wherever the pattern brings them to the surface. Tinsel fabrics are made about three-fourths of a yard in width, and they sell at 75 cents to \$2.50 a yard. They come in various colors, and many of them are beautiful and artistic in design. Some are copies of old Venetian tapestries. Tinsel fabrics are used for church and for theatrical purposes and sometimes for gowns and for decorative purposes.

The costlier fabrics, with interwoven metal threads, are called gold and silver brocades. In these the gold threads House, Sign, Ornamenal and Fresco Painter, are of silver, gold plated, and the silver threads are of pure silver; the body of the fabric is of silk. The brocades are all beautiful, and many of them are exceedingly so. These fabrics are made about five-eighths of a yard in width, and they sell at various prices up to \$25 and sometimes as high as \$50 a yard. The costliest of these fabrics are very rarely imported into this country, brocades at \$10 and \$13 a yard being about No. 1 Fever, Congestion the highest priced used here.
