DEPARTMENT GROWS

In 38 Years the Increase Has Been Very Great.

The Graduating Class in 1860 Was 24 in Number.-In 1896 It Was 344.—The Attendance This Year Has Been 765.

The first building to catch the eye of the visitor to the University of Michigan who approaches the campus from the railroad station, is that of the law department. Always conspicuous by its situation, the large square tower on the northwest, and glass extension to the present cramped reading room facilities on the west, popularly called the "Green House" by its jovial habtitues, have heretofore given it the distinction of marked difference from the other simpler and less forward buildings of the University. The accompanying cut shows the building as it will appear next October after remodeling and addition. Shorn of its tower and its "green house," it will still be an imposing, and indeed a more beautiful structure than at present, with the beauty that comes from size, proportion, and adaptation to its

purpose.

The front is not a monotonously unbroken one. The parts containing the two pillared entrances project some cotta about the numerous windows three shades lighter than the main body of the brick. The hip roof is of slate, except over the library, the roof of whose large central reading room is glazed. The numerous windows in the front are suitably grouped and they are set with plate glass.

The rooms of the old building on the left are not radically changed in their arrangement, but their finishings are freshened. In the new addition oak is used in the woodwork, the ceilings are of Georgia pine, and the halls and rooms are deadened to facilitate quiet study and work.

There are two entrances on the east of the building opposite those in the When complete the whole structure will be 208 feet long and 100 feet wide. It will encroach to such an extent upon the sidewalk now passing diagonally over to the main building, that an entirely new connection will have to be made. University hall will be brought much nearer to its legal neighbor through these changes, and as the time goes on, no doubt it is hoped that the most used entrance to the law department will be that leading from the college of literature, science

The following brief history of the department was compiled for the U. of M. Daily and is taken from its col-

sity of Michigan was organized in 1859, eighteen years after the opening of the Department of Literature, Science and the Arts. The infant department was noused very modestly, the lectures and other department exercises being held in the room then used as a chapel. The library found accommodations in the then general library.

Thomas McIntyre Cooley, James Val-entine Campbell and Charles Irish Walker were chosen as the faculty and the new department was opened with an attendance of ninety students. The ourse extended over two years of six

Since this modest beginning the Law Department has steadily developed and prospered. In 1884 the law term was extended to nine months in a year, and in 1886 the classes were separated for purposes of instruction. In 1895 the course was lengthened to three years

of nine months each.





Brings Up the Texas Precedent and Quotes Henry Clay and the Action of France in 1777, Both Favoring Recognition of Cuban Independence-Stirring Appeal on Behalf of the Stricken Cubans by the Illinois Senator.

Washington, April 12.-Senator Mason delivered a speech in the senate in answer to the president's message. The speech, which declares for war, is likely to have its effect upon congress. It is aimed to answer the president's reference to President Jackson's message against recognition of the independence of Texas. The senator shows that following Jackson's message congress recognized the independence and credited a charge d'affaires to the Texas capital. The senator says, while the president invoked executive precedents, he ought not to deny congress the right to apply legislative precedents in the same case. The Mason speech quotes from Henry Clay in favor of recognition and from the action of France in 1777 toward the American revolutionists.

When Texas Was Recognized.

The senator says that when the re public of Texas was recognized there were only 30,000 Anglo-Americans withher borders. There are more men under arms in the insurgent army today than there were men, women and children in Texas when her independence was acknowledged by an act of congress. The total army of Texas consisted of fewer than 800 men. Senator Mason took the floor shortly after 1 o'clock to speak on the president's message. He was interrupted at the outset by a remark of Allen: will not commence today.'

"I don't know about that," sharply rejoined Mason. "Wait until you hear my speech."

The senator was not again interrupted. The speech was less impassioned than he usually delivers, but its effect on the senators, especially that portion in which he answered the president's reference to the Texas case, marked and listened to with the closest attention.

Jackson's Recommendation.

Commenting upon the president's message, in which he refered to President Jackson's recommendation against recognition of the independence of Texas, Senator Mason said:

"I propose now to show, since the executive has informed us what the executive branch of the government thought at that time, what the executive branch thought and did on the same question.

"If the executive feels bound by exective precedent I must be permitted to feel bound by legislative precedent. President Jackson issued the message spoken of and I call particular attention to dates-on the 21st day of December, 1836, immediately thereafter the resolution was introduced into the senate of the United States recognizing Texan indenpendence by Robert J. Walker, a United States senator from Mississippi.

Action of Congress. "On the 1st of March, before President Jackson's time had expired, that resolution was debated and passed by the senate of the United States by a vote of 23 to 22 and a motion to reconsider on the following day was lost

'The house of representatives immediately made an appropriation for a diplomatic agent from the United States to the government of Texas, thereby pursuing the very course suggested by Henry Clay in his attempts to recognize in congress the independence of Spanish-American states.

"The last official act of President Jackson, previous to his retirement from the executive chair, was the nomination of Alcee Lablanche as charge l'affaires to the new republic of Texas. "It is a historical fact that within a few days thereafter the newly accredited ministers from the republic of Texas were given an audience at the White House and they were duly recognized as such ministers by the republic of the United States.

Exceedingly Unfortunate.

"I would not wish to suggest that the learned lawyer who furnished the authorities for this branch of the president's message was in the least disingenuous, but it is exceedingly unfortunate that the mere opinion of the executive should be cited as a precedent, when as a matter of fact, the government of the United States, composed quantumountumountum of the executive and legislative branches, did set a precedent in absolute conflict with the opinion of President Jackson, cited in the message.

"In other words, the message cited by the present executive from President Jackson was delivered on the 21st day of December, 1836, and in less than 'The Geisha' at the Athens Friday ten weeks after sending his opinion to congress he recognized the independence of the republic of Texas by accrediting ministers to and receiving ministers from that republic.

Vulture and Eagle.

"The brilliant orator from Iowa, Mr. Cousins, said the other day in the house that, hovering about the dark waters of that mysterious harbor of Havana, the black-winged vulture watches for the dead, while over it and after all there is the eagle's piercing eye, eternally watching for the truth.

"Mr. President, is it to continue to be an eagle, or is the avarice and greed of the nation to cause it to descend and partake of the vulture's food? Perez, writing to Aranguren, said: 'The Yankees are hogs, and if you conquer your own independence they will absorb you.' Mr. President, did he tell the truth? Mr. President, are we going out on an errand after mercy loaded down with daybooks and journals? Are we to forget our citizens who went down in the harbor of Havana in our greed for gold and territory?

Close the Door.

"Are to leave the door open to comrel additional terms from the insurgents who sacrificed their wives, their children, and their homes? Do we wish special treaties of commerce and leave the door open for that? Do we wish to leave some American investor who has bought Spanish bonds and who wishes

to trade them for the bonds of the reputric? Do we, worse still, wish to leave the door open to compel those brave men and women to accept some terms of autonomy, or to pay blood money to the Spaniard or to the Shylocks of our own land? You say no Then I say close the door. It can be done by the acknowledgement of the

independence of Cuba today. The speech has already been pronounced the effort of Mason's life and there is no doubt he made a deep and lasting impression upon the hearers.

Appeal for Independence. 'Mr. President, I have been told and led to believe that as a rule at the close of life and approach of that change which we call death, when nature ceases to struggle against nature and there is no more pain, there is given to each parting soul a moment that is absolutely serene. According to the statement of our own colleagues and wellinformed physicians, nearly twenty five out of every 100 of the reconcentra dos are marked for death. I appeal for them to the executive, and to the legislative branch of government as well. Driven and scourged like dogs, they all hope still for the day of emancipation. May I be forgiven if I express the hope that the heart of the executive may be touched in their own behalf? May we not hope that their last lingering look of life be not with suspicion and hatred upon your flag and mine; that it may not rest upon the hated color of the yellow flag of Spain, but that in their rapt and parting moments they may be soothed and sustained by the sight of their own flag, the flag with a single star, the flag of the republic of

OVATION TO GENERAL LEE.

Cuba?

He Receives a Royal Welcome to the National Capital.

Washington, April 12.—General Fitzhugh Lee arrived in Washington at 2:30 o'clock, and entering a closed carriage, was driven at once up the avenue, a hundred or more bicyclists ac-



companying the carriage. The carriage belonged to the state department, and General Lee was driven at once to the department, presumably to report his arrival, and receive any instructions it might have.

Word had gone through the department that he was due to arrive, and the corridors in front of the secretary's door was jammed with people, and as General Lee stepped from the elevator in front of the secretary's door, the crowd gave three rousing cheers which rang through the building. General Lee bowed his recognition to the crowd and was immediately ushered into the secroom. throughout the building was tremendous, and the cheers drew an enormous throng to the corridors. General Le remained in the building only a few minutes, quickly departing, accompanied by Secretary Sherman and Assistant Secretary Day, for the White House The state department at once telephoned the senate to arrange for General Lee's appearance before the foreign relations committee.

The ovation was repeated as Lee went over from the state department to the White House. A mounted bicycle boy had preceded the carriage carrying a large Cuban flag, and this served to stimulate the enthusiasm displayed along the drive to the White House portico. At the railroad station, when General Lee arrived, the crowd was immense and exceedingly enthusiastic. The information comes from confidential and reliable authority that not

only will General Lee present evidence to the senate foreign relations committee showing conclusively that the Maine was destroyed by Spanish officials, but evidence will be presented showing that when the Montgomery went to Havana to relieve the Fern, which was used to convey food to the reconcentrados, she was placed over a mine which was discovered by a diver from the Montgomery, who was sent down to examine the bottom. The diver cut the wires attached to the mine.

Precious Gems in the United States. The value of the precious stones produced in the United States during 1897. as shown by a preliminary report of the United States geological survey, was \$130,675, as compared with \$97,-850 in 1896. The principal items of this total are: Turquoise, \$55,000; sapphire, \$25,000; quartz crystal, \$12,000. tourmaline, \$9,025; and gold quartz, \$5,000. The principal features of interest to the trade during the year were the investment of English capital in, and the increased output of, the Fergus county, Montana, sapphire deposits: the further development of turquoise deposits in Santa Fe and Grant counties, New Mexico; the development of the tourmaline deposits at Mount Mica, Paris, Me., and Hadden Neck, Conn., and the finding and sale of almandine garnets from Cowee Valley, N. C. The finding of gigantic quartz crystal (rock crystal) at Mokelumne hill, Calaveras county, California, was also of considerable importance. The great increase in the importation of diamonds, caused by the decrease of duty on those stones, was important, though not unlooked for. The continued popularity of the Australian opal in the United States was evidenced by the increased sales of this gem .-New York Sun.





Then the Helena and th Amphitrite at the government dock re ceived the news, and the officers of th ships out in the stream sent boats t inquire to the cause of the excitement and soon the whole fleet was cheering Commander Forsyth sent a boat wit the newspaper bulletin to Captai Sampson aboard the flagship New York and the boat was cheerd by every crew. Said a gunner on the Marblehead: "If we don't fight Spain I'll never wear an American uniform in a foreign port." This is the cystallized sentiment of the blue-jackets.

The San Francisco and New Orleans, Halifax, N. S., April 12.-The United States warships San Francisco and New Orleans sailed at 9 o'clock in the morning for New York. They took on board 250 tons of coal at this port.

MASSACRE OF CUBANS.

Fifty Reconcentrados Slaughtered by the Spaniards. St. Louis, April 12.-A special dispatch from Key West says: News has

reached Havana of the massacre of fifty reconcentrados at Escambra. Permission was given the reconcentrados in Santa Clara to return to their devastated homes. They issued from the city and camped at Escambra, erecting palm huts. Trusting the Spaniards, they began anew the struggle for existence. To escape starvation the fugitives killed several head of cattle out of a drove of hundreds which the Spanwoman becomes a mother she should prepare herself for iards have never been able to take to the towns, so closely are they guarded by the insurgents.

This was made the pretext for a massacre, and Thursday night a troop of Spaniards dashed into the camp, rode down the fleeing men and women and slashed them to death. A few escaped into the woods, but fifty were killed and many more wounded. The reconcentrados are now without hope. They believe that the Spaniards' promises were but a plot to inveigle them into the fields so that they might be slaughtered.

Fear a Massacre at Havana.

Havana, April 12.—There are still in Havana over 600 Americans, rushed panic-stricken to the British consulate because it was rumored that the volunteers were bent on massacre. The British pro-consul, Arthur Aroztegui, assured them that they would be protected. Erastus Wilson, an American dentist, has published in La Lucha a letter against General Lee in favor of Spain, Mr. Wilson says that he remains in Havana certain that nothing will happen to him. 
