

DEATH OF MARTIN CLARK.

He Dies Suddenly in a Buggy Yesterday Afternoon.

Martin Clark died suddenly at 1:30 o'clock yesterday afternoon, while riding in a buggy on Liberty st., of heart failure. He had been sick for a few weeks but had taken a ride Wednesday, which seemed to do him so much good that he went out again yesterday. He was 80 years old on July 19 last. was a graduate of Hamilton college, N. Y., and came to Ann Arbor in 1853. He was at first a teacher in a select school here. Then for several years he clerked in various stores and afterwards started in business for himself. running a grocery and bakery. His business at one time reached \$26,000 a He has held various offices under the federal, state and municipal government and was elected coroner in 1876 and served in that capacity until 1894. He was for some years a member of the board of health. For 45 years he did not pay out \$1 for medicines. Mr. Clark has written much for the newspapers of the city and was a welcome visitor at their offices. He and his estimable wife were inseperable companions and enjoyed a happy old age together. 

In most jails all these classes are huddled together indiscriminately; nothing else is possible. What could be more inevitably fatal to the morals of the community than to be housed day and night for weeks or months with those who have grown in vice and crime? In the county jail of Washtenaw county there is a measure of seclusion possible for first offenders. For instance, in the upper ward there is an iron cage provided for the incarceration of lunatics. Scarcely any circulation of air is possible, no window is accessible to those confined in it. A Chelsea Man Who Shaved Himself Blue Vitriol on His 96th Birthday. Daniel Tichenor, of Chelsea, celebrat-

As a boy he worked at mill-wrighting and shoemaking and on coming of age went to Georgia to work in the pine region. 



A GOOD APPOINTMENT.

Dr. Klingmann Gets a Good Appointment from the Asylum Board.

Last January the board of control of the Michigan state asylums created the office of special pathologist, to whom all material will besent for examination. The board consists of the superintendents of the four asylums, at Pontiac, Kalamazoo, Traverse City and Newberry. They appointed to the office of special pathologist Dr. Theophile Klingmann, assistant to Dr. Herdman. Dr. Klingmann is the son of the late Rev. Stephan Klingmann, of Weinsberg, and brother of Rev. Julius Klingmann. He is peculiarly fitted for his position, having had a large general practice in Bay City, from where he went to Berlin and Leipsic, Germany, where for two years he studied nervous diseases in the large hospital in those cities. He does all the post mortem work for the three asylums in the lower peninsula. The Newberry asylum is so far distant that a doctor attends to the immediate work there, being, however, under the instructions of Dr. Klingmann. The next meeting of the board of control will he held in November. 



It would be a public misfortune if an educational institution which is the pride of our state should be dragged into politics. It was to avoid this that the framers of our constitution wisely provided that the election of regents should be held in the spring when political issues are so largely subordinated to the question of personal fitness. For half a century the power of the governor to appoint regents for the whole of the unexpired term stood unquestioned. Gov. Pingree is trying to oust two of the board of regents, who are honored members of his own political party, and to put one of his clerks into the place which the ablest citizens of Michigan have been proud to occupy. I was solicited by Gov. Pingree's friends to use my influence with our committee in favor of following their example. I emphatically refused and both the executive and the campaign committees unanimously decided not to countenance the governor's attempt to make our great university a mere political machine."

Proposed to the Spaniards by the United States Peace Commissioners at Paris.

INVOLVES ALL OF THE PHILIPPINES

Discussed - President Decided in His Value of Spain's Pacific Expenditure.

Washington, Nov. 1. - The advices from Paris to the effect that the United States commissioners have demanded the cession to the United States of the entire Philippine group are in line with the instructions that have been issued to the representatives of the United States. Up to a very recent date the United states commissioners had no precise instructions on this vital point. There was a lack of data as to the financial and political affairs of the Philippines. and so it happened that when the commissioners sailed they were not committed beyond change to any line of policy. A majority of the numbers leaned towards a restriction of the demands to be put forth as to the Philippines, varying all the way from the re tention of Manila bay and the immediate surrounding country to the acquisition of the whole island of Luzon. Listened to the Popular Demand.

That represented about the extreme demand that was in mind when the commission left. But since that time the president has become convinced that there is a great popular demand for the annexation to the United States of the whole Philippine group, and he is disposed to defer to that sentiment. Besides, there is ground to believe that in an unofficial manner, possibly through informal communication with Aguinaldo's agent in Paris, or perhaps through some direct dealing between that chieftain and Admiral Dewey, the United States commissioners have satisfied themselves that the difficulties in the way of annexation, so far as they might be expected to depend upon the will of the natives, have been very much exaggerated.

Proposition Read at Paris.

The question of money consideration is the one upon which the difficulty is expected. Dispatches from Paris yes a joint meeting of two hours' duration sented its proposition regarding the Philippines. The United States proposition was to the effect that the United possess for itself certain territory and parts of land bound by and lying within such parallels of latitude and longitude mark the limits of the Philippine archipelago. The United States do not purpose assuming the Philippine debt of \$40,000,000, but they are willing to be responsible to Spain for a sum of money equal to the actual expenditures by Spain in the Philippines for the advantage of the islands and for the good of their people, for permanent betterments and for improvements, both physical and mental.

Reimburssment of "Pacific Expenses." The presentment specifies that the United States will reimburse Spain to the extent of her "pacific expenditures" made in the archipelago. This phrase "pacific expenditures" is employed to differentiate the expenditures by Spain in combatting insurrections in the Philippines. The one is felt by the American commissioners to be a fair burden on the acquiring power, while by Spain in the inevitable hazard to a nation resorting to arms to enforce order in its own territory. What are "pacific expenditures" will cause controversy, as they were not defined. But it may be accepted that they include Henry Stumpenhusen, the democartic money expended for lighthouses, schools, breakwaters, and perhaps the naval station at Cavite.

Effect of the Scheme on the Dons.

The Spanish commissioners listened attentively, though not without some evidences of impatience and surprise at the financial suggestions in the American presentment, and finally asked until Friday to consult the Madrid government and make reply. Adjournment was then taken to that day. After the conference was dissolved, the Spanish commissioners expressed the opinion that the American demand would create in Spain, as it had upon her commissioners, an exceedingly grave impres-Were the Spanish commissioners sion. pushed to a final determination now they would reject the American demands, but the changing tone of the Spanish press recently urges the consummation of a treaty of peace, however rigorous, the argument being that although the Spaniards bow to the American demands the commissioners do not acknowledge the justice or admit the legality of them.

Chattanooga, Tenn., Oct. 31 .- Maj. W. T. Comegys was a witness before the war investigators Saturday. He was medical purveyor of Camp Thomas. Washington, Nov. 1.—The following from Hanna, American consul at Puerto Rico, has been received by the assistant secretary of state: "I am convinced that young men seeking work or positions of any kind should not come to Puerto Rico. Such persons as carpenters, mechanics, and laborers, of al grades, should stay away from Puerto Rico. No person should come here without plenty of money to pay board bills and have enough to take him back to his home in the United States. This is the most densely populated country in the world. There are several hundred thousand working Puerto Ricans ready to fill the vacant jobs and at a low price.'

KAISER AT JERUSALEM.

Enters the City Heralded by Big Guns and Through Triumphal Arches. Jerusalem, Oct. 31.-The approach of

their German imperial majesties to the city Saturday was made through triumphal arches, and amid banners, garlands and ever-growing crowds displaying in every way their enthusiasm and delight. The formal entry through the Jaffa gate was heralded by the roar of guns at the citadel, where the Turkish band played the German anthem. From the tower of David Emperor William and Empress Augusta Victoria proceeded on foot, amid wild cheering, to the Church of the Holy Sepulchre, where they were received by the Roman Catholic, Greek and Armenian clergy, whose patriarchs presented addresses eulogizing the devotion of Emperor William, who has since conferred decorations on the patriarchs.

Their majesties then proceeded to the German Evangelical church, where the pastor presented an address. At 6 o'clock Saturday evening a reception was held at the German consulate, and later there was a general illumination of the city, with a display of fireworks Yesterday the imperial pair attended service at the Evangelical church in Bethlehem, afterward paying a visit to the Church of the Nativity. The weather yesterday was beautiful and everywhere the greatest enthusiasm has been displayed.

European War Dogs Are Restless to the Point of Crying Havoc.

BRITAIN AT WORK VERY GRIMLY

Lining Up Her Warships and Generally Picking Her Flints-Activity in This Line That Shows the Situation To Be Very Critical-Preparation in an Advanced Stage to Call Out the Whole Or-

ganized Force of the Nation. London, Nov. 1.-There was an unexpectedly gloomy feeling yesterday morning on the stock exchange and the Paris bourse, both these markets being influenced, it is inferred, from the aggressive tone of the French papers. Besides this, something extraordinary seems to have happened, and it looks as if a crisis were approaching. The British emergency squadron is gathering at Devenport with all possible speed. Seven battleships and one cruiser have been thus far designated to join this squadron. Officers and sailors have been hurriedly recalled from leave of absence, several battleships and cruisers at Portsmouth are taking their full crews on board, and other warlike preparations are being made.

Alleged Russian Spy Arrested. A number of signal men, now on duty with the British channel squadron, which arrived at Gibraltar yesterday, have been ordered home for service, it is presumed, on board the auxiliary cruisers if the latter should be required for active service. A sensation has been caused by the arrest yesterday morning of a supposed Russian spy at a fort near Harwich. The man was already under surveillance, and went to a redoubt where he tried to obtain some information from a sentry regarding the fortifications. He was promptly arrested and inquiries are being made

regarding his antecedents. Volunteers Ordered To Be Ready. It was also asserted that the commanding officers of the London volunteer regiments had received orders to prepare for immediate mobilization, and it is reported that the different artillery corps have been informed as to the forts on the southern and eastern coasts to which they have been allotted. The Pall Mall Gazette yesterday afternoon said: "England has been and even now is so near war that the government has carried its preparations to the farthest limit of the preparatory stage. It has been arranged to call out the reserves and militia and to mobilize the volunteers simultaneously, and to form large camps at various important railroad junctions, where rolling stock and locomotives will be concentrated."

WANTS WAR NEWS SUPPRESSED.

Papers Asked To Be Silent Regarding Preparations - Cause of Activity.

London, Nov. 1.-It is probable that the cause of the activity in British military and naval quarters is the news from Paris that France will try to reopen the whole Egyptian question in connection with the Fashoda affair. This would put in the hands of Europe the question of British occupation of Egypt, a situation that could not but be looked upon with suspicion by Great Britain. The Daily Mail this morning publishes no news regarding England's war preparations, explaining that silence is due to a letter from the war office asking it not to publish "anything which might be useful to a possible ene-

my."

Most of the papers are full of alleged war preparations despite the undoubted fact that the authorities are doing their best to discourage publication, and are even denying statements that have already appeared. Yesterday a sudden order was received at Dover for an experimental mobilization of the defense forces. All the heights and forts were smartly occupied in a manner giving satisfaction. The arsenal at Woolwich is working until 11 o'clock every night, the government having given large orfor guns, searchlights and other

naval equipment.

The British channel squadron has cast anchor off Gibraltar. The advices from Paris in the special dispatches this morning add little to what was already known regarding the situation at Fashoda. It is believed that Captain Baratier is taking only verbal instructions for Major Marchand. The idea prevails at the French capital that Count Muravieff, the Russian foreign minister while there on his recent visit promised Russian support in reopening the whole Egyptian question, and that Major Marchand will be instructed to fall back and maintain his occupation of all Bahr-El-Gazel.

The Cairo correspondent of The Daily Mail says an Egyptian battalion has been dispatched to Fashoda.

Dreyfus Case at Last Where It Can Have Fair Hearing.

CIVIL TRIBUNAL HAS FULL POWER.

Can Demand All the Testimony That Was Used to Send the Captain to Devil's Island-"Dossier" Not Privileged -France and Fashoda.

Paris, Oct. 28.—President Faure last evening asked M. Dupuy to form a cabinet in succession to the Brisson ministry which resigned Tuesday. Dupuy asked until today to decide, but will doubtless accept the task unless unforeseen difficulties arise.

Paris, Oct. 26.—The Brisson cabinet resigned last night as the result of the adverse result of a vote of confidence. There was great excitement in the city yesterday on the occasion of the assembling of the French congress. In short, if the court makes a sincere use of its powers the truth will have a much better chance of being discovered than would have been the case had it merely ordered revision before another court-martial, whose members might have been actuated by a desire to shield the general staff. Having concluded its inquiry it can present a new dossier to either a civil or a military court for the final decision. Its proceedings will not be public and there can, therefore, be no objection to the communication to it of the alleged secret dossier, if this is still in existence, while the numerous generals who have exprssed their belief in the guilt of Dreyfus will now be called upon to explain the grounds of their

Substance of the Decision. The decision of the court first declares that "in view of the arguments of the public prosecutor denouncing to the court the condemnation pronounced by the first court-martial of the military government of Paris on Dec. 22, 1894, against Alfred Dreyfus, then a captain of artillery attached to the general staff; in view of all the documents in the case," etc., and as the matter has been brought before the court according to certain laws, etc., "the court declares the application to be in proper form and legally admissible, and states that it will institute a supplementary inquiry, and declares there is no ground at the present moment for deciding on the public prosecutor's application for a suspension of the penalty." 
New Railway for the Hawkeyes.
