The Next Senate. The present senate of the United States consists of seventy-six members, of whom forty-two are democrats, thirty-two are of these independents (Davis, of Illinois,) may be classed as a democrat, and the other (Booth, of California,) may be classed as a republican, leaving the senate divided politically: democrats, forty-three; republicans, thirty-three.

Here is just one paragraph out of Congressman Horr's famous speech at East governor was mis-spelled. And 400,000 of Saginaw the other night, we cannot re-

a grand document:

There is no better evidence of a country's intelligence than the letters its people write. I don't care what kind of letters they write, so they write letters, the number of letters the people write is a perfect index to their intelligence. The people of the southern states for the last ten years haven't written letters enough to pay their own postage into \$25,000,000, whereas Michigan with her undoveloped country to-day writes letters enough to pay her own postage bill. Have you ever examined this educational business? I had occasion to look it up. The great state of New York every year pays more money to educate her common people than the entire lê southern states. The little state of Vermont pays more than the states of Mississippi, Alabama and Arkansas. Why, the state of Michigan, only admitted to the Union in 1837, not a quarter of her acreage under cultivation, and yet we have got \$3,000,000 more in school-houses than the entire eleven states that went out of the Union. [Great applause.] And now do you think you can carry Michigan for Hancock where those school-houses are? [Laughter.] There is a map in the patent office in Washington. I wish I had it here. It is a map of the United States. They have taken the statistics of the country—the educational bureau did it—and wherever there is 60 per cent. who cannot read and write, the map is painted brown, and where there are 30 per cent. who cannot read and write, the map is painted black; and where there are 60 per cent. it is painted brown, and where there are 30 per cent. a lighter color, and so on until they get down to five per cent, where it is almost white. On that map you can see that blackness represents ignorance. If I had that map here before you and should take a pencil and draw a line around the black portion of it. 




