A noble work is that of training and dereloping minds, and the pay thereof should not be meagre. For noble work demands noble mind, and noble mind is at a premium in every mart of trade, studio of art or workshop of artisan.

A feeling wide-spread among college professors exists that their salaries are too often inadequate to the requirements of their position. Men of business and manual labor are apt to pooh-pooh this idea under the erroneous supposition or at least the argument, that college professors have easy work, small families and light ex-

This plea is made so often that it is well nough to consider it. In the first place the wages of the artisan in all markets are overned mainly by the length of time required at an apprenticeship in learning the trade, and the latitude for the display of genius which the trade affords after it is once mastered. In an ordinary manual | better. art oftentimes a boy begins at sixteen and is a workman at twenty. He gets common wages. Where the time of his apprentice-J. Q. A. utation, takes a man to the middle of his life. To that time he has been unable to earn more that enough for his own existence; he has rather belonged to the class of consumers and not to the producers. So,

now, that he has gained his professorshipthing by no means certain, even after so long a probation-we expect him to earn enough money to repay him for his large outlay of time and money. To do that he should get a higher salary than the head salesman, and book-keeper in a large mercantile house, or a governmental clerk,

#### EUROPEAN CORRESPONDENCE.

From our Regular Correspondent. PARIS, April 9, 1883.

The old established Ham Fair, which, from time immemorial has delighted the good bourgeois of Paris during Passion week, was held as usual on the Boulevard Richard Lenoir, between the Bastile and the Boulevard Voltaire. It would require a born and bred charcutier to describe by their right names all the delicacies. having cured pork for a basis, which adorned the half mile or so of little wooden sheds that made up the famous Foire aux Jambons. Seeing that the fair has its origin in the dues paid to the Bishop and chapitre of Notre Dame de Paris, on imported swine flesh. and that during the week a rigid fast is imposed on all good Catholics, it is difficult to imagine why this particular date should have been chosen for the sale of the least maigre of all meats. The secret of this apparent anomaly is lost in the back pages of history. The present generation, especially the inhabitants of the eleventh arrondisment of Paris, accept their Ham Fair with a good grace; and under the shadow of the great skeptic whose name adorns the handsome boulevard adjacent, rush to buy the succulent porcine meat offered to them at what the venders call the lowest prices ever seen or heard of. "Buy, buy, buy," is the motto of the Ham Fair, whether the hams be from Wesphalia, the pork sausages from Bologna, or dried filled with good reading matter. We sucking pigs, which, for all one knows know of no paper having better thought may have been extracted from the pyramid of Cheops. Nor is pork the sole meat dispensed in every shape at the fair. Sausages of horseflesb, and donkey meat enclosed in shiny red skins, and smoked sections of mule were displayed on handsome stalls, adorned with medals and certificates of first prizes won at many an agricultural show. Charcuterie hippophagique may have its devotee; certain it is that the establishments which are compelled by law to announce the nature of their viands, but are not obliged to state exactly how gallant steeds and sure-footed donkeys came to be transformed into sausage meat, are constantly surrounded by gaping throngs always ready to taste, if not to purchase. At the northwestern extremity of Ham Fair is the annual mart for the disposal of every kind of worn-out old-fashioned, disused articles. which can only be classified under the general appelation of rubbish. What other name, indeed, would apply to an exhibition where rusty nails, horse-shoes, and battered-in kettles predominate, and where secondhand wooden legs, tarnished door-knobs, and Prussian helmets with the spikes

wares do not, as a rule, "run to" stalls.

The most curious featurs of the rubbish fair is the tenacity with which the venders refuse to abate their usually exorbitant prices, but the initiated affirm that prices come down wonderfully on the last day when articles can be obtained at the purchaser's own price.





History of Russian Coronation. London Echo.

The first Russian Czar who introduced the ceremony of coronation into Russia was the mighty John III or Ivan (1462stantinople, and by this marriage claimed "Why, Aunt Margaret, have you been kings of Western Europe seem first to have become aware of the rise of the powerful new Christian monarchy in Eastern Europe, and began to send am-bassadors to Moscow. Ivan did not crown himself, but in 1498 solemnly invested his grandson, Demetrius, with the Imperial Christian diadem and robe which had been brought from Constan tinople, and had been worn by the Cæsars of the Eastern Empire. ceremony of unction at the coronation was afterward introduced by Ivan IV, or "The Terrible," and has since remained as it had all along been in Western Europe, an inseparable adjunct of the coronation. Ivan IV was the first Czar who received the Eucharist at his coronation. Michael Theodrovitsch insisted upon being anointed, not only on his forehead and over his lips, but on his beard also, after the biblical prece-dent. In earlier times the clergy of the Russian Church played a greater part than they do a present in the coronation ceremony. As it was held almost indispensable alike in England, France and Germany that the Nationa Primates, the Archbishops of Canter

bury, Rheims and Mainz, should "consecrate" the national monarch to his office, so it was in Russia with the Patriarch of Moscow. The Prelate was apposed to be the peculiar steward and minister of the sacramental rite of coronation. He gave the divine confirmation and unction to the presumed free choice of the people. The voice of reigning family was a comparatively late conception in Russia, as well as in ent things. There appeared to be a Kings. The present German Emperor placed it upon his own head. Similarly in Russia the representatives of the Church now play quite a subordinate part in the coronation of the Czars being little more than ministering servants and and assisting spectators. 
