



THE BICYCLE AND TRICYCLF.

A Sketch of the Modern Pegasus. The bicycle is no longer a novelty. Its silent run over our streets creates no surprise. The same public which digested the telephone and the electric light, looked and wondered when the first "wheel" was seen whirling along, shook hands with its rider, said "good morning" the next day, and then settled back, rode the new horse, wondered why they hadn't had it before, and forgot the date of its birth in believing that it had existed a century. Great as is the aptitude of the American people for adopting any new and useful invention, the rapidity by which the bicycle has become a permanent institution with the riding public, makes an occurrence seldom noted in this rushing age. It is now some dozen years since the present bicycle was placed upon the English market, and but about 18 years since the first crank-movement velocipede rattled over the highways. Although the bicycle was first exhibited in America at the Centennial, it was some two years before Yankee enterprise branched out in the manufacture of these machines. In 1878, Col. Albert A. TAX EQUALIZATION.

Editor of COURIER: In your paper of May 18th, you say that the article of Mr. Wynkup on the equalization of the county has attracted considerable attention and has been commended by a number of supervisors. Imperfectly as the article was written it has attracted some attention, but I do not wish to have the impression conveyed that any considerable number of the present board of supervisors have endorsed it. The new members as a rule, will not be likely to commit themselves to any course of action which might endanger their chances of being placed in a situation where they might benefit their districts. The old members of the board, most of whom have been right in their glory on this equalization business will be happy in letting well enough alone. Still some of the present board are out spoken in their condemnation of the present system of equalization. But the endorsement of the article mentioned above comes mostly from old supervisors, or more properly speaking ex-supervisors. Some of them are ex-supervisors voluntarily and some of them are exsupervisors, not because they were not good and capable officers for they were, not because they did not di tribute the burdens of taxation over their townships with a fair and impartial hand. Oh no, there was no complaint on that ground. But they are ex-supervisors solely because they have been the unfortunate victims of the unrelenting cruelty and greediness of one or more committees on equalization. They have had a bitter experience in this business and it is no wonder they condemn it in strong language, and I have no doubt if the present system is continued there are members on the present board of supervisors who will heartialy endorse what I have written on this subject, next fall if they do not now. They will be in the same situation as the darkey minister

who announced to his congregation with tears in his eyes that he should preach to them no more, for said he "my church has jes been done gone and sent me in my resignation." But I see my article is too ong already and I will hasten a close. When I commenced writing this article I thought I would send you some figures drawn from official sources showing the valuation of one or more committees districts before and after they had passed through their own smut mill of equalization. In some extreme cases it might be hard to tell which was grist and which the toll, and if the supervisors who represented them had their choice they would hardly have known which to choose; to have the state and county taxes levied on what they had taken off their districts or on what they had left on. In taking leave of this subject I venture the prediction that the present board of supervisors will not be unanimous in upholding the old system of equalization and the time is not




