This volume is the last of a series of six, and it tells of the struggles of Anti-Slavery times, not in a historical way, but as a vivid pen picture of thoughts and actions. In point of time this one goes back of the others, even to 1848, but like them it has in it lots of "stir." The romantic thread running through the darkened background is as a sauce skillfully introduced to season the digestion of the national problem discussed.
