#### DESTRUCTION ON THE COAST. Millions of Dollars Worth of Property

Destroyed. The gale which swept along the Atlantic oast on the 6th inst. was almost unprecedented in its fury, and the amount of property destroyed. At Long Branch a portion of the pier was destroyed and the pavillion wrecked. A bridge on the Philadelphia & Long Branch railroad was washed away and travel stopped. Coney Island suffered terribly, and it was feared that a tidal wave might submerge it. Water flooded the meadows; the marine railway between Manhattan and Brighton beaches was destroyed; Culver's iron pier was partially wrecked; the old iron pier suffered much; all the houses and sheds nearest the beach were

entirely or partially demolished, and bathing Columbus, Ga., has been entirely destroyed by arc. The fire had gotten such headway when discovered that it could not be controlled. Brighton Beach hotel was so badly damaged About 120 young ladies boarded in the build. that a second visitation of the wind would estroy it. At Atlantic City, N carried out to sea boarding houses, stores dwellings, bath houses and other buildings Howards pier is more than half washed away. Much damage was done to the South Atlantic City and West Jersey railways. On the same day New England was devastated by the worst gale known for years. Telegraph wires were blown down in all directions nst., the bark Elmira was ship wrecked on. In western Vermont it blew 70 miles the coast of Long Beach, N. J. Not a soul of an hour. At Castleton, Vt., a hotel the 14 on board survived to tell the terrible roof, 80x100 feet, was blown off, uncovering 30 sleeping boarders. As it fell it cut one building in two and seriously damaged two others but fortunately no one was hurt. A tract four miles wide, in the valley from the Green Mountains to Lake Champlain, was devastated. At Rutland, Vt., the roof of the Baptist church and the spire of the Congregational church were blown away, several barns demolished, and a number of houses damaged. At Northampton, Mass., at 6 a. m. the cyclone was accompanied by rain, and after the rainfall the treets were found covered with small fishes. At Keene, N. H., several acres of standing time ber were blown down. Changes of 55 degrees

> The gale along the coast especially the Cape Cod and Maine coasts, must have caused numerous disasters. The wind blew from 54 to 60 miles an hour. Vessels were beached at Bristol, Provincetown, Chatham, Cape Elizabeth, Whitehead, etc. Portland harbor is full of wreckage and when full reports are received of life and property lost, the story will surely e a terrible one. The schooner Etta Nutting reported gone down with all on board, and from all along the Maine coast unknown vessels are reported driven on the rocks. At Calais a warm rain opened the upper St. Croix river, and unless a cold snap intervenes a freshet is imminent. In northern and central New England the rain was a deluge, but the gale less evere. Three fishing schooners were wrecked n the harbor of Portsmouth, N. H., 20 coasters lost anchors and entered the port of refuge; rews all saved. It is impossible to estimat the damage, but it must aggregate millions.


