



Sinkat. BRIGANDS on the 15th captured the Judge and other officials of Monastier, on the Albanian frontier, in Greece.

UNDER the provisions of the Irish Tramvays act, a company has been formed in London to purchase estates, relieve over-crowded districts and encourage flactiosidence.

LATER NEWS.

THE Ohio River was slowly falling at Cincinnati on the 17th, although it was still nearly two feet higher than ever known before, but at other points the water was rising and doing immense damage. From Evansville to New Albany, Ind., a distance of two hundred miles, all the villages bordering on the river were inundated, and over ten thousand people were homeless. At Lawrenceburg about fifteen hundred buildings were destroyed, and Germantown was almost wiped from the face of the earth. In Ohio Portsmouth was entirely under water, and many buildings had been carried off at Maysville, Gallipolis, New Richmond, port and Augusta. At Shawneetown, sand people were homeless, while at New-port four thousand houses were inundated, thirty-three buildings were washed away and over one hundred were turned bottom upward. The estimated damage was \$1,000,000. Measures for the relief of the

### Imported Images.

In a rough, soft wooden box in a marble dealer's store was an image of Cupid cut from marble, chunks of wood supporting the weak and delicate parts.

"It is a specimen of ready-made parlor statuary," the dealer said. "It has just arrived from Italy, and when dusted, is ready for the parlor of a millionaire.

"Why do you call it ready-made?" "The statues are all made to order but not as the term is commonly understood. In Florence, for instance, are a number of studios over which artists of ability and repute preside. In a moment of inspiration that Cupid was conceived and modeled in clay. workmen, whose inspiration lasts them from twelve to fourteen hours a day, and for seven days a week, carve from the block as many copies of the model as the trade will bear. Thus the price of the inspiration may be distributed over twenty-five, fifty or one hundred Cupids. If a man should hire the sculptor to make a single image, he would pay \$500, perhaps \$1,000, for the inspiration, besides the price of the block and the labor of the workman. The sculptor himself might put a file on the statute, and he might not, just as the exigencies of society permitted, or his fancy dictated. "In Sicilian marble, which is an out-

door stone, we have many designs suitable for cemeteries and graves. These imported goods are not only superior to. but they are cheaper than, anything you can get in any other way. The prices of cemetery pieces range from \$100 to \$500, and the parlor pieces from \$150 to \$1,000. The difference between these statues and those costing from two to five times as much is simply that these have no great sculptor's name attached. 

#### A POSTAL TELEGRAPH.

In this country it is the recognized province of the government to transmit the correspondence of the people resident within its domain. Next to the surety of delivery comes celerity. The reliability of our postal system is already assured, and the limit of speed by rail is nearly attained, yet a busy, impatient race of business men demand still greater facilities of correspondence at lower rates than now exist, so their attention turns towards the telegraph and telephone for relief. But the latter is not as yet well enough developed to be relied upon for long distances, therefore the telegraph more properly comes to be considered as a general carrying agent.

At present we are so unfortunate as to find the telegraph of the whole country under the control of a single monopoly. charging us what it will for the gain of its stockholders. Many small companies have at times been started, but sooner or later the octopus has drawn them in and swallowed them alive and kicking.

In the light of these facts, while we do Francisco Chronicle. not join the pessimists, who wofully predict the ruin of the country from monop olies, we do think that the interests of the people will be best served if something is encouraged which can make a stand against the telegraphic corporation.

The yearly overplus of national revenues is now embarrassing financiers, but if turned into a right channel it would afford us not only a relief but in a few years, a complete duplication of the entire Western Union lines.

The main objection to it is, that by bringing it under government control the agents will have to be appointed as the postmasters and other officials are, and the civil service list thereby will be enormously increased to the no small danger of further corruption in politics. It must be acknowledged that there is some force to the objection, yet in the minds of many the advantages will outweigh the objections. A proper enforcement of beneficial civil service rules will put the tack. government in control of a great engine for its own business and in the service of the people a ready and obedient agent for the cheap transmission of their rapidly increasing business.







#### THE NEWS.

Compiled from Late Dispatches. CONGRESSIONAL.

BILLS were introduced in the Senate on the 12th: By Mr. McPherson, to suspend the coinage of the standard silver dollar until June, 1886, and to receive trade dollars in small mounts for postage and revenue stamps; by amounts for postage and revenue stamps; by Mr. Voorhees, to prohibit the assessment of Government officials and employes for political purposes.... In the House bills were reported to retire or recoin the trade dollar; to provide for building the Michigan & Mississippi Canal, and to aid temporarily and support the common schools. Mr. Potter introduced a bill to convert the three, four and four and one-haif per cent. bonds into two and one-half per cents, paying a premium equal to the amount saved to the country. THE McPherson bill to provide for the issue of circulating notes to National banks was advocated in the Senate on the 13th by Mr. Bayard as being in the line of absolute security. Mr. Sherman offered an amendsecurity. Mr. Sherman offered an amendment as to bonds bearing more than three per cent. interest. He said sentiment in Congress was hostile to the suspension of silver coinage or the adoption of a new ratio between the precious metals, and that a silver standard was casting its shadow upon the future....In the House a petition was presented for pensions to Union soldiers confined in Andersonville, Belle Isle or other Confederate prisons.

A BILL was passed in the Senate on the 14th to make all public roads and highways postroutes. Mr. Logan introduced a bill to provide that honorably discharged soldiers or vide that honorably discharged soldiers or sailors be preferred for appointment to civit offices, and Mr. Beek offered a bill for the organization of Supreme Courts in the Territories. The McPherson bill relative to National-bank circulation was debated.... In the House Mr. McKinley presented a telegram from Cleveland recommending that the flood relief appropriation be increased to \$1.000,000. A debate followed on the Mississippi contested-election case of Chalmers vs. Manning, but no action was taken... THE session of the Senate on the 15th

was mostly occupied in debating the bill to provide for the issue of circulating notes to National banks; an amendment pre-viously submitted by Mr. Sherman, providing viously submitted by Mr. Sherman, providing that if any bonds deposited bore interest higher than three per cent, additional notes should be issued equal to one-half of the interest in excess of three per cent. accruing before maturity, was rejected—7 to 42. A joint resolution making a further appropriation of \$200,000 for the relief of sufferers by the Ohio flood was passed. Adjourned to the 18th... In the House the joint resolution making an additional appropriation of \$200,000 for the relief of flood sufferers was passed. The Chalmers-Manning election case was taken up, and a resolution declaring that Manning was entitled to a seat from Mississippi was defeated—92 to 157; the majority resolutions, discharging the Committee on Election from the prima facie case and leaving the seat vacant until the case is decided on its merits, were then adopted—130 to 56. Adjourned to the 18th.

Mr. Wilson was a highly respected citizen, a native of New Hampshire, and the last of a family of ten brothers.

MRS. CARRIE VANDERGRIFT, the wife of a wealthy coal dealer at Burlington, N. J., was met in her yard on the 13th by an unknown man, who threw the contents of a vial of vitrol in her face, destroying her eyesight. The cause for the horrible deed THE body of Martin Riley, a farmer of

Adrian, Minn., was found murdered in a straw-stack on the 13th. His son, aged fifteen years, who had disappeared, was supposed to have committed the crime. AT Halleck, Nev., the thermometer reg istered forty-five degrees below zero on the 13th, the coldest ever known in that sec-

THOMAS SHEA, whose mind was unsettled, Wilkesbarre, Pa., that in a dream he had been summoned to Heaven. He then walked to the high bridge at Nanticoke, jumped off and was horribly mangled. THE mill-owners at Pittsburgh on the 13th withdrew their order for a ten per cent. reduction in the wages of machine molders, thus averting a strike.


