



JAMES GILLESPIE BLAINE.

He Stops a Few Minutes in Ann Arbor.

On Monday morning last, probably the largest crowd ever seen at the M. C. depot assembled there for the purpose of seeing and hearing one of the most polished and brilliant statesmen of America. the republican candidate for president, Hon. James G. Blaine.

DISPATCHES on the 14th from Columbus, O., stated that all the syndicate mines in the Hocking Valley, with the exception of Nos. 3 and 7, were on fire. It was impossible to get at the flames. Thus far there had been no disturbance in the valley, but the excitement there was reported to be intense. No one doubted that the striking colliers set fire to the mine.

THE boys employed in a number of the glass factories in Pittsburgh, Pa., struck on the 14th for an advance of from three to ten cents per day in their wages. The factories were closed.

A CYCLONE swept over Auburn, Me., on the 14th, destroying numerous barns, unroofing several houses, and blowing down trees and fences. No lives were lost. Coke trains collided a few days ago near Monongahela City, Pa., wrecking an engine and twelve cars, killing a fireman, and fatally scalding an engineer.


