



Once there was a spider. There is nothing very startling about this fact, unless you are of a nervous turn and the said unruly insect drops down into your face while you are trying to go to sleep, or you are easily cast down by running into his web thrown across a doorway. Spiders are chiefly domestic in their habits in this latitude, and have a weakness for rounding out the corners of rooms and filling the chinks in out of the way places with a substance which, if it had been a little stronger, would have won them an honorable place in the arts and made them as popular as

they are now obnoxious. One evening the individual subject of this history was discovered spreading his nest across an open window that had been raised to give the supper table a more pleasant surrounding and as he had not proceeded far when his plans were observed, a close watch was kept on his movements and the following notes taken on the process: The upper limit of the web was the half-raised sash, and enough of the space below was taken to make a structure about a foot square, which was mapped out by single lines fastened to the window frame. Inside of this a few strands were thrown, which crossed at the center, where an irregular bull's-eye like case of operations was formed by cross-webs put in very inartistically. The spider then added more spokes to his wheel until he had twenty, and then accomplished the feat of joining these altogether by circular webs about an inch apart. These kept the rays in place like a set of guy ropes, that made a deel of climbing and calcu-

The spider did not try to spring from one ray to the other or shoot out his web, but took a trip around by the shortest route and waxed the newly spun line to the ray before setting out again. He had worked at his best rate for a full half hour, and couldn't exhaust himself further just now by running after game that was

ported that they found the jail building in a dilapidated condition, and that it is growing worse every year, and that it is unsafe and unfit for the confinement of prisoners. Also that Sheriff Wallace had done his full duty in keeping the building clean and in good sanitary condition as possible, but they could not ask the judge of this circuit to designate some other jail for the confinement of prisoners of Washtenaw county, under the provisions of sec. 8945 of Howell's annotated statutes, believing the expense would be too great, but thought that a new jail

ought to be built at once. Report adopted. A committee consisting of Supervisors C. S. Gregory, Feldkamp and Dansingburg was appointed to investigate charges against the management of the county

On motion of Mr. O'Hearn the bonds of the next county treasurer were fixed at \$150,000.

offered the following, which was adopted: Resolved, that the supervisors appearing be-fore the probate court as witnesses in insane cases be allowed \$2 per day and mileage. On motion of Mr. O'Hearn each supervisor was requested to enter upon the tax roll the amount of indebtedness of his district to the county for the support of the town and city poor, as certified to by the

county superintendents of the poor. Wednesday, Oct. 22d. Supervisor Kress offered the sollowing which was adopted: Resolved, that the county clerk is hereby authorized and instructed to furnish supplies for the county offices, and such supplies for the county jail chargable to the county, and so far as practicable to the lowest bidder.

The committee on public buildings made their report, showing an expenditure of \$87.56, and stated that only such repairs as were imperative were made. Several epairs were recommended.

The county superintendents of the poor presented their annual report showing that \$10,535.57 had been received from all sources, and \$7,215,56 expended, leavng balance on hand of \$1,198.10. There s due from towns and cities for taking are of their poor \$2,688.35. Value of farm and buildings estimated at \$25,000. Products of the farm for past year, \$2,-253.50. Farm stock, \$1,421.50. Implements on hand, \$4,716. Number of paupers maintained, 188; males, 135; females, 53. Average number of inmates, 78; under 16 years old, 13; idiots, 9; blind, 3; mutes, 3. Divided into nationalities the 188 maintained were as follows: Irish 46, Germans 28, English 11, Scotch and Canadians each 5, negroes 7, Swiss 2, Swedes and Italians 1 each. Average cost per week, \$1.25. Estimates for coming year \$9,000.



Compiled from Late Dispatches. DOMESTIC.

THE schooner Lucy, sugar laden, was recently wrecked off Sabine Pass, Tex., and three of the crew perished.

The Governor of Idahoreported at Wash-

ington on the 28th that the funded debt of the Territory had been practically wiped out; that the population was 88,000, and that the people were entitled to the advantages of a State Government.

AT a crossing in Pittsburgh, Pa., the other day a train struck a two-horse wagon, one of the men on the vehicle being fatally hurt. One of the horses was thrown forty feet, striking a citizen who was standing on the station platform, killing him in-

A JURY in New York has given William Brady a verdict for \$50,000 against C. P. Huntington for negotiating the purchase of the Morgan Railroad and steamship lines

in Louisiana and Texas. DISASTROUS storms on the coast of Lower California recently caused the destruction of several steamers, and over four score lives were lost. Twenty horses at Cape St. Lucas were destroyed, a great number of cattle killed, and nine Mexican coasters

AT a meeting of business men of Louisville on the 28th it was resolved to hold another exposition next year, and plans are already being arranged.

Exports from New York for the seven

days ended on the 28th (exclusive of specie) were \$6,778,000, against \$6,403,000 the previous week.

THE recent coal-mine disaster near Youngstown, Pa., resulted in the death of ourteen men, whose bodies had been brought to the surface. Seven others were wounded, and some of them might not sur-

THREE horse-thieves were captured a few days ago by a posse of citizens near the town of Prinville, Eastern Oregon, and lynched. That whole section of country was overrun with stock-thieves, and the settlers were resolved to drive the hands

NORMAN JONES, aged twelve, was arrested at Fitchburg, Mass., on the 28th for placing obstructions on the track to wreck trains "for fun."


