The Apportionment Analyzed and Criticised.

ED. COURIER:-If anyone has any doubt of the unfairness of the action of the present board of supervisors in its apportionment of the state and county taxes, let him examine carefully the table of equalization adopted by the board. Bear in mind that it is upon the equalized

are apportioned. Now look at the table. In the township of Sylvan (I quote the total assessed valuation of real and personal property is \$1,277,460, which is by the board equalized at \$1,190,000, leaving \$87,460 of property in that township upon which the owners pay no tax. In the township of York the real and personal assessed valuation is \$1,325,260, which is equalized by the board at \$1,156,000, leaving \$169,260 of taxable property in that township upon which, by the action of this board, the owners pay no state or

county taxes. In the township of Salem the assessed valuation of real and personal property is \$1,040,675, and the equalized valuation upon which state and county taxes are paid is \$1,150,000, making thereby the tax-payers of Salem pay state and county taxes upon \$109,325 of property which has no existence whatever in that township. In the City of Ypsilanti, 1st district, the real and personal property assessment is \$1,718,950 and the equalized assessment upon which state and county taxes must be paid is \$1,880,000, making \$161,050 which has no existence there and

tax-payers. From the above, which are only examples, it is perfectly evident that the taxpayers of Salem and Ypsilanti 1st district are paying taxes upon the property of the citizens of Sylvan and York.

In the 1st district (1st and 2d wards) of this city the equalized assessment is \$27,-650 less than the actual assessment. In the 2d district (3d and 4th wards) the equalized assessment is \$75,950 less than the actual assessment. Here are over \$100,000 worth of actual property in the above districts which pays no state or county tax whatever, while in the 3d district (5th and 6th wards) the tax-payers pay state and county taxes upon the equalized assessment which is \$2,164 more than the actual assessment, or actual assessable property of the district. But the wise board of supervisors proceed to equalize the assessment and make an "equalized assessment" and says that Jones's equalized assessment is \$1,000 and Brown's equlized assessment is \$3,000, and that upon these equalized assessments each shall pay two per cent. since there are only \$4,000 to pay \$80 taxes. Note the results. Jones who is worth \$2,000 pays a two per cent. tax upon \$1,000, making \$20—that is he pays no tax on one-half his property-and Brown erty which he does not possess. In fact,

he is unjustly deprived of \$20, it being the additional amount Jones should pay, and what Brown is compelled to pay upon Jones's property by this un-equalized

But, perhaps, it is claimed that \$1,000 Brown-but that the percentage of tax is different. If this position is true it in no way alters the injustice. If the board of supervisors had permitted the assessments to remain as they were fairly made, each would have paid one half of the taxes, whereas by their action they have made Brown pay three times as much as Jones, since Jones's equalized assssment is \$1,000 and Brown's \$3,000. Therefore of the \$80 taxes Jones's actual value, \$2,000, is an injustice and extortion as to Brown. So we repeat that by the unjust and unfair action of the board of supervisors the taxpayers of Salem and Ypsilanti 1st district are paying taxes upon the property

of the citizens of Sylvan and York. Where there has been an abuse of the assessing power by the supervisor and board of review it is just and proper that the board of supervisors should correct it, but it is not possible that it exists to the extent of from \$50,000 to \$150,000 in a single township or district.
