



empted to commit a felony. A box with its lld nailed on is held as being closed against inspection, and is therefore subject to letter rates. Postmasters have no right to pry open such a box and then nail it up again. Even if they had the right to do so, they have not the time.

SEVERAL bills on the calendar were considered in the Senate on the 20th, after which onsideration of the Inter-State Commer-sill occupied the remainder of the session In the House a bill was reported to prohibi aliens from holding lands in the Unite States. In Committee of the Whole the In dian Appropriation bill was considered When the committee rose eulogies were pronounced to the memory of the late John H Evans, of South Carolina.

In the spnate on the 21st the invasion of Oklahoma iands was considered, a bill to establish a Court of Appeals was discussed, and the remainder of the session was occupied in the remainder of the session was occupied in debate on the Inter-State Commerce bill. A message was received announcing the death of Congressman John H. Evins, of South Carolina, and appropriate resolutions of respect to his memory were adopted. ... In the House consideration of the Indian bill provoked a long discussion on the Oklahoma question. The Agricultural Appropriation bill was reported. Eulogistic addresses upon the private life and public services of the late Senator Anthony, of Rhode Island, were delivered by several members.

THE status of the Oklahoma lands was the chief subject for debate in the Senate on the 22d. Messrs. Dawes, Vest, Harrison and Maxey held that the law forbade the invasion Marey held that the law forbade the invasion of these lands by white men. Mr. Pluml claimed that without the consent of the Indians the lands could be opened to settle ment by the action of Congress and the President.... In the House, the Indian Appropriation bill was further discussed. Amendments were adopted to establish an Indian Industrial school at Santa Fe and to negotiate with three tribes for the opening of the Oklahoma lands to white settlers, after which the bill was passed.

In the Senate on the 23rd, when Mr. Vest's resolution for negotiations with three Indian tribes for the cession of the Oklahoma dian tribes for the cession of the Oklahoma lands came up, Mr. Plumb offered a substitute requesting the President to enter into negotiations with the red men for all lands above 160 acres to each head of a family, the surplus to be used for actual settlers only. After some debate, both resolutions were referred to the Committee on Indian Affairs. A National flag was presented to the Senate by the Women's Silk-Culture Association of the United States... In the House the day was occupied in discussing Senate appropriation bills. A silk flag was presented to the House by the Women's Silk-Culture Association. In the evening fortysix pension bills were passed.




