

The students all room and board in the town. The university has long since given up the dormitory system. As a general thing two students will room together, and a number get their meals at a "club," or boarding house. Rooms are usually in suits, a sitting-room or study and a sleeping-room, and they differ in every way, according to the tastes and means of the occupants. Prices for room rent and care run from \$1 to \$5 a week, and thus, through the error of liberality, quite a number of animals are justified, "killed by kindness" every year. #### LETTERS FROM THE PEOPLE.

A Practical Way to do It.

ED. COURIER :- My idea of the correct way to boom this city, is for 100 men to subscribe \$300 each, (no foolishness) making a total of \$30,000. The subscribers to this fund to meet, elect a committee of five or seven whose duty it shall be to organize, look after the railroad shop uestion, or anything else that we may want located here; receive and consider what propositions it may be desirable to make, submit the same to the subscribers, and if a majority say accept, take the necessary steps to consummate the business. If it requires \$5,000 to accomplish the project, assess each subscriber \$50, The committee can then make the proper and legal arrangements with the institution that is to be started here; and so on, giving more or less to each institution

until the fund is exhausted. Let it gain general publicity in the papers of the state that Ann Arbor has raised (or substantially so) that amount of money (\$30,000), and the committee will not wait long before it will have plenty of propositions to consider.

If a man or corporation starts a manufactory of any kind, he or they do it to make money, and if we can give inducements to have such manufactories started here, they will come here, no matter where shops. I have no doubt that without T., A. A. & N. M. R. R. has several better locations for their shops, for that is towards the people of this city. All things being equal, as the president and the superintendent remarked to me the other day, if things were a little more than equal, they might be induced to locate the shops here. However, from the extended conversation I had with those gentlemen, I am fully convinced that neither nice talking nor eloquent speeches will accomplish the desired result.

Let us get at this shop question at once, call a meeting, have a subscription paper drawn up somewhat after this

We, the undersigned, agree to pay the amount set opposite our names, for the purpose of giving new life and prosperity to our beautiful city, to be expended as a majority of the subscribers may direct from time to time, etc.

If \$30,000 is not subscribed at that meeting, let a committee of, say ten, be appointed to raise what may be lacking. "Oh! but," says one man, "you can't find 100 men who will give \$300 each.' Well, if we haven't 100 men in our city who will give that amount for railroad shops, (speaking of railroad shops Gov Ashley remarked that Ann Arbor was too far from the center of the road, but when I said "wouldn't enough money make it nearer the center?" he smiled) and several similar institutions, we might as well settle back on pine boxes and go to whittling and talking about our neigh-

I don't care if you get 500 persons to subscribe the amount, or say 200, but the way to do is for the soliciting committee, after the meeting of the citizens, to select enough names to make up the 100 or 200 as the case may be, who will give \$150 or \$300, as may be decided upon, and then visit these persons. I had not intended to say one word

about what I thought, but intended to Senator seems able to ad-Vance, as it fall in line, as I have always used my best and unselfish endeavor to do, in everything calculated to help our town, but, neighbors and friends, I have come to the conclusion that we must get down to business, hence these lines.




