

Michigan Crop Report for October.

The returns from threshings up to about The returns from threshings up to about September 25, show an average of 16 and 82-hundredths bushels of wheat per acre in the southern four tiers of counties, and of 13 and 87-hundredths bushels per acre in the northern counties. These figures indicate a total yield in the state of 26,-594,513 bushels. This is 40,177 bushels less than the September estimate.

This month's returns show the average yield of wheat per acre in the southern

yield of wheat per acre in the southern counties to be 59-hundredths of a bushel more, and in the northern counties I and 70-hundredths of a bushel less, than reported in September. This is the final estimates of the subset of timate of the wheat crop of 1886, and like the October estimates of former crops, is believed to be as accurate as can be obtained at this date. One year ago the 1885 crop was estimated at 30,837,361 bushels. The national department of agriculture in December, or two months later, estimated the crop at 31,261,000 bushels. The average yield per acre of wheat raised on corn stubble is returned at 12 and 73-hundredths bushels; on wheat stubble, at 13 and 15-hundredths bushels; on oat stubble, at 14 and 23-hundredths bushels; and on summer fallow, at 20 and 2-hundredths bushels.

Reports have been received of the quan tity of wheat marketed by farmers during the month of September at 268 elevators and mills. Of these 219 are in the south-ern four tiers of counties, which is 52 per cent. of the whole number of elevators and mills in these counties. and mills in these counties. The total number of bushels reported marketed is 1,272,269, of which 300,665 bushels were marketed in the first or southern tier of counties; 273,459 bushels in the second tier; 248,804 bushels in the third tier; 319,935 hushels in the fourth tier; and 129,406 bushels in the counties north of the southern four tiers. At 34 elegators the southern four tiers. At 34 elevators and mills, or 13 per cent of the whole number from which reports have been received, there was no wheat marketed during

the month. The total number of bushels of wheat eported marketed in August and Sepember is 2,825,699. The yield per acre of oats in the south-

ern four tiers of counties is 32 and 85-hundredths bushels, and in the northern counties 29 and 12-hundredths bushels. The yield per acre of barley in the state The condition of clover sown this year is 67 per cent., the comparison being with vitality and growth of average years.

Corn is estimated to yield 57 bushels of ears, or about 28 bushels of shelled corn per acre in the southern counties, and 54 bushels of ears, or about 27 bushels of shelled corn per acre in the northern

The corn crop matured from the 10th to the 20th of September.
Frost injured the crop in several localities in the northern counties, but did no naterial damage in the southern counties. Potatoes will yield in the southern counties 69 per cent., and in the northern counties 66 per cent. of an average crop.

Winter apples will yield in the southern counties about 92 per cent., and in the northern counties 87 per cent., of an average crop.

Crossing Wheat-How New Varieties Are Started. Every observing farmer knows that it is quite difficult to keep his corn pure, and that it is mixed badly in his field from corn in adjoining fields. If I raise a pure yellow Dent corn, and forty rods to wind-word my neighbor raises, field of white ward my neighbor raises a field of white Dent corn, the ears in my field will be sprinkled with white and whitish kernels. and the deep yellow will be changed on many ears to very light yellow. Where

two fields are close together the nearest row will be mixed up half and half. Now this is not the case with wheat. A man will reap the kind of wheat he sows every will reap the kind of wheat he sows every time, and the only mixing is by the threshing machine. With corn, the pollen can float on the wind, or be carried by insects directly from the tassel in one field to the combination sluggers. Not so with wheat.

The fertilization necessary to produce a kernel of wheat, takes place inside the chaff; the male and female elements being both contained within that chaff. Hence a very delicate operation by a skillful hand is necessary, and just at the right time, in order to cross two varieties of wheat.
Two heads are selected from the two kinds to be crossed. At the right time the chaff containing the prospective kernel must be carefully pried open, and, the anthers which contain the pollen-dust which has not yet imparted its life-giving power to the would-be kernel, must be cut off and taken out. Then a shoff from the other taken out. Then a chaff from the other head of wheat must be opened carefully and the pollen-dust from the anthers within must be taken out and introduced inin must be taken out and introduced inside the chaff of the first, and to come in contact with the stigmatic surface. The chaff must then be carefully closed up, and if the thing has not been killed in the operation and perfect fertilization has been accomplished, a kernel will be gradually developed which will be a cross of the two varieties taken. 

At the time of the last annual meeting of the league, the prospect of any effective coperation with city or county authorities seemed very dim indeed. Nevertheless it was still the feeling of the executive committee that every reasonable effort should be made to secure such cooperation and thus release the League from the burden of prosecuting offenders at its own expense.

After securing evidence against a number of saloon-keepers for various violations of the law, a special interview was had with the county attorney with reference to the vigorous prosecution of suits. The result of the conference was very disheartening and members of the committee were almost inclined to despair of accomplishing anything.

Despite this lack of success the committee decided to bring complaint against James L. Stone, proprietor of the Franklin House, for keeping his bar open on Sunday, After many vexatious delays occasioned by the desire of the prosecuting attorney to have the case withdrawn, Mr. Stone plead guilty.

Determined to leave nothing reasonable undone, the committee prepared a petition to the Common Council of the City of Ann Arbor:

To the Common Council of the City of Ann Ar-

"The undersigned citizens of Ann Arbor would respectfully represent to your honorable body that certain ordinances of the city are not in their opinion as efficiently enforced as the interests of public morality require. The ordinances referred to are those prohibiting gaming, the keeping open of saloons on Sunday and on other days of the week within the hours prohibited by law, and the selling of liquor to minors. The charter of the city makes it the duty of the chief of police "To see that all the by-laws and ordinances of the common council are properly and efficiently enferced, and especially those relating to police and sanitary regulations."

"We regard as unsound and thoroughly

cially those relating to police and sanitary regulations."

"We regard as unsound and thoroughly mischlevous any theory of interpretation which relieves him of this responsibility and makes it necessary for private citizens to constitute themselves private detectives for the purpose of seeing that the ordinances are enforced by the arrest and punishment of those who violate them. Inasmuch as the law makes it the duty of the chief of police to 'see' that the ordinances are enforced, it is thereby made his duty to inform himself of the fact whether they are being violated or enforced, and not to wait for private citizens to make the investigation for him and report the result to him.

"We, therefore, ask that this officer shall be neid responsible hereafter for his neglect to perform his duty and enforce the ordinances referred to, and we ask the common council to instruct him to see that the same are efficiently enforced throughout the city."

Nearly one hundred and fifty of the leading citizen of Ann Arbor, with several saloon-keepers signed this petition. It was given to one of the aldermen with the expectation that he would present the petition to the common council. The petition was not presented (and hence does not appear on the records), but the aldermen aforesaid did introduce a resolution covering the ground requested, which was passed December 7th. Within a lew days from the taking of this action, four saloon-keepers, Win. Frank, J. Hoffsteter, Waish & Gibney and G. Clarken, were arrested by the police, and in due time all were convicted.

Although the committee had secured a large amount of evidence, as before stated, it was thought advisable under the circumstances to discontinue further prosecutions so long as the authorities shewed a disposition to act in good faith.

In November, the city attorney showed a disposition to push suits against gamblers and keepers of nouses of fill-tame. Early in December action was brought under the city ordinance against Mrs. Lorinda Jenkins for keeping a disorderly house. The trial was heid, the city attorney prosecuting with great vigor, and the defendant would have been convicted had there not been a slight technical fault in the complaint. As it was, the jury disagreed, standing four for conviction to two for acquittal. Eather than run the risk of a new trial the defendant promised to leave the town within ten days. The promise was fulfilled and thus was a house vacated which had been a stench in the community for several years.

Ing for the service of the spring elections the Executive committee addressed requests to the chairman of the democratic and republican city committees asking them to call their conventions at least two weeks in advance. To these requests no formal answers were returned. Various members of the committee in their individual capacity thought it advisable to call a meeting to consider the expediency of preparing a citizens' ticket. After several meetings this ticket was prepared and submitted to the voters in April with the well known result. Although many of the persons chiefly interested in this movement were connected with the league, this was in no sense a league ticket, and not a cent was ever taken from the league treasury to defray the expenses incurred in connection with the election. The league is by its very nature a non-partisan body, having nothing to do with politics, and any appearance to the contrary is occasioned only by its members exercising their individual political rights in just the same way as other citizens.

With the incoming of the new city administration came a much better management of police affairs. Disorderly women were compelled to leave town, and saloonkeepers detected in violating the law were arrested, tried and convicted. It seems safe to say that there has been less violation of the law within the league is not directly responsibly for this better state of affairs, its members cannot help feeling that their work has had much to do with the improvement. Russia on the 14th selected Prince Alexander, of Oldenburg, as the future ruler of Bulgaria. THERE were thirty-three new cases of cholera and eighteen deaths in Austro-Hungary on the 14th.

THE schooner George M. Case, grain-laden and bound from Chicago to Buffalo, foundered on the 14th near Port Colbourne, Can., and three lives were lost. ADVICES of the 15th report three dreadful crimes in Canada. At Renfrew David Gorgol killed Mrs. Stuart with an axe, at Palmer Rapids a landlord beat the head of his infant to a jelly and then burned the

body, and at Stratford a brute beat Mis Conway, an aged widow, to death. REV H. W. Several divines protested against his views.


