

It has failed in every state in which it has been tried. Maine is the only state in which it has been fairly and fully tested. The predominent political party favored it, and Neal Dow, the chief apostle of the system, has managed and controlled the movement from the begining. If prohibition cannot prohibit in that state, under the most favorable conditions, it cannot anywhere. The official reords state that 1,262 liquor dealers paid the United States govern-ment taxes in 1886, or one to every 545 inhabitants. Of these 1,156 paid a tax as retail spirituous liquor dealers, and 100 as retail malt liquor dealers. In Bangor there are 140 open bars, and no attempt is made to enforce the law. In Portland the law is a dead letter with 150 saloons in full blast every day. posed to its being enforced."
We have facts from reliable sources to show the law is not enforced to any large extent in Rhode Island, Kansas, Georgia, and Iowa. It has been but recently enacced in these states, and it is not as easy to obtain liquors as in Maine, but there is not a state in which it has been enacted where intoxicants cannot be obtained "on the sly" at least, and experience and common sense show that the law will grow less rather than more stringent.

But in Maine, the old model prohibition state, Dow says: "Intoxication has not been perceptibly lessened." That is ough in reference to its practicability and until the friends of prohibition will wipe out these facts they have no right to denounce old temperance men as taking sides with whisky dealers, but must admit that a man can be a good temperance man while opposing what he believes has and will fail.

We are sorry. Could we see the least hope of destroying this appalling evil or intemperance by law or that such a plan s sanctioned by the God of love and humanity, we would enter the ranks and work faithfully till it should be destroyed. There is no evil with which this nation is cursed greater than this, not one whose pathway is strewn with so many victims Our young men are perishing by the thousands. Those of the brightest intelects are destroyed, and still the ruin goes on. It is more than terrible, yet the deep gulf of death is being filled faster than at any former time. Seemingly, hell is moved from beneath to meet them at their

Prohibition cannot prohibit the sale of intoxicating liquors because it violates the fundamental principle of individual liberty on which this government is founded. The overmastering conviction of the people is that each one is a free man—free to pursue any calling, provided he does not terfere with the rights of others. The law in all cases is designed to protect right, not prohibit wrong. God, not the state, can say, "Thou shalt not steal." The state, in protecting the rights of property, can affix such penalty to the law as to prevent crime in many cases. Men are not free to steal, because stealing is taking what belongs to another. The liberty of the individual ends when he chooses to take, without permission, what does not belong to him. When we do not violate the rights of others, every man may do as e pleases, buy, sell, and get gains as he chooses. Every man has the right to engage in any kind of business provided he pes not violate individual rights. It looks hard for a new comer to set up business where his neighbor has long been successul, and do what he can by fair means to upplant him, but who will ask for a law

prohibit him from doing it? The principle that covers all such cases s this, any man has the right to sell wood, coal, flour or rum provided there is no injury done but by the consent of the purchaser. He has the right to sell the most deadly poisons to any man, when it is so labeled, for no one could be injured but

by the consent of the purchaser.

Rights are protected, but when not invaded, even when the evil falls heavy on re individual, how is he to be prohibited from pursuing any calling without the violation of individual liberty. Every man has the civil right to drink, when and what he pleases: if not, why not? But ntoxication is a terrible evil. That is true. So is eating too much, and eating improper food and at improper hours, but how shall these and kindred evils be pro-hibited by law? Who will or can recog-nize the justice of such a law? If the state may thus regulate the life of the individual, all individual liberty is trampled out

But it is said that selling intoxicating iquors is a crime. It is certainly an evil, ut how a crime? It is a wrong, but what injury is done by the mere sale of ntoxicants? No one can be injured by the sale alone. Injury, wrong and crime comes of drunkenness, but that is caused by the voluntary fict of the drunkard. The existence of rum may tempt men to the sale alone. The legislature shall enact laws with suitable penalties for suppression of the manufacture, sale and keeping for sale or gift, of intoxicating liquors except as herein spe-

This is a question, not of sentiment, but of sound public policy. We have now a tax law which has reduced the number of places where intoxicating liquors were sold more than one-half. It has already extinguished over fifty per cent. of those places and is nstantly lessening it as shown by the statistics. The burden of proof, therefore, falls upon the advocates of the amendment to show that in all reasonable, probability the amendment will wholly close up all those places where intoxicating liquors are sold or kept for sale, unless kept and sold for the purposes mentioned in the amendment Have they done it, or do they attempt to do it? My learned friend, the nominee for Judge of the Supreme Court upon the Prohibition party ticket states truly that the old law was ineffective because the "search and seizure" section was declared unconstitu tional by our Supreme Court, as in violation of Sections 28 and 32 of Article 6 of our Con stitution: which sections are still in force. zure statute and warrant the destruction of all liquors found." That the true remedy for the prevention of liquor selling is to prevent, either by moral suasion or legal force, or both, the crime of liquor drinking; that liquor selling is only the result of the great law of supply and demand, and that when the demand is destroyed the supply will necessarily cease, and that those who honestly seek the suppression of the crime should address themselves as earnestly and faithfully to the destruction of the drinking habit as to the suppression of liquor selling.

A MAN OF EXPERIENCE.

The candid opinion of a broad minded liberal man of wide experience on an important subject is always valuable. We know of no one better fitted therefore to speak intelligently on temperance and prohibition than Hon. P. T. Barnum, a life-long temperance man. A recent interview with him is as follows:

MR. P. T. BARNUM

was seen at his rooms in the Murray Hill hotel. Hesaid: "Although I once stumped Connecticut for prohibition and with success, I do not believe in it. It didn't work. The dealers sold without license to their hearts' content, and things were worse than ever. I go for high license. I was chairman of the temperance committee in the Connecticut legislature about twenty years ago, and proposed then the plan of local option. But I suggested there should be only one drinking place to a specified number of voters. At present a majority of the towns in our state vote against liquor selling under local option, and this goes as far towards reducing the traffic as we can get. Now, under local option, I advocate high license in all cities where liquor is sold. I would limit the number of lisences to one for every 500 voters. I consider this a perfectly liberal allowance, as not half or a quarter of those to whom a saloon is allotted would ever enter one. This scheme would give for a town of 10,000 people twenty drinking places. Isn't that enough?" "How would you dispose of these licenses?" was asked.

"But if a person of objectionable character bids off a license I would not have the bid accepted. This sort of scrutiny is important, and if an unsuitable location is selected for liquor selling I would have the authorities (in our state they are the county commissioners) revoke the license connected with it, which should be resold at auction."

"Most assuredly. Liquor saloons are a







at present. (b) A prohibitory law could be put on the statute books by the present legisla-ture, that would have all the effect, so far as the liquor traffic is concerned, of a constitutional amendment, and if it should prove inoperative, would not need such

cumbrous machinery to repeal it. (c) The Times believes that the passage of the constitutional amendment would mean free whi-ky for Michigan. (d) The success of the prohibitory amendment and the passage of a law in accordance threwith would render necessary an increase of nearly twenty thou-sand dollars annually to the taxes of this county, and there would be no corres-

nding benefit. 2. The Times believes that if the pro posed amendment should go into effect the state will be holden, and will have to pay damages, that can be proved, arising from its operation. (a) It believes these damages will ag-

3. It is no part of the duty of the Time to question the propriety or impropriety of the action of the legi lature of 1875 in pealing the prohibi ory law. That was a long time ago.

of irresponsible men, and that the results of the traffic were vastly more disastrous than under the present law.
