

A BOOMING TOWN.

Hearing of the boom at Sault Ste. Marie in real estate THE COURIER determined to send a correspondent to the scene of action, and with the following

As the town is located on the northeastern corner of the Upper Peninsula seventy miles from the rail-road, large sleighs were brought into use from St. Ignace, which point we reached by boat from Mackinac after buffeting the ice for two hours in going seven miles. A general rush of speculators from Chicago St. Paul and Minneapolis was centering at St. Ignace, all clamoring for convey ances. The regular sleigh is covered, has a stove and carries the mails with two changes of horses on the road. Bu everything went, parties of five or six paying from \$25 to \$250 for transporta

The country is bleak, desolate, and wild, dotted with farm-houses from five to ten miles apart where the pilgrims flocked to warm and lunch. It took six teen hours of riding to cover the distance and upon arriving we found the accomo dations so crowded that men hired billiard tables by the hour to alternately play on and sleep on during the night A friend gave us the use of his library room floor whereon we spread our buffale overcoats, blankets, etc., and slept the calm sleep of the weary.

Next morning the town was early astiand after breakfast the road in front of the hotel was not long in being blocked by eager speculators buying and selling. They tried it at first by options, offering to put up \$100 for the refusal of a piece for ten days. If the land should go back in value they only lost \$100, but it was likely to double or treble in value. However the owners were too sharp for such dealing and required at least onethird cash down. In consequence many of the speculators who came with the intention of buying the town for a thousand dollars went off saddened and de-
