There is a crisis in Ann Arbor - six girls have been murdered and the police have in no way approached a solution. In fact, the oolice have oroven to be incompetent, poorly coordinated, and vindictive. Based on information given to us by reliable friends, and upon facts and related events discussed at a number of hed. night Free Community Council meetings at the Trans-Love Communes, we accuse the police

1. of not investigatins extremely relative information concernins attembted attacks;
2. of not making it clear to the total public exactly what is being done to solve the murders;
3. of making it. difficult for peoole with information to relay it to one central, responsible police source. (People are siven the beauracratic run around, or are beins treated like aximinals!):
4. of using the murder investigation to harass street people, and beople who smoke marijuana. (lie know from experience that swokins marijuana harms no one, and that it is oriminal that there are laws against its use, and entorcement of those laws is so harsh, selective, and a waste of taxpayers? money. The police should be puttins their total energies into solvino these murders.)

We have learned through the experience of. organizing to obtain the city's cooperation to produce free, Sunday rock \& roll concerts in the parle that it takes the collective and unified encrgies of all the people to lecitimize our needs, and to demand respect for our culture. As the pios step un their harassment on the hip community; and continue to brutalize black people and fail to serve the whole communlty in a time of crisis, we must once again come together to expose them and orovide for our own survival. We Will not be fucked with!
ie will exhaust all lesal means, and we will use any tactics that will insure our survival, so that we may continue to serve the needs of the people. We will not be free until all the people are free. (To this end we Dlan to be at the City Council Meeting Monday, 16 June at $?$ PM to demand a oublic hearing of our grievances and to make it clear to the oolice that they are responsible to the people - not in control of the people!)

Our complaints include a number of other incidents of police pis behavior, and since we have not been able to deal satisfactorily with the pies on an individual or single commune basis, we are forced to educate and nobllize the whole commity around the problems at hand. The final and total solution is in the hands of the people - All Power to All the Peoplel

1. The Thistle Stop Restaurant on S.U. and Forest was ransacked ( $\$ 300$ damages) and two of our black friends spat on by two punk fraternity (sic) boys on 11 June, while policemen in a car out
front watched. When the manager asked the oiss to arrest the bunks, he was told that witness statements were contradictory and nothins could be done! It seems the piss have consoired With the punks to hariass the only and the best 24 hour restaurant in town. If the pigs don't take care of real crime, we will. Arm the People!
2. Two ihite Panther Party members were walkins down S.U. a few weeks ago when Sheriff Harvey "s goons bulled uo and stole their rolled up ihite Panther flags, saying it advocated the violent offerthrom of the rovemhment. Fi.sht on! The brothers went to the bic sty with friends and were unable to get their flags back. Charces of theft w111 be brought against these outrageous piss. If there is no justice in the courts, we will have it in the strects by any means necessary!
3. A couple of youns citizens attemoted to oro to a City Counoil meetinc on 2 June, and were stopped at the first floor entrance and harrassed and searched by the local Ann Arbor piss, and then told to get out because there was no City Council meeting that nisht. A government removed from the beople foolishly fosters rebellion!
4. Fuzzy, a inite Panther, famous for sellins many. Black Panther papers, and organizins the street people into frizbee games on Forest and S.U., and helping many sreat toke downs get rollins on the streets, was busted for curfem 11 June out of a crowd of youns people in the Satellite Restaurant. The volice were down on his ass, and had threatened to get him if they saw him on the streets. The streets belons to the people! Fuck curfert! te demand an end to repressive ois beharior!
5. The Ann Arbor piçs consistently come by the Trans-love Communes on. 4111 Street in the late night and put their damned search liohts all over our houses. Te surrounded a ois one ni ht., confronted him, and demanded an explanation for such obviously attemoted intimidation. All he had to oink was that he was lookins at our lawn! . What a fool! Leave us alone or feel the Wrath of the People!
6. People have been harassed and intimidated by the oigs for distributins the Ann Arbor Argus and postins other community flyers. Pun and Skio, Ministers of Defense and Education, were arrested for distributing obscene literature to minons from Milan Iish school with intent to corruot their morals. The judge and the prosecutor are absolute fools when they refuse to listen to the ki＇s impressions of material which has change：their lives and bxoujht the wath ot the self－appointed censois upon them（six students were suspended from $\operatorname{milan}$ High， and some of them were intimidated into testifying at the prelimin－ ary exam that they had received the materiai at the WFF National Hdqts．， 1510 Hill．Zight（n！）When Fun iriedtocarry on his questioning of witness Mike Kuser－（Fun served as his own revo－ lutionary lawyer）－to establish in the court record what Nike felt about the hite Fanthers and the literature he had received， the prosecutor，pi弓－head Chay，objected with a grunt and an oink！ He claimed that the question at hand was not what the students t thought about the whole thing－or about anyining for that matter but whether the material＇in iact＇was io be judged obscene with the people，not in his fucke－up honkie value system which is antiquated and without respect for young peoples need and desire
to learn what the world is all about．
