The Test Oath in Tennessee.

The New York Commercial Advertiser (conservative republican) says Mr. Andrew Johnson, Military Governor of Tennessee, has issued a proc lamation in regard to the coming elec exception-concede that it was a larger meet- tion in that State, in which he has oring than theirs of the 11th, and it was doubtdered that any one offering to vote must take a most extraordinary oath. This oath, after a recital of the ordinary and unobjectionable features in regard to supporting the Constitution and the government, proceeds as fol-

"That I will cordially oppose all armistices or negotiations for peace with rebels in arms, until the Constitution of the United States and al laws made in pursuance thereof shall be established over all the national Union; and that I will heartily aid and assist the loyal people in whatever measures may be adopted for the attainment of these ends." It is easy to see against what and

whom this oath is aimed, but like many other inconsiderate devices, it recoils upon its framers. The voter is required to swear opposition to "all negotiations for peace with rebels in arms." It would seem to follow that he should oppose all negotiators also. Now, Mr. Lincoln in his "To whom, it may concern" letter declares that he will receive and consider any proposition looking to peace "which comes by and with an authority that can control the armies now at war against the United States," Such authority must certainly be a "rebel in arms," and a consistent and conscientous voter would conse quently be troubled to take this test oath without mental reservation; particularly as Mr. Lincoln in the letter alluded to, in his anxiety to treat with the rebel authorities, offers to meet their propositions "with liberal terms on other substantial and collateral points? We fear that Mr. Johnson has made it impossible for any one to vote in Tennessee, either democrats if they favor an armistice, or republicans if they stand by the "To whom ir may coneera" pronunciamento.

It is time that from the administra

tion party some open rebuke be given to this action, and that the loud-voiced advocates of freedom and civil rights should express their minds upon a subject as grave as this. It was against ust such a policy that the manifesto of Sena or Wade and Congressman Davis was directed. > From Sheridan's Army. NEW YORK, Oct. 26.

The Herald's correspondent with Sheridan, the 25th, says: Our men are enjoying a respite after the late battle, and our position is nearly the same as it was before the battle, with the exception of having made a lodgment on the left summit of the Massanutlen Mountain. The following is the official report of what we captured on the 19th :-1,200 prisoners of the rank and file, 64 commissioned officers, 48 pieces of artillery, 40 caissons, 65 ambulances, 50 army wagons, 15,000 rounds of artillery ammunition, 1,500 small arms, several wagon loads, including all the medical stores of the enemy, a large quantity of small arm ammunition and a large number of battle flags. A letter from the President was re d to the army, thanking Gen. Sheridan and his brave men for the month's operations in the Valley, and especially for the splendid work on the 19th. Our losses on the 19th, though not officially reported, will sum up nearly as follows: Army of West Virginia, killed 60, wounded 350, prisoners 400, total 810; 19th Corps, killed 400, wounded 1,200, prisoners 100, total 1,700; 6th Corps, killed 300, wounded 1,000, missing 50, total 1,250; Col. Kitching's division, killed 20, wounded 150, missing 56, total 226;—



I have been ab sent nearly a week on a visit to my brother in Sparta, who has been quite out of health for some time. Your letter I found here on my return home yesterday. The delay of my reply thus occa-

sinced I regret. Without further explanation or apology allow me now to say to you that no person living can possibly feel a greater desire for an end to be put to this unnatusal and merciless war upon honorable and just terns than I do. But I really do not see that it is in my power or yours, or that of any number of persons in our position, to inaugurate any movement that will even tend to aid in bringing about a result that we and so many more desire.

The movement by our Legislature at its last session, at the suggestion of the Executive, on this subject, was by authority properly constituted for such a purpose. That movement in my judgment, was timely, judicious, and in the right direction. Nor has it been without results. The organization of that party at the North to which you refer may justly be claimed as a part of the fruit of it. These it is to be hoped, will be followed by others of a more marked character, if all in both sections who sincerely desire peace upon correct terms will give that movement thus mangur ated all the aid in their power

The resolutions of the Georgia Legislature, at its last session, upon the subject of peace, in my judgment, embodied and set forth very clearly those principles upon which alone there can be perma nent peace between the different sections of this extensive, once happy and prosperous, but now distracted country.

Easy and perfect solutions to all pres ent troubles, and those far more grievous ones which boom in prospect, and portentously threaten the coming future, is nothing more than the simple recognition of the fundamental principle and truth upon which all American constituultimate, absolute sovereignty of the States. The doctrine our Legislature announced to the people at the North and to the world. It is the only keynote to peace-permanent, lasting peace -consistent with the security of the fices have been, and are, to which you public liberty.

It was upon this principle that the original thirteen co-equal and co-sovereign States formed the Federal compact of the old Union in 1787. It is up on the same principle that the present co equal and co sovereign States of our Confederacy formed their new com-

All wars which do not resolt in the extinction or extermination of one side or the other must be ended

From the discussion or interchange of views in such a Convention, the history as well as the true nature of our institutions, and the relation of the States toward each other and towards the Feder al head, would doubtless be much better understood generally than they now are; but I should favor such a proposition only as a peaceful conference, as the Convention of 1787 was. I should be opposed to leaving the questions at issue to the absolute decision of such a body. Delegates might be clothed with powers to consult and agree, if they could, upon some plan of adjustment, to be submitted for subsequent ratification by the sovereign States whom it affected, before it should be obligatory or binding, and then binding only on such as should so ratify it. It becomes the people of the South, as well as the people of the North, to be quite as watchful and jealous of their common ancestors were.
