Bank notes are subject to many mishaps, but the bank will redeem them, provide they remain so nearly legible that it is possible to identify them. When a note is irrecoverably lost, the usual practice is-if the note be under one hundred pounds-to make the loser wait five years, after which time application for payment will be entertained But, with notes of one hundred pounds and upwards, a sum equal to the amount lost is invested in consols, in the name of the Governor and Company of the Bank of England, for twenty years. During this time, the dividends, as they accrue, are paid to the loses; and, at the end of the term, the stock is transferred into bis name.

Observe, how very quick the child's eye is, in the passive age of infancy, to catch impressions, and receive the meaning of looks, voices, and motions It peruses all faces, colors, and sounds .-Every sentiment that looks into the eyes, looks back out of its eyes, and plays in

miniature on his countenance.

"The tear that steals down the cheek of a mother's suppressed grief gathers the little infantile face into a responsive sob. With a kind of wondering silence, it studies the mother in her prayer; and looks up piously with her in that exploring watch that signifies unspoken prayer. If the child is handled fretfully, scolded, jerked, or simply laid aside, not affectionately, in no warmth of motherly gentleness, it feels the sting of just that which is felt towards it; and so it is angered by anger, irritated by irritation, fretted by fretfulness; having thus impressed upon it just that kind of impatience or ill-nature which is feit towards it, and growing faithfully into the bad mould, as by a fixed law.

"The steamer Sultana, Capt. Mason, arrived from New Orleans, last night, the 26th, with about 2,200 people on board, 1,964, of whom were exchanged Federal prisoners from Vicksburg, the balance being refugees and regular passengers from various points along the river, proceeding towards St. Louis .-She left the coal pile about one o'clock this morning, and had made some eight or ten miles, when an explosion of one of her boilers occurred. The boat, with its mass of living freight, took fire in the vicinity of the engines, and in a short time she was burned to the water, and now lies on a sand bar near Fogleman's Landing, nothing visible but her charred remains and jackstaff standing erect.

The scene following the explosion was terrible and heart-rending in the extreme. Hundreds of people were blown into the air, and descending into the water, some dead, some with broken limbs, some scalded, were borne under by the resistless current of the great river, never to rise egain. The survivors represent the screams as agonizing beyond precedent. Some clung to frail pieces of the wreck, as drowning men cling to straws, and sustained themselves for a few moments, but finally became exhausted and sunk. Only the best of swimmers, aided by fragments of the wreck, were enabled to reach the woods, and there take refuge, until rescued by boats seat from the landing here to their assistance.

There were about fifteen women and ascertained, not more than two or three had been found at the hour when this account was written.

Some of the wretched people were borne by the current as far down as the levee at this city, and this was the first intimation the officers of the boats in port received of the terrible disaster. A yawl was immediately sent out from the Marble City, and in a few minutes several persons were picked out of the water and brought ashore. Two were afterward found clinging to the wheel, and they were also saved. Upon being brought to a realization of the calamity, the officers of the boats in port, under notification of Capt. Senior, of the River Guard, steamed up, and in a short time were at the burning steamer, where hundreds of people were picked up and brought to this landing, arriving about daylight. They were met by a number of citizens and ladies, who supplied them with abundance of new clothing from

the Quartermaster's Department and from various stores. At this time it is impossible to give a correct statement of the cause of the aceident, and number or names of the lost and saved. Everything is in the great est confusion. Mr. Rawberry, the first mate, was on the watch, and standing in the pilot house with Capt. George Clay ton, who was at the wheel at the time of the explosion He only remembers the shock, that he was blown and the air, and was afterwards taken from the water. He saw the lower deck in flames and knows no more. He can give no idea of the cause of the accident, and says the boat was going at ordinary speed, and all seemed well up to the moment the explosion occurred; that the 2d engineer, a sober, reliable man named Clemens, was at the engines, and that nothing more than common was in progress. Captain Clayton was also hurled and rubbish, sustaining slight injuries.— He immediately jumped overboard with a door, by which he was enabled to reach the Arkansas shore three miles below, where, striking a sapling, he seized and clung to it until saved. Clemens, the engineer, was badly burned and scalded, and can hardly recover. Mr. John Fogleman, residing on the Arkansas side, on being aroused by the noise, and seeing the burning steamer, hastily constructed a rude raft, and in this way was the means of saving about one hundred eves. The past forty eight hours have been among the most intensely exciting of the very exciting month we have had. General Grant's arrival seemed to indi c. te that we were to have an immediate advance. The men who had been lounging about in hopes of going home, were called into an unexpected alacity. am bound to say that the terms of the of the officers, Major-Generals Blair and Logan being about the foremost to express dissent. Yesterday a special train started with Generals Sherman, Schofield, and Howard for Durham's station, the scene of the previous interview, and reached there about one o'clock. General Johnston came an hour afterward, when the whole of the conditions were gone over.

The subordinate officers remained outside discussing the several battles in which they had been opposing each other. After a long interview the conference broke up with the result we had expected. The train did not get here until eight o'clock last night, but it was soon noised about that the surrender was complete. The terms have not yet been made public, but I have learned the fact that the terms are the same as those of Lee to Grant, with some further limitations and provisions concerning the privilege of the officers and men to go beyond the present lines.

As neither Johnston nor Sherman expected the previous terms would be acentable at Washington, they were not surprised to find General Grant bearing news of their rejection By Johnston's particular request, no civilians were present. Breckinridge remained absent from the conference, and Grant did the same. The whole of the proceedings have been conducted by General Sherman, and when fully consummated will be sent forward to Washington for approval.





Put into a kettle the fresh beef, or mutton, or the freshened corn beet; cover with hot water and set it boiling. Put upon the top of the kettle a tin pau that will close it as tightly as possible Nearly fill the covering pan with cold water, and replenish it when it evapor ates. The boiling of the meat is now to be kept up from three to six hours or more, or until the meat is cooked "all to pieces," that is, made perfectly tender, so that it no longer adheres to the bones, and will not even hold together to be lifted with a fork. The main point is to boil it long enough. The kettle can stand upon the back of the stove from morning until night if need be; slow boiling is about as effective as rapid boiling. If water boils at all, it is heated 212°, and is no hotter than this when boiling ever so furiously.

The "science" of this process is in

having the pan of water for a cover. The rising steam, which if allowed to escape would carry off much of the flavor and substance of the meat, is condensed upon the bottom of she pan, and falls back into the kettle, so long as the water in the covering pan is below the boiling heat. The covering pan may be improved by bending it down a little in the middle, so that the condensed sleam will drop back from the center. If the boiling be so rapid as to heat the water in the covering pan also to boiling, the water may be accasionally changed for cold.

When thoroughly done, dip out the meat with a skimmer, remove the bones, and put the meat into a pan or deep dish. Leaving the cover off, simmer the pot liquor down to a convenient quantity and mix it with the meat. Now cover it with a plate, and put on a quantity of weights-sad-irons, or a etone, or any other convenient weightand set it aside to cool over night. The liquor will form a hard jelly with the meat, and the mass will become a solid piece, having the form of the containing dish and cover, and will be in nice order to place upon the table, for a substantial meal, or as a cold relish. It is a good preparation for a Sunday dinner; and, as it keeps well, as good to have on hand for an emergency. It can be cut into nice slices, and will be tender, juicy, very palatable, easily digested, and nourishing. If fat and lean bits be mixed together, the slices will If the meat be quite fat, the pot liquor may be first cooled and the fat removed, and afterwards be boiled down a little and then poured on the meat as above described .- American Agriculturist.

Jeff. Davis's Coffee Set.

The Richmond Whiq of the 17th inst, contains the following: "We examined on Saturday, the mechanism of one of those curious souvenirs of the war, that, like their recipients, "can not escape history." We allude to a fancy coffee or tea set, we do without delay.

O. M. MARTIN. not know which, which formerly graced the mansion of President Jefferson Davis, but which was disposed of at auction with silverware, &c., by Messrs. Bell, Ellett & Co., Pearl Street, a few days before the evacuation, when Mr. Davis concluded to "decline housekeeping." and make a tour for his health .-The coffee or tea set in question is a perfect minature or fac-simile of a railroad locomotive, with tender attached. The locomotive boiler receives the coffee or tea, makes and discharges it through a spiggot, a steam whistle indicating when tea or coffee is ready. The boiler of the locomotive is of porcelain, and the figure of the fireman, of the same material, appears on the locomotive, vigorously ringing the bell, which, we sup-pose, means the breakfast, dinner, or supper bell. The tender, which is an admixture of brass and other metal, carries the sugar in an elegant sugar caisson, with goblet for cognac and running small cut glasses. The sides of the tender are embellished with racks for eigars. The most curious contrivance of all is a secret music-box, located somewhere in the tender, which, being set, plays eight popular airs, sufficient in length to entertain a supper, dinner, or breakfast table. It got obstreperous on Saturday, and refused to play "Dixie." The whole establishment, engine and tender, rests on two beautifully enameled wait-ers. As we have said before, the article was disposed of at auction, and purchased by an Italian, A. Barratti, who, several days 2go, disposed of the same to Colonel Friedman, of Philadelphia, a gentleman well known in and out of the Colonel Friedman purchased the

souvenir with a view of presenting the same to President Lincoln; and to save the public the trouble of an effort of inspecting the mechanism we have described, we may as well state that the rare article is on its way to Washington and the White House. It may not be inappropriate to mention that upon the side of the locomotive, in miniature, is em-blazoned "President Jefferson Davis," showing that the testimonial, locomotive and tender, were built expressly for his use or pleasure. Upon the front, just above where the "cow-catcher" ought to be, appears the confederate national banner and battle-flag, entwined with the national ensign of France. Wonder if the whole affair wasn't a present from "Little Nap," as a testimonial of his "sincere regard and friendship," and as kitchen waiters, Slidell and Mason, who
