The Education of Editors.

Journalism has come to be recognized as one of the learned professions, and to take rank with theology, law and medi-cine. It is, indeed, a learned profession, aince it requires a far greater amount of learning than either of the others. Good preachers, doctors, and lawyers are more numerous than good editors. The reason of the difference is to be found in the fact that all possible facilities are offered for the study of theology and the rest, any other trade, must be learned by hard work. A college course and three years or less at a medical school are supposed to fit a man for doctor's duties; but there are no schools for the editors except the

newspaper office. Journalism presents one essential point of difference from other professions; there is no theory about it—it is all practice. Hence it is plain that a knowledge of it cannot be acquired from "books." It would be impossible to write a textbook on journalism. Some fundamental principles underlie it, to be sure; but no one can instruct another in an application of them. The best editors are made of raw material. Put a smart boy in a somposing room, and let him work himself. up, stage by stage, and he comes out at the top, if he reaches that point at all, the most thorough editor that can be made. College-bred youths, as a rule, do not make good editors. They know so much, and cherish so exalted an idea of their own importance, that they cannot stoop te learn the details of journalism, and it is these details that should be mastered by every one who aspires to become a first class editer. They want to write principles underlie it, to be sure; but no a first class editor. They want to write be frequently changing one's business. "leaders" at the start, even before they

eaght; but the majority are too proud to do this, and fail disastrously. We do not mean to insist that a thor

ough knowledge of printing is indispensable to an editor; but it is exceedingly helpful; the ability to handle type and make up a "form" is of trifling value, when compared with the drill through which this ability is gained. On a good foundation obtained at the public school the best education can be built up in a printing office, and it is such an education that tells in journalism.—Boston Rec-
