AN INTERESTING REMINISCENCE. The Struggle Over Edward Everett's Nom-

ination as Minister to Great Britain. The contest in the Senate of the Unied States over the confirmation of Mr. Dana as Minister to Great Britain recalls the very bitter struggle in 1841, when Edward Everett had been nominated for the same place. Harrison had been elected President, receiving 234 electoral votes against sixty for Van Buren, and he was inaugurated on the 4th of March. But he died on the 4th of April following, and John Tyler be-came President, retaining Daniel Webster as Secretary of State, and nominating, when Congress met in extra session, Mr. Everett as Minister to England, as had been agreed upon before the death of Gen. Harrison. Mr. Everett had always been very "conservative," but he had, when a candidate for the gubernatorial chair of Massachusetts, expressed the opinion, in answer to a letter, that Congress had the power to abolish slavery in this district. This was made the pretext by the Democrats to defeat the nomination, and thus retain Andrew Stevenson (father of the present Senator from Kentucky) at the Court of St. James. The Whig party had a majority, but the Democrats thought that, if they could brand Mr. Everett as an abolition-

The Senate Committee on Foreign Relations—a majority of which tt's confirmation, but Senator William R. King, who was a member of the committee, made a minority report, in which he took the ground that it would be to have the country represented by an abolitionist, when there was already a strong anti-slavery feeling. The nomnati n was placed on the calendar with the adverse minority report. That night Senator Morehead, of Kentucky, confidentially informed Thurlow Weed, of the Albany Journal, then here as a correspondent for his paper, what was gong on in executive session, and said that even Mr. Clay, while he advocated the confirmation, would only give a silent vote for it. Mr. Weed declared that this would never do, and at once set about checkmating the opposition to Mr. Everett by communications in the Baltimore Patriot, which came back here in season, and by personal appeals to Mr. Rufus Cheate, then a Senator from Massachusetts, was also very active among the Whig Senators, and before the nomination was reached for action. the Southern Whigs saw that it would be suicidal for them to be made tools of by the Democrats. Herze-govina has already the active sympathy of those provinces which once suffered the same wrongs and attained quasi independence by revolt, as well as those that themselves need the relief for which Herzegovina is now struggling. since the insurrection shaped itself, Herzegovina has had the moral support, and such surreptitious aid as could be given, from the adjoining provinces of Uroatia, Montenegro, Bornia and Servia. CUP CARE. - For cup cake, use three eggs, two cups of sugar, two and one-half cups of flour, three-fourths of a cup of butter, one cup of water, and two tes-spoonfuls of baking-powder. Flavor with one teaspoonful of extract of lemon or vanilla. For frosting the cake, use nine heaping teaspoonfuls of pulverized white sugar to the white of one egg, half a teaspoonful of extract of lemon. The whites of two eggs will be sufficient for one large cake. Beat the whites to a fine stiff broth, and stir in the sugar slowly; beat all together well, and spread over the cake with a knife. Set the cake in a warm place to dry.

Suspended Animation.

The well-known case of Col. Townsend, recorded by an old physician, Dr. George Ckeyne, in his work entitled "The English Malady, or a Treatise of Nervous Diseases of all Kinds" (London, 1733), exemplifies the voluntary assumption of the death-state. Since our last report we have had one case of small pox and one of varioloid. From the fact that the disease did not spread to a greater extent in the city, while it was prevailing to such an extent so near us as the county house, shows the wisdom of the most rigid quarantine and a thorough system of vaccination, notwithstanding the strong opposition any such measure will meet with from the people.
