The 46th Congress.

—Wade Hampton continues weak and is subject to frequent attacks of severe pain, although his indomitable fortitude keeps him cheerful, hopeful and in good spirits. —Postmaster David Bailey, who died at Cambridge, Me., a few days ago, had been appointed to that position by President Adams in 1828, and had held it continuously ever since.

—Cardinal Cullen, though he had during his lifetime been the possessor of more than \$5,000,000 and in a state of almost apostolic poverty, and had lived a little while longer his benefactions would have left him an absolute pauper.

—The Republican papers assume that the importance of the Democrats has surrendered their principles into the hands of the Greenbackers. This is for effect solely. The real animus of the policy manifested by the Democrats at Lansing for a joining of forces, is the long action of the Republican party under the rasping rule and tongue of Republicanism and the re-appearance at the front of Chandlerism in its worst form.
